ACTING SPEAKER AUBRY: The House will come to order.

Rabbi Rubin will offer a prayer.

RABBI ISRAEL RUBIN: This week, the Jewish Calendar marks *Tu B'Shvat*, the New Year for Trees, when deep within the trunk, new sap begins to rise, eventually to blossom forth into leaves, flowers and fruit. It is customary to eat exotic fruit, especially carob, to show appreciation that every fruit is a blessing. Why carob? In the *tractate Ta'anit*, the 2,000 year Talmud predates the Rip Van Winkle legend of Sleepy Hollow with the original ancient Sage who was Honi ha-Magel. Honi had wondered why an old farmer would take time and effort to plant a carob tree when he could not personally live to enjoy the fruit of his labor. But the farmer

responded, *Just as my ancestors before had planted for me, so do I plant for future descendants.* More than just poetic, trees send a serious message. More than just nice to look at, trees and plants are essential to a healthy world and environment.

Almighty God, we pray that You endow and inspire the honorable men and women of this great Assembly with good vision and wisdom to think forward to fruit when even now, presently, there seems to be bare and barren, to plan ahead for future growth and sustainability and look forward and yearn for the Spring. Amen.

MR. MORELLE: Thank you, Mr. Speaker. I move to dispense with the further reading of the Journal of Sunday, January 28th and ask that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

Mr. Morelle.

MR. MORELLE: Yes, thank you, Mr. Speaker, colleagues. Welcome back to the Capitol. Before I give our schedule for the day, I do want to note that on this day in 1936, the first Major

League Baseball Hall of Fame class was inducted in Cooperstown, New York. It seems appropriate, given that there's a new class that was just elected last week. The original and inaugural members, Ty Cobb, Babe Ruth, Honus Wagner, Christy Mathewson and Walter Johnson; that's a pretty good ball club.

And under the heading of "Did you know," did you know that Lyons, New York, which is in the 130th Assembly District represented by our friend, Mr. Oaks, was long considered the peppermint capital of the world? And this is because the H.G. Hotchkiss International Prize Medal Essential Oil Company - is that a mouthful - was founded in Phelps, New York and moved to Lyons in 1841. They became the largest company of their kind in the world and after a long and successful history, made them known as the peppermint capital of the world for many years to come. So, you just don't know how extraordinarily diverse New York is.

And let me give our Calendar for the day and, of course, want to thank Rabbi Rubin for being in the Chamber once again. We always look forward to his presence and the *Tu B'Shvat* table for members and guests to enjoy.

For Majority members, there will be the need for a Democratic Conference at the conclusion of our work on the -- in the Chamber this afternoon. I will continue to consult, of course, with my colleagues on the other side of the aisle to see if they have any Conference needs throughout the afternoon.

With that, Mr. Speaker, this is the appropriate time for any introductions and housekeeping.

ACTING SPEAKER AUBRY: For the purposes of an introduction, Ms. Fahy.

MS. FAHY: Thank you, Mr. Speaker, and I ask that you join me in welcoming our Rabbi who presented so eloquently this afternoon. We welcome him back. He's been here many -- probably many more times than I have been here over the years. And Rabbi Rubin carries so many titles, but he's here particularly today in celebration of *Tu B'Shvat*, which is the New Year for Trees and they have a -- he, along with a number of the young women from the Albany Maimonides Hebrew Day School are here to share a number of treats. So, I ask all to stop by and enjoy some of those treats.

But the Rabbi not only is the spiritual leader here and has been active in numerous congregations and Jewish organizations, he also is the author of a number of ethics and educational books, but

he most particularly is always involved in outreach programs, particularly with our young people. So, when he talks about thinking forward and when he talks about the significance of trees and planning for future -- future generations, he lives what he speaks, and that is he is always there to educate and -- and nurture our young people, including the lovely young women from the Day School that are here today. So if you would, Mr. Speaker, please join me in -- in welcoming him and extending all cordialities of the House. Thank you.

ACTING SPEAKER AUBRY: Certainly. On behalf of Ms. Fahy, Mr. Weprin, the Speaker and all the members, Rabbi Rubin, we thank you so very much for coming and sharing your blessing with us and for this -- this holiday that reminds us that Spring is just around the corner. Thank you so very much. You're always welcome here.

Mrs. Peoples-Stokes.

MRS. PEOPLES-STOKES: Thank you, Mr. Speaker, for the opportunity to interrupt the proceedings to introduce a dynamic young lady from Erie Community College. She is a part of Fostering Youth Success Alliance. Many of them are here with us today shadowing us, Mr. Speaker. Deja Wilson is an Erie Community College student. She is studying social sciences and forensic studies. She is a powerful young lady who has been through a lot in her life, but she is doing very well, and we're very proud of her. I want to

commend my colleague, Deborah Glick, for her work on pulling together these opportunities to foster youth and success with this Alliance, and certainly want to thank the Alliance for the work that they do with young people across the State of New York who have had the fostering and experience, but, yet, are still able to live thriving young adult lives. Thank you, Mr. Speaker.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mrs. Peoples-Stokes, the Speaker and all the members, we welcome you here to the New York State Assembly. We extend to you the privileges of the floor. We commend you on the academic work that you're doing. We hope you will be successful in that endeavor and, you know, one day maybe come and represent your community here in the New York State Assembly. Thank you so very much.

Cindy, who is a long-time friend, serves the Minority Leader of the County Legislature and has represented the 28th District since 2008. She is the current President and long-time member of the Maplewood Neighborhood Association and she

continues to play a critical leadership role in leading our neighborhoods forward.

Howard Maffucci has just been elected to the Monroe County Legislature this past November and represents the 10th District, including the Towns of Brighton, East Rochester and Pittsford, and prior to his election, Howard began his career as a seventh and eighth grade social studies teacher, and became Assistant Principal at a local high school and went on to serve as the Superintendent of the East Rochester Schools for 14 years. He's a long-time friend. I remember Howard coming in and talking about education issues.

I'm delighted that they're both in the Chamber representing our community with distinction, and if you would please extend all the cordialities of the House on behalf of myself and the members of the Monroe County Delegation.

MR. MONTESANO: Thank you, Mr. Speaker. Just, you know, this type of bill gives me pause because we're extending an attorney-client privilege to people that are not attorneys. I understand when people call a lawyer referral service or a Bar Association or some other organization that provides legal services, they speak to a receptionist or an intake person and they may explain certain things to them about their case. So, I think it's up to that organization or Bar Association to have their employees sign a confidentiality agreement, not -- not to discuss these types of phone calls, you know, with anyone else. But I think by extending the attorney-client privilege to people that are not attorneys, we are diluting what that privilege represents, especially in a court of law, investigative agencies and, especially, and most importantly, in the Federal court system and Federal law enforcement agencies. So for these reasons, I'll be casting a no vote. Thank you.
