And under the heading of "Did you know," did you know the first lever voting machine, called the "Myers Automatic Booth," was used for the first time in the United States in 1892 in Lockport, New York. Lockport is in the 144th Assembly District, represented by Mr. Norris. The machine was invented by Jacob Myers, an inventor from Rochester. The machine simultaneously pulled the curtain closed and unlocked the voting levers so a ballot could be cast. By 1930, every major U.S. city was using that technology. Ah, the good old days.

As a reminder, sponsors and Chairs, will have until January 17th to recommit any of these bills from the Calendar back to Committee.

Our principal work of the day will be to begin consenting these bills, beginning with, appropriately enough, Calendar No. 1, which is located on page 4 of your scorecards.

So, Mr. Speaker, I note there is some housekeeping to do, if we could take that up, this would be the appropriate time, sir.
