ACTING SPEAKER AUBRY: The House will come to order.

Before our opening prayer, let us pause for a moment of silence in honor of our friend and former colleague, Louise Slaughter, of Monroe County. She recently passed away. While we honor her and other colleagues whom we have lost during our traditional memorial later in this Session, it is fitting at this time to take this moment as a remembrance of her dedication to public service in numerous capacities, including in this Chamber.

(Whereupon, a moment of silence was observed.)

Father Longobucco will offer a prayer.

FATHER ROBERT LONGOBUCCO: Dear God:

We ask Your blessing upon our legislators, their staff and all who work for the good of the State of New York. May You endow them with wisdom to discern the best in common good, grant them eyes to see the lives of the most vulnerable and ears to hear the smallest of voices crying for justice. Give them good judgment that rewards the faith our State has placed in them and make them peacemakers so that all might live free of violence, intolerance and fear. Make our great State a sign of hope, joy and equality for all. Amen.

ACTING SPEAKER AUBRY: Visitors are invited to join the members in the Pledge of Allegiance.

(Whereupon, Acting Speaker Aubry led visitors and members in the Pledge of Allegiance.)

A quorum being present, the Clerk will read the Journal of Friday, March 16th.

Mr. Morelle.

MR. MORELLE: Thank you, Mr. Speaker. I move to dispense with the further reading of the Journal of Friday, March 16th and ask that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

Mr. Morelle.

MR. MORELLE: Yes, thank you, Mr. Speaker. Colleagues, I apologize for the delay in getting started, but as you all know, we need to be flexible over the next couple of weeks as we work to conclude our budget negotiations.

So before I give some outline for our work this afternoon, let me just note that on this day in 1918, Congress enacted Daylight Savings Time and divided the nation into time zones. In addition to State boundaries, state-to-state commerce and train junctions were also considered when drawing the boundaries for ease of business. When the law passed, much of the State of Idaho was incorrectly placed in Central Time Zone, rather than Mountain, until a 2007 amendment. Although the law made it official, the state had been observing Mountain time prior to the amendment.

And under the heading of, "Did you know," did you know that the Bare Knuckle Boxing Hall of Fame - did you even know that existed? If you didn't, you should know that it is located in Belfast, New York in the 148th Assembly District represented by our friend, Mr. Giglio. Originally owned by trainer, William Muldoon, John L. Sullivan, the famous boxer, trained in barns to prepare for the last Bare Knuckle Boxing Championship against Jake Kilrain. Those barns have been virtually untouched for more than 120 years and opened in 2009 as the Hall of Fame.

And before I move on to our business for the day, it always bears mentioning that on March 17th, although not exactly this day, but close enough, Mr. Speaker, our distinguished and incredibly capable and world-renowned Sergeant-at-Arms celebrated his birthday, Mr. Wayne Jackson. We would not want the moment to go by.

(Applause)

Although Mr. Jackson would probably like us all to move along quickly here, we do have some business, so let me give an idea of what our schedule for the day is. Members have on their desks a main Calendar with four new bills added to the Calendar for the first time today. After any introductions and housekeeping, Mr. Speaker, we will take up the new bills on consent beginning with Calendar No. 713. We will then begin consenting the bills already on the Calendar. For those who have been watching, we left off last and will begin with Calendar No. 212, which is on page 31 of the main Calendar.

Obviously it bears saying that as budget negotiations continue, Mr. Speaker and colleagues, we will be making announcements on any Budget Subcommittee Conference schedules as they become available. There are none to report right now, but I always encourage people to pay extra special notice. For our Majority members, there may be the need for a Conference at the conclusion of our Session today. I will keep you posted on that and, as always, we'll consult with the Minority to see if they have any Conference needs as the day unfolds, as well.

So with that, Mr. Speaker, I note there are introductions. If there's any housekeeping, as well, this would be appropriate time to take that all up.

ACTING SPEAKER AUBRY: We will start with housekeeping, Mr. Morelle.

On a motion by Mrs. Galef, page 4, Calendar No. 714, Bill No. A5514-B, amendments are received and adopted.

For the purposes of an introduction, Mr. Phillip Steck.

MR. STECK: Thank you very much, Mr. Speaker.

It's my pleasure to recognize today Father Robert Longobucco. This is a very special introduction for two reasons. First of all, he chose the priesthood over a career in the New York State Assembly where he worked for three years as a media representative for Joe Lentol, and he was visiting with Joe's office prior to giving the opening prayer today. Secondly, he is the Pastor at the church named in honor of the, I believe, the first Native American Saint, and the name of the Parish is Kateri Tekakwitha. So, that's also very unusual, but Father Longobucco grew up in Bayville, Long Island. His mother was a school teacher and his father owned a bar who proclaimed himself to be a social chemist. He then attended the University at Albany. He worked as a member of the Jesuit Volunteer Corps in Watts. After that he worked for Assemblyman Lentol and he received his Masters of Divinity from the Catholic University of America and was ordained to the Priesthood on July 3, 1998. His first position was at St. Mary's in Oneonta. He then returned to the Capital Region as the Campus Minister at the University of Albany and as I mentioned before he is now the Priest at St. Kateri Tekakwitha Parish in Niskayuna in the 110th Assembly District. We're very pleased to have Father Bob here with us today.

ACTING SPEAKER AUBRY: And on the same topic, Mr. Lentol.

MR. LENTOL: Thank you, Mr. Speaker. I'd like to join Mr. Steck in welcoming Father Bob and, as you know, you're very special to me, Father Bob. And, Father Bob worked for me as a Communications Director, as Mr. Steck has told you, before he left to go to work for a Higher Power. And, you know, some of you may think that I drove him to it --

(Laughter)

-- but don't believe that. Thank you, Father Bob, for your invocation today. You are, indeed, now a spiritual man. I knew how spiritual you were when you worked for me, but that is why people now flock to hear your sermons every week about love, community and peace. And -- but on a serious note, I want to add that Father Bob should really be, how should I put it, Christened, or I think, Sanctified, because not Bishop nor Pope or any of those titles could fit him well, but he could be named the world's most loyal Mets fan on Earth. So, I want to ask you, Father, because having languished as a Mets fan for many years like you, that they have a winning season and you have to pray very hard for them this year. Play God, Bob. And, by the way, you know that today is a very special day for Joe Morelle, Joe Lentol and Joe Giglio and Joe Giamboi (phonetic). So, all of the Joe's in this House wish you a happy Saint Joseph's Day, as well. Thank you, Father Bob.

ACTING SPEAKER AUBRY: On behalf of Mr.

Steck, Mr. Lentol, the Speaker and all the members, Father Bob, we welcome you here to the New York State Assembly. Thank you so very much for joining us. Good to have you.

Mr. Raia for purposes of an introduction.

MR. RAI: Yes, Mr. Speaker, thank you. I rise today for the purposes of an introduction. It's always wonderful to have people come up from my hometown and get introduced on the floor, but it's particularly wonderful when the person I'm introducing I've often affectionately called "my sister from another mother." I'd like to introduce Tracey Edwards. Tracey, please stand, and her husband, Walter, behind me. Tracey is the Long Island Regional Director for the NAACP. Her husband, Walter -- son, oh, excuse me. Walter, I know that. Yeah, okay. Go figure. Her son, Walter, and I'm never going to hear the end of this one. Sorry Walter, it happens to me, too, with my mother, you'll get over it. Her son, Walter, who I've only known for 20-something years, is the Second Vice President of the Huntington NAACP, and they're up for the NAACP's Legislative Action Day.

But Tracey and I started in government together taking a little program called the Huntington Leadership Program some 20 years ago. She's a former town board member. She is a mainstay in Huntington and I'm so proud to have her up here. Just as a point of personal privilege, I'd also like to wish my mother, Jo-Ann Raia, a happy birthday today. She is also a "Good Joe" because today

is Saint Joseph's Day and happy birthday to Wayne and to Mrs. Cook's wonderful staff for cooking us lunch. Please offer Tracey all the cordialities of the House and -- and welcome her back any time because I sure would. Thank you.

ACTING SPEAKER AUBRY: On behalf of Mr. Raia, the Speaker and all the members -- and also Mr. Ramos and all the members, we welcome you here, Tracey, to the New York State Assembly. We extend to you the privileges of the floor. We hope you enjoy the day with us and that your activities today will be beneficial. Please know that you're always welcome and you can come back. Thank you so very much.

Mr. Thiele for an introduction.

MR. THIELE: Thank you, Mr. Speaker. I rise for an introduction. It is my pleasure and honor today to introduce the members of the East Hampton High School Chamber Ensemble. These students have traveled to Albany today with their Director, Troy Grindle, to perform at the Empire State Plaza during the New York State School Music Association 45th celebration of music in our schools. And, Mr. Speaker, at a time here today where we're in the middle of the budget negotiations and there is so much stress and tempers sometimes goes short, hearing the string music of the Chamber Ensemble today was a very, very soothing experience. The students that are here today, and there are eight of them, are Raymond Chan, Kate Estuye, Diego Hernandez, Kiana Magat, Abelia Martinez,

Amy Orozco, Rachel Osborne and Tyler Simpson. Mr. Speaker, I would ask that you extend to them the courtesies of the -- of the House.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. Thiele, the Speaker and all the members, we welcome you here to the New York State Assembly, the People's House. We extend to you the privileges of the floor. We thank you for the performances that you have provided us today. We hope that you continue that marvelous experience of making music. Thank you, again. Please always be welcome here. Thank you.

Ms. Joyner for an introduction.

MS. JOYNER: Thank you, Mr. Speaker. I wanted to welcome the members of the New York State Bleeding Disorders Coalition. They have joined us in the back of the Chamber this afternoon. Earlier this month, we've adopted a resolution proclaiming March as Bleeding Disorders Awareness Month. Nearly one in 100 New Yorkers are living with bleeding disorders, including hemophilia, sickle cell and anemia. While there is treatment for these conditions, there is no cure for them as of yet. So, I wanted to thank the Coalition and encourage everyone to participate in the Red Tie Challenge as a way of educating the public about this very important issue. Thank you.

ACTING SPEAKER AUBRY: Certainly. On behalf of Ms. Joyner, the Speaker and all the members, we welcome this

Coalition here to the New York State Assembly. We extend to you the privileges of the floor. Thank you for the work that you're doing to help all those who suffer from those particular diseases. And I often wear a red tie. I'll wear the red tie you gave me today soon. Thank you so very much.

MR. ORTIZ: Thank you, Mr. Speaker, for allowing me to explain my vote -- my vote. This particular piece of legislation expands the duties of the Office of Children of Family Services concerning to lesbian, gays, bisexual and transgender runaways and homeless youth. As we know, there was a report that came out of the Comptroller's Office from the City of New York where he estimated that about 112,000 students who are homeless, and they're in temporary housing, and I am amazed that my colleagues in the Senate will not pass this important piece of legislation to ensure that these youth will have the opportunity to have a place that they can call home. Enacting -- an enactment of this bill would ensure that all

employees of a group program providing care to homeless youth in New York State will receive adequate and comprehensive training to allow them to be more sensitive to issues specifically affecting lesbian, gay, bisexual and transgender runaway homeless youth.

Mr. Speaker, I would like to close with a quote for our past President, Barack Obama, who said, and I quote, "When all Americans are treated as equal no matter who they are or who they love, we are all more free." And I close quote and I am voting in the affirmative, Mr. Speaker.
