In the absence of clergy, let us pause for a moment of silence.

(Whereupon, a moment of silence was observed.)

Visitors are invited to join the members in the Pledge of Allegiance.

(Whereupon, Acting Speaker Aubry led visitors and members in the Pledge of Allegiance.)

A quorum being present, the Clerk will read the Journal of Wednesday, May 30th.

Mr. Morelle.

MR. MORELLE: Mr. Speaker, I move to dispense

with the further reading of the Journal of Wednesday, May 30th and ask that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

Mr. Morelle.

MR. MORELLE: Yes, thank you. Good morning, Mr. Speaker; good morning, ladies and gentlemen. Before I give our schedule for the morning and afternoon, let me just note that on this date in 1819, poet and journalist Walt Whitman was born in West Hills, New York. Considered one of America's most influential poets, in 1855 he self-published the collection *Leaves of Grass*, which is now a hallmark of American literature.

And under the heading of, "Did you know," did you know that Kissena Park velodrome is the last remaining velodrome in New York State? Kissena Park is located in the 25th Assembly District, represented by our friend, Ms. Rozic. And a velodrome, for those, including me, who did not know, is a bicycle racing track characterized by steep banking curves, which allow cyclists to keep riding with speed through the turns. The outdoor track, which opened in 1962, continues to host events that draw cycling enthusiasts from all over the country.

I wish we had a legislative one so we could not slow down while we're making our turns, but turns we must make, and let me turn to our schedule for the day. Members have on their desks a main Calendar and a debate list. After any introductions and

housekeeping, we will continue our consent of the new bills on the main Calendar, beginning on page 82 of the main Calendar with Calendar No. 941. We will also, Mr. Speaker and colleagues, take up bill off the debate list. Members of the following Committees should also be aware that we'll be calling these Committees throughout the balance of the afternoon here, that includes the Corporations Committee, Committee on Environmental Conservation, Higher Education, Housing and Judiciary. So, I'd ask members to pay special notice so that they will be available when you call those Committees.

With that, Mr. Speaker, that's an outline of our work today. If there are any introductions or housekeeping, this would be the appropriate time, sir.

ACTING SPEAKER AUBRY: For the purposes of an introduction, Mr. Santabarbara.

MR. SANTABARBARA: Thank you, Mr. Speaker. Today I'm pleased to introduce 34 high school students representing school districts in the areas of Schenectady, Montgomery and Albany Counties in the 111th Assembly District. They join us today as part of an annual Student Cabinet Program that encourages students to participate in their State government. The goal of the program is to give students a voice in the critical issues affecting their education. Our meetings have produced lively debates and meaningful discussions about some of the tough issues affecting education. Today, the students conducted a hearing on some of the recent legislation we have taken up here in the New York State Assembly.

The students had an opportunity to listen to testimony from education advocates, and ask their own questions on issues important to them. Following the hearing, the students came up with their own ideas for legislation and presented their proposals.

Mr. Speaker, all of these students are future leaders, and I'm so very pleased to have them with us here today. They are joined by a number of teachers, staff and administrators from each of the school districts. I ask that you please welcome these special guests to the Chamber and extend to them all the cordialities of the House.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. Santabarbara, the Speaker and all the members, we welcome these students and their advisors here to the New York State Assembly. We extend to you the privileges of the floor, hope that you will enjoy your experience as we go through our legislative day, and that you've had great experience in providing the ideas and ways in which we might improve education in this State. Thank you so very much. Continue your good work.

MR. LALOR: Mr. Speaker, I have a great introduction today. She's making her first ever visit to the Chamber, my oldest of my four children, Katie, is with me today. She is an amazing girl. She's very proud of what we call her special heart. She was born with something called Hypoplastic Left Heart Syndrome.

She was born without a left ventricle. She's endured four open heart surgeries and now she's a beautiful 11-year-old girl. She's about to finish the 6th grade at Brinckerhoff Elementary School. She plays softball, and her real passion is singing and acting. She's played Annie in a local production of *Annie*, she's been Cosette in *Les Mis*, and she's going to be in a production of - what's the play this summer - *Mary Poppins*, this summer. So, please extend my first born, my beautiful Katherine Mary, all the cordialities.

ACTING SPEAKER AUBRY: Certainly. On behalf of your dad, the Speaker and all the members, Katie, we welcome you here to the New York State Assembly. As family, you always have the privileges of the floor. We will always be happy to see you. Continue on in your aspirations and in this place, we could use a Mary Poppins or two.

MR. MCDONALD: Well, thank you, Mr. Speaker. On behalf of myself and Member Fahy, we are joined today by the 5th grade class, the dual language students, from the Albany City School District's Delaware Community School, joined by their teachers, Mrs. Travez, and also School Board Member Jenn Lange.

The Dual Language Program is the only program of its kind in the northeast corridor of New York State. Mastery of more

than one language and understanding and appreciation of both cultural and linguistic diversity truly contributes to success in our multi-cultural nation. Children who learn to read in their native language very quickly catch on to reading in their second language. The same is true for math, for science and social studies concepts. Concepts are learned in one language, and then naturally transfer into the second language.

This unique language emersion program in Spanish and English is open to children throughout the City of Albany starting in pre-K. It features one bilingual class for each grade through 5th grade, evenly divided between Spanish and English teachers. Instructional time is divided between learning in Spanish and in English, and content area is integrated to grow cultural and linguistic exchanges among the students. This program is taught by bilingual professionals, many of whom are from Ecuador, Puerto Rico, Dominican Republic, Peru and the United States. In addition, there's also a bilingual school psychologist and speech therapist. Because of their backgrounds, the teachers share their cultural heritage with their children, helping them to better achieve a multra -- multi-cultural awareness.

Mr. Speaker, if you could please welcome our young guests here to the Chamber and extend to them the cordialities of the House.
