MR. MORELLE: Mr. Speaker, I move to dispense

with the further reading of the Journal of Sunday, June 10th, and ask that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

Mr. Morelle.

MR. MORELLE: Yes, thank you, Mr. Speaker. Ladies and gentlemen, good afternoon. Before I talk about our schedule for this afternoon, let me note that on this day in 1776, the Continental Congress selected Thomas Jefferson of Virginia, John Adams of Massachusetts, Benjamin Franklin of Pennsylvania, Roger Sherman of Connecticut, and Robert R. Livingston of New York to draft a Declaration of Independence. The Declaration Committee operated from June 11, 1776 until July 5, 1776, the day on which the Declaration was published. I do note that Mr. Gottfried wondered whether or not in the bill drafting world whether they consider June 11th to be Independence Day. I assured him that's probably not the case, but...

Under the heading of "Did You Know," did you know know that Culper Ring was headquartered in Setauket, New York? Located in the 4th Assembly District which is represented by our good friend, Mr. Englebright. The Culper Ring was a group of American spies organized by General George Washington in the summer of 1778 at the height of the Revolutionary War. The Ring proved successful, as it provided General Washington with news of planned attacks and strategies by the British military. A lot of colonial

history today, Mr. Speaker.

Let me talk about our modern history, which will be that we make today. We have on our desks a main Calendar and a debate list. After any introductions and housekeeping, we will begin our work this afternoon by consenting the 49 new bills added to the Calendar beginning with Rules Report No. 34, which is on page 4 of the main Calendar. We will also work off the debate list. Members should be aware we will have a number of committee meetings this afternoon. MR. MCDONOUGH: Thank you, Mr. Speaker, for allowing me the privilege. I have some very special guests here today, members of my family, which are special to me. I would like to introduce them to you. They traveled up from Georgia to be with me

But she raises awareness for congenital heart defects as a patient herself, and there was a wonderful story in our local paper about her ordeal and how she deals with it. And she leads a very productive and successful young life at age 10. She's very active with the Girl Scouts and the Smithtown Historical Society. So I invited her and her mom, Natalie Worthington, who's seated in the back, to come to the Capitol for a visit. So they took a tour today, and they are going to go over to the Senate and meet our Senator very shortly. But I would ask you to please welcome her and offer all the cordialities of this great House.

The latest report released by the U.S. Centers for Disease Control shows that about 1 in 59 children in the United States are now being diagnosed with autism. That's up from 1 in 68 in 2012, and the numbers have more than doubled in less than 20 years. The data also revealed that as autism rates continue to climb, a majority of children are not diagnosed until after age four. My son Michael, who will be 17 this year, was not diagnosed until age three. This delay means that many children are not getting the help that they need. Screening is a way to detect autism before the onset of symptoms. By age two, a diagnosis by an experienced professional can now be considered very reliable. To promote and improve the early identification of autism, the American Academy of Pediatrics has published a -- practice guidelines that recommend screening at the age of 18 and 24 months. Despite these guidelines, most pediatric practices do not consistently use the screening. This bill will amend the Public Health Law -- Law here in New York State to provide these essential screenings that follow the current recommended guidelines.

Early treatment of autism can have a significantly positive impact in the health and well-being of children and their families, and I'm pleased to cast my vote in the affirmative.

In that case, this bill requires the attorney to file their name, business address and telephone number. And I will share with you that their legal fee also has to be approved by the Unemployment Compensation Board even though the legal fee is being paid not by the Unemployment Compensation Board, but by the claimant. This is one more hurdle, making it more difficult for a

claimant to obtain legal representation to represent themselves, and for that reason I will be voting no.
