MS. WOERNER: Thank you, Mr. Speaker. Today I rise to speak on this resolution memorializing Governor Cuomo to recognize Intestinal Malrotation and Volvulus Awareness Day in the

State of New York. Intestinal malrotation is a congenital birth defect that occurs when the intestine fails to rotate correctly during embryonic development. This can lead to a life-threatening surgical emergency where the intestine twists, restricting blood flow to vital organs.

This birth defect was brought to my attention by a constituent, Jolyan Stevens, who joins us here in the Chamber with her son, Charlie, who was sadly diagnosed with this intestinal malrotation after more than a dozen health care professionals failed to recognize his symptoms. Thankfully, Charlie was diagnosed early and received life-threatening emergency surgery and today, Charlie is a happy toddler enjoying life with his family. But for some, this diagnosis comes too late, those like Mya Brown, whose diagnosis was missed by 23 medical professionals and resulted in her death, remind us that we must bring awareness to serious birth defects such as intestinal malrotation and volvulus. Through the education about families and doctors and increased awareness of the symptoms of intestinal malrotation will help thousands of individuals across New York State who are affected by this diagnosis.

I'd like to thank you all for supporting this resolution and for Ms. Stevens for her commendable effort in bringing awareness to intestinal malrotation.
