There are many small businesses that have developed to -- to sell our CBD products that are produced on farms and I am very concerned that as we switch to a licensed retail model, that that will end up being both a tax on small business and that we could see business interruptions as those licenses aren't processed in a timely manner.

I'm given to understand that these will be registrations, not licenses, and that will be a quicker process, but I remain concerned that -- that while this is an important bill for the industry, that it not be a tax on small business and that it not result in any business interruptions. Thank you, Mr. Speaker.

They researched stillbirth and found that there were many other families who had endured the same loss. They have dedicated themselves to helping others going through this and to help ease some of the pain that is involved when a family suffers such a loss. Things like getting a birth certificate or a death certificate or the unexpected costs of a funeral all are obstacles adding to the pain of the loss of their baby.

The Goodwin's found a wonderful organization called Star Legacy which was founded by the Cohlan family, who was from Mr. Buchwald's district, who I believe are also here today. And the Goodwin's have joined with them to help educate the medical and public about stillbirth and to raise funds for research to try and help prevent it. They have taken their tragedy and have committed to helping countless others. Please welcome them and extend the cordialities of the House, Mr. Speaker.
