MRS. PEOPLES-STOKES: Mr. Speaker, I move to dismiss with the further reading of the Journal of Sunday, February the 9th and ask that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

MRS. PEOPLES-STOKES: Thank you, Mr. Speaker. Just to go over the schedule for today, I will, first of all, would like to share a quote. This quote today is, Mr. Speaker, from

Jesse Owens. He was an American track and field athlete and a four-time gold medalist in 1936 - before most of us were even thought about - Mr. Speaker, in the Olympic games. These words that Jesse is sharing with us today I think are as real then as they are now. "We all have dreams. In order to make dreams come into reality, it takes an awful lot of determination, dedication, self-discipline and effort."

With that, Mr. Speaker, I will say that the members do have on their desks a main Calendar. We also have to continue with our consent from our main Calendar last week where we left off, which is at Calendar No. 261. That's on page 47. Full disclosure, there will be a need for a Minority [sic] Conference immediately following Session. And as always, Mr. Speaker, we will check with our colleagues on the other side of the aisle to see what their needs are. That is a general introduction -- a general outline. If there are introductions and/or housekeeping, now would be a great time.

ACTING SPEAKER AUBRY: We will have an introduction.

Ms. Fahy for the purposes of an introduction.

MS. FAHY: Thank you, Mr. Speaker, for allowing me to interrupt the proceedings. This -- this afternoon I'm truly honored to, once again, this year welcome back Rabbi Rubin, who just provided our opening prayer. He is among the most distinguished of

religious leaders in the Capital Region, and he's here today to help us celebrate Tu BiShvat. And I'm sorry, Rabbi, if I don't get that quite right every year. But it is the beginning of the New Year for Trees. Tu BiShvat has developed into an ecological holiday that reminds us of our connection to the earth, and it's our role as -- our role here as caretakers of the environment. This marks the season in which the earliest-blooming trees in Israel emerge from their winter sleep and begin a new fruit-bearing cycle. It's now celebrated as a tree planting festival in Israel, and Jews around the world plant trees in memory of a loved one and friends, share a meal that incorporate dried fruits, nuts -- and nuts, which Rabbi Rubin and his students, along with many other colleagues of his throughout the Capital Region, have provided for members here today. At the heart of this holiday is a celebration of the world in all its glory and complexity.

hope I'm saying this right - Chag Sameach. Chag Sameach, or a happy

If you could offer them the cordialities of our House.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mrs. Peoples-Stokes and the enumerated members, we -- and the Speaker and all the other members, we welcome you here to the New York State Assembly. We extend to you the privileges of the floor. Our thanks and gratitude for the work that you do to help displaced homemakers and to make our State stronger by doing so. We hope you will continue that work, and we always look forward to your annual trip here to Albany to share with us those experiences and the things that we can do to help you help others. Thank you so very much.

Mr. Jones for an introduction.

MR. JONES: Thank you, Mr. Speaker. Canada

MS. WOERNER: Thank you, Mr. Speaker, for allowing me to interrupt the proceedings for the purposes of an introduction. I am joined today by three members of the City government in the City of Saratoga Springs: Mayor Meg Kelly, Commissioner of Finance, Michelle Matigan; and our newest commissioner, Commissioner Robin Dalton of Public Safety. I know many of you are fans of Saratoga Springs, having taken in -- taken in the races there or enjoyed our dining opportunities. But what you may not know about Saratoga Springs is that 50 percent of our elected officials are women. We take great pride in having reached about 30 percent --

Kayla Colasimo, Valerie Schwartz, Todd Verwerk, Dalton Letta and Julian Hartwig. They're excited to be here. They wanted to see the Capitol. This is a first for them, and if you would kindly give them all the cordialities it would be much appreciated.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. DiPietro, the Speaker and all the members, we welcome these extraordinary citizens here to the New York State Assembly. We

extend to you the privileges of the House. This is the People's House. We're so pleased that you are here, and that you're advocating for individuals who we know need an extra hand sometimes. MR. CROUCH: Thank you, Mr. Speaker. I have the honor of introducing some people from my district, the Southern Tier. These people represent ACHIEVE, and formerly, years ago, it was the Broome Tioga ARC, but it's changed their name to ACHIEVE as they've adopted different missions. They've actually gone into Chenango County, so now they provide services for people with developmental disabilities in Broome, Chenango and Tioga County. There's some wonderful things that they're doing. I have four individuals that are here today to represent ACHIEVE and talk to us as legislators. It's Trisha Peters, Mellisa Ellis, Theresa Melnyk, and Cameo Clough. And on behalf of my colleagues Assemblywoman Lupardo and Assemblyman Chris Friend, we all kind of represent that other area that these people work in and do their magic.

So if you would extend the cordialities of the House and give them your warm cordial welcome.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. Crouch, Mr. Friend, Ms. Lupardo, the Speaker and all the members, we welcome these distinguished ladies here to the New

MR. LIPETRI: Thank you, Mr. Speaker. Allow me to interrupt these proceedings to speak on the resolution. April 23, 2010, Brooke DiPalma was off to school as she normally did day after day after day. That -- that morning, her father dropped her off. Before he dropped her off, she went off into the classroom, into the building. He says to her, "I love you." She looks back, as any other daughter would, looks back at her father, locks eyes and says, "I love you." Unbeknownst to Brooke, unbeknownst to her entire family, the -- the DiPalma family, that was the last time she would ever see her father. That was the last time she would ever speak to her father. Those last words, "I love you" were the last words she would ever say to her father, Joe. You see, that day he committed suicide. And like many others across this State, across this nation, that suffer from mental health, suffer from depression or bullying, it was a tragedy that affected them. The glue that stuck that family together was suddenly vanished. But you see, Mr. Speaker, Brooke, her sister Jaimie, her family, they created P.S. I Love You Day. A day where they could speak out to all those individuals, those families, that have to endure these type of tragedies, but more importantly, to prevent these occurrences from ever happening again. So the goal of P.S. I Love You Day is to bring awareness to these mental health illnesses. The goal is to get 70,000 people and 200 schools to wear purple, celebrated each and every year on the second Friday of February. This year it being February 14th. Now, Mr. Speaker, some people will call that a coincidence, the 10-year anniversary of P.S. I Love You Day

falling on February 14th. But as I said, Mr. Speaker, coincidence is just God's way of staying anonymous. And so this year, Joe looks down on Brooke, her sister, her family, and they know that he is with them, specifically on February 14th. The theme this year is "Be proud of who you are. Every little bit of it." And on February 14th as people go to work, as you leave work, as you go about your day, those three words you could say to somebody, "I love you", it may just be a small touch, Mr. Speaker, but it could have huge, long-lasting effects.

So I want to thank you for your time, Mr. Speaker. I want to thank Brooke DiPalma and the entire DiPalma family for building from a tragedy to make sure other families never have to suffer what the DiPalmas had to suffer. Thank you.

ACTING SPEAKER AUBRY: Thank you, sir.

MS. SEAWRIGHT: Thank you, Mr. Speaker, for allowing me to interrupt the proceedings for the purpose of an introduction. I'm honored today to have two very special friends here from Manhattan, and -- Susan Foster and Jacqueline Shafiroff. They are the founders of a non-profit called "A Place to Be(ad) Me", B-E-A-D Me. They both are fabulous humanitarians. Susan Foster was raised on Long Island. She's a celebrated jewelry designer, having designed for Neiman Marcus and Bergdorf Goodman. She now is giving back to society by helping children with art-making to

support specifically children who have suffered trauma in the home. And Jacqueline Shafiroff is a graduate of NYU with a master's in social work and is a board member of this fabulous organization.

I ask that you please welcome them to the Chamber and extend to them the cordialities of the House.

ACTING SPEAKER AUBRY: Certainly. On behalf of Ms. Seawright, the Speaker and all the members, we gratefully acknowledge the fact that you have come and shared with us today. We extend to you the privileges of the floor. We hope that you will continue this great work and that more and more young people will benefit from the work that you do. MS. FAHY: Mr. Speaker, I rise to explain my vote and just want to quickly mention that this bill was proposed as a result of the very rapid growth of transportation network companies, often referred to as Uber and Lyft, and some -- a couple of horrific incidences that did occur when young people or others got into vehicles mistakenly. Vehicles that weren't identified in any obvious way. Especially those that didn't have a light identifying them as a Lyft or Uber, and had no identification inside the vehicle. So this requires that there be some type of light or notification as you do see on many of them, especially Lyft vehicles, and it requires that there be a picture ID on the inside of the vehicle as you might see in a taxi cab, as you often see in a taxi cab. So it's something that we think is just an extra safety standard, especially for those who may jump in coming out of a -- something late at night, a concert or what have you, and not necessarily realize what vehicle they're getting in. And so it's for the passengers' protection, and thank you for the support on this.
