MRS. PEOPLES-STOKES: Mr. Speaker, I move to

MRS. PEOPLES-STOKES: Thank you so much, Mr. Speaker, and good morning to my colleagues and friends and guests that are in the Chambers with us today. We are going to start with our quote for the day. And I want to quote a gentleman who is just so quotable, he gave tremendous amount of speeches during his lifetime. He left us a great legacy and a great path to follow; it's none other than the Reverend Dr. Martin Luther King. So, I want to provide two quotes of his which I think kind of meet each other. I'm not sure at what time in his lifespan he gave these, or which speeches for sure, but they do kind of meet each other and kind of have a similar message. The first one is, Mr. Speaker, Justice anywhere is a threat --"Injustice anywhere is a threat to justice everywhere." I'm going to repeat that, Mr. Speaker, because I garbled the first word. "Injustice anywhere is a threat to justice everywhere." The second quote by Dr. King this morning, Mr. Speaker, is, "The time is always right to do what is right." Again, Dr. Martin Luther King.

Mr. Speaker, we have our main Calendar on our desks. After there are any introductions and housekeeping, we should continue with the consent of the bills that we worked on from yesterday. We're going to begin on Calendar No. 62, which is on page

9. We will also take up a Rules Report, No. 34, by Assemblymember Braunstein. Members of the Housing Committee should look forward to being called into a Committee meeting off the floor, and Majority members should look forward to a Conference at the conclusion of today's Session. And of course, Mr. Speaker, as always, we will consult with our colleagues on the other side of the aisle to see if they might have a similar need.

MR. MCDONALD: Well, thank you, Mr. Speaker, and I appreciate the opportunity to interrupt our proceedings today. Later on this morning we will be declaring today, February 28th, 2019 as Rare Disease Day here in the State of New York. And we have today with us many representatives from many different organizations here for Rare Disease Awareness Day.

While each of these diseases and disorders may affect a small number of people, rare and genetic diseases together affect approximately 30 million people throughout America. Rare Disease Awareness Day is a campaign to educate the general public and decision-makers about rare diseases and the impact that they have on their patients and their families. The political momentum resulting from this day has also served for advocacy purposes. This campaign has contributed to the advancement of national policies for rare diseases in several countries, and now is the time to join together for better care.

I'd like to introduce our guests who are here today, and I will introduce them by organization. First of all, from NORD, the New York Rare Action Network and the Oley Foundation, we have Mary Wootten and her daughter, Natalie Wootten, who is here, as well as Lisa Metzger, who is with the Oley Foundation. Representing the Cystic Fibrosis Foundation, we have parent advocates Emilie McHale, Maribel Lape and Brock Lape. Representing the Leukemia and Lymphoma Society, we have the Executive Director, Maureen O'Brien, and past Board Chair, Brad Wagner. And we also have with us today a two-time blood cancer survivor, Barbara Silver. And representing the Rare Kidney Disease -- the Northeast Kidney Foundation, excuse me, we have its Executive Director Carol LaFleur, and Francesca Caseragola, who is a patient advocate for the Northeast Kidney Foundation. For the Juvenile Arthritis Disease, we have the State Director of the Arthritis Foundation, Mary Barlett, and representing the American Cancer Society, we have Mark Kaplan, who is a Senior Regional Media Advocacy Manager.

Mr. Speaker, if you could please extend our special group the courtesies of the House, it would be appreciated. Thank you.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. McDonald, the Speaker and all the members, we welcome you here to the New York State Assembly. We extend to you the privileges of the floor. We commend you on the work that you do to assist and bring awareness of these rare diseases. We hope that you will continue that work and know that we appreciate it greatly. Thank you so very much.

MS. MALLIOTAKIS: Thank you, Mr. Speaker.

Today, it's my honor to introduce a very special little advocate from Staten Island, and that is 11-year-old Ava Rose Garnett. She is one of the many people who make me very proud to represent my home borough. As my colleague mentioned, today is Rare Disease Day and she's an advocate because she has a rare disease. Her genetic disorder is known as Nail-patella Syndrome. And Nail-patella Syndrome causes serious abnormalities of the joints and nails and can cause serious health problems. But anyone who knows Ava knows that that has not slowed her down a bit. Ava attends the 6th grade at IS 75 and has grown up playing soccer and other sports, and as a member of Girl Scout Troop 5116, she handcrafted hundreds of ribbons each year to raise awareness for Rare Disease Day and, in fact, I'm wearing one

today. After meeting Ava as she advocated for rare diseases at my Women's History celebration last year, I felt so inspired that my staff and I brought ribbons to our office and we, during Session last year, presented her with a proclamation; in fact, she is the youngest person to receive a [sic] Assembly Proclamation from my office, and I'm very proud of Ava.

Since then, Ava has continued to raise awareness of rare diseases by modeling adaptive clothing for Runway of Dreams. She also attended SheLift in Colorado, where she connects with other differently limbed young women and mentors at outdoor retreats, where she proves that she can do anything. She also recently had her first taste of show business when she had the opportunity to appear on an episode of CBS' series *God Friended Me*. I'm thrilled that Ava is able to join us today to hear firsthand about this resolution and how much New York State cares about her cause. Keep a look out in your mailboxes today, or if you see us later on you may get one of Ava's famous ribbons that she brought to Albany herself. And she is joined today by her parents, John and Heather, who are in the first row, and her brother, John Russell. So please welcome them and I would love if my colleagues can stop by and say hi to Ava before she leaves.

Mr. Braunstein to explain his vote.

MR. BRAUNSTEIN: Thank you, Mr. Speaker.

Today, the State of New York is taking a strong stand that revenge porn will no longer be tolerated in our State. Victims of revenge porn are frequently harassed, stalked. They have a hard time sometimes finding a job, sometimes entering into new relationships. They suffer extreme emotional distress and even sometimes commit suicide. So today, we're sending a message to anybody who is thinking about disseminating revenge porn that if they choose to do so, they could potentially spend up to a year in prison. This will have a deterrent effect on that type of activity. It will prevent many people from becoming victims of revenge porn.

Also, I appreciate the Speaker's assistance and the Codes Committee's assistance in including a provision in this bill that would allow victims to petition a court to issue an injunction to require websites to take revenge porn down. Very often victims aren't necessarily interested in seeing someone go to jail, sometimes they're

not looking for money damages. A lot of times what they simply want is for the pictures to be removed from the Internet so they can move on with their lives. And today, we're providing them a tool to use to have a court issue an injunction so those pictures can be taken down. So, I'm proud to have sponsored this bill and I think it will protect many New Yorkers once it's passed and signed into law. Thank you very much.

ACTING SPEAKER AUBRY: Mr. Braunstein in the affirmative.

Ms. Fernandez.

MS. FERNANDEZ: Thank you, Mr. Speaker, for allowing me to explain my vote. I thank the sponsor for taking up this legislation and his years of work on it. This piece of legislation is so needed and extremely timely for this day and age. We're in a time that technology has a piece of nearly every aspect of our lives. No one can deny the influence of social media and the Internet. Plain and simple, revenge porn is abuse, a form of abuse exposing the most private parts of a person's life using their own body against them. It is violating, it is life-threatening and it is abuse done with the direct intention of harming someone. The State has made huge strides in protecting those most vulnerable and, in this case, women, and has given new opportunity for justice. This piece of legislation is no different from that and, again, I thank the sponsor and the activists, the victims and anyone else in fear of being wrongfully exposed. So with that, I vote in the affirmative.

MS. GLICK: Thank you very much, Mr. Speaker. Briefly let me just congratulate my colleague. This has been a long overdue action. He's worked very hard for a long time. Many of my friends are grateful that we were -- our lives preceded social media and that the sort of thing that has happened to young people and continues to negatively impact their lives after a relationship breaks up is outrageous and tragic. And I just want to congratulate him again for the work that he has done to bring this to fruition today. Thank you so much and I withdraw my request and vote in the affirmative.
