MRS. PEOPLES-STOKES: Thank you, Mr.

Speaker. We would like to begin with a former colleague of ours who you might know has stood in the front of the Chambers [sic] since he arrived. It's none other than - I think he used to sit right back here where -- somewhere near where Barbara Lifton is. But it is always good to see him, Mr. Brodsky. He served for a number of years. Before I got here, he served for a number years while I was here. He's a member of -- of distinction and I would ask that you would welcome him to -- back to our Chamber.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mrs. Peoples-Stokes, the Speaker and all the members, and I'm not so sure about distinction --

MRS. PEOPLES-STOKES: Mr. Speaker, if I could also take this moment to introduce another very special guest in our Chambers [sic]. It's none other than Ziva Weinstein. She is a retired teacher, where she taught in Brooklyn for many years. She now lives in Manhattan. And in five weeks she will be celebrating her 90th birthday. Can we give you her an early birthday celebration, Mr. Speaker? Ms. Weinstein.

ACTING SPEAKER AUBRY: Mrs. -- Certainly. On behalf of your daughter, the Speaker and all the members, we welcome you here to the New York State Assembly. We extend to you as family the privileges of the floor. Happy Birthday. We are always so glad to see you. And clearly, your daughter enjoys it more than we do. Look at the joy on her face. Thank you so very much.

Ms. Niou for an introduction.

MS. NIOU: Thank you, Mr. Speaker, for allowing me to actually take this opportunity to introduce some very special individuals whom I've invited to spend the day with us in Albany to specially celebrate the Asian Pacific American Heritage Month. So, today we are actually joined for the first time in our legislative Body's history by members of Red Canary Song, who Ron will be introducing, and also my friend, Havana Rose Liu. Do you want to stand up, Havana? And so, Havana is actually an amazing multimedia artist. She actually has been advocating a lot for body positivity and

self-identity. She's recently graduated from New York University. She earned a self-directed degree on the intersection of art, activism and wellness practices. And her bilingual heritage and experiences growing up have shaped her entrepreneurship and encouragement of female empowerment, identity and multiculturalism. Havana's Tiny Breast line of jewelry further supports women's rights, body positivity and serves the philanthropic channel towards breast cancer awareness.

So, as some of you might know, I have freckles, and Havana has freckles. And when I first saw her, I was like, *Oh my* gosh, I've got to embrace mine, too. And so a lot of folks have said the same thing about her. And also, some of you might know, I recently also found a lump in my breast and -- and -- and these are discussions that we, as women, must have, and so I really appreciate Havana for bringing these things to the forefront. These individuals have really represented a new generation of leaders campaigning for diversity, identity and cultures of Asian Pacific Americans in New York City. We are so proud to have a growing number of Asian Pacific Americans fighting for visibility and challenging the norms of our communities through academia, the arts and political advocacy. They are changing the ways that our Asian Pacific American communities, and in particular our immigrant community, are treated and seen. Unfortunately, today my friend Jin Park is unable to join us, his father had an emergency. But he is the first DACA recipient to ever receive a prestigious Rhodes Scholarship, and he was supposed to be here today as well. I want to thank my colleagues for setting aside

this day to celebrate with us. We want to also recognize that we have seniors from the BRC Senior Center, the Lee's Family Association, Gee How Oak Tin Association and the Xin Wei Association. I encourage all of you to join us in the Well today for a really amazing show. We have brought Satica and also Year of the Ox to be with all of you. So, thank you so much.

ACTING SPEAKER AUBRY: Certainly. On behalf of Ms. Niou, the Speaker and all the members, we welcome you here to the New York State Assembly, extend to you the privileges of the floor. To the entire group in the back, we thank you for taking this time and being with us today on Asian Pacific recognition month. We hope you will continue to come back. Know that you are always welcome. This is the People's House, this is your House. Thank you so very much.

(Applause)

Mr. Kim.

MR. KIM: Thank you, Mr. Speaker, for allowing me to inter -- interrupt the procedures to introduce a -- a few very special guests to the Chamber today. We are celebrating, like we do every single year, APA Heritage Month in Albany. That is today. We will have delicious Korean food later for everyone to enjoy at the Well, please stop by. But every single year, you know, my colleagues and I, we attend countless Asian Heritage Month celebrations to only highlight the successes and oftentimes, without even knowing, perpetuating ourselves the modern minority. We need to disrupt this

and have some uncomfortable conversations that's going on in Asian-American communities. We are also victims of poverty. One out of four Asian-American seniors in New York City live in poverty. One out of five Asian-Americans live in poverty. In fact, out of all minority groups, Asian-Americans are the highest in terms of the rapid poverty rates growing in all communities. And in my backyard in -- in -- in Flushing, you know, instead of dealing with the poverty, we have a city that continues to criminalize poverty, culminating in the death of people and constituents of mine like Yang Song, who was a sex worker two years ago who had been targeted, who had been harassed for months before on that tragic day in November of 2017 when she fell from a fourth-floor balcony during a targeted police raid. Instead of having honest conversations about these incidents, we continue to send more surveillance and more police to these sites. Instead of embracing that there is economic injustice also in Asian-American communities, we look the other way. But Red Canary Song, the group that I'm proud to announce to the floor today, has come forward and say, Enough is enough. We're going to organize, we're going to reverse the narrative that had hurt Asian and all American communities. So, I am proud to announce my good friend, Kate Zen and the Red Canary Song to the floor today, Mr. Speaker. Thank you.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. Kim, the Speaker and all the members, we welcome you here to the New York State Assembly. We extend to you the privileges of the floor, hope that today's trip will be beneficial to you and to all of us.

Ms. Romeo for the purposes of an introduction.

MS. ROMEO: Thank you, Mr. Speaker. And I rise today for a very exciting introduction and honor for a resolution this Body will be adopting today recognizing May 30th as Women in Baseball Day, and in honor of the 76th Anniversary of opening day for the All-American Girls Professional Baseball League. I am honored to introduce two amazing women here in the Gallery with us today that are former professional ballplayers. I was only eight years old when I first Miss Sarah Ferguson, nicknamed "Sandy" [sic]. Sarah grew up playing sandlot ball and told every neighborhood kid that she had met that one day she was going to grow up to play professional baseball. In 1952 she was invited to try out for the AAGPL through a scout and began playing for the Rockford Peaches the next season. For the next two seasons, she played as catcher and right field, but

unfortunately, the League was disbanded after its 1954 season. When the league ended, Sarah worked at the Olmstead Air Force Base and later at the U.S. Naval Air Development Center, where she had top security clearance and met all original seven U.S. astronauts. After retiring from professional baseball, Sarah had the chance to stay active, empowering future young ball players by coaching and mentoring many individuals and has worked with the All-American Girls Professional Baseball League Foundation since its foundation in 1987.

Sister Toni Ann Palmermo, whose nickname went by "Peanuts," is a member of the School Sisters of St. Francis, who started playing professional softball for the Bloomer Girls at age 11. One year later she was invited to spring training in Cuba with the All-American Girls Professional Baseball League, and at 14 was asked to go on tour in 1949 and 1950. Playing shortstop for the Chicago Colleens and the Springfield Sallies, in her career Sister Toni even had the privilege of playing a game in the original Yankee Stadium. In 1982 she was inducted into the National Women's Hall of -- Baseball Hall of Fame, and was honored at the National Baseball Hall of Fame in Cooperstown, New York. Sister Toni has been a dedicated -- has dedicated the balance of her life working for the poor and empowering other women. These women were two of over 600 professional female ballplayers that were able to live out the dream of many of us former female ballplayers. And I'm very honored to have them here in Albany today to tell their stories and to share in the history that was

the All-American Girls Professional Baseball League.

Thank you, Mr. Speaker.

ACTING SPEAKER AUBRY: Certainly. On behalf of Ms. Romeo, the Speaker and all the members, we welcome you distinguished ladies here to the New York State Assembly, extend to you the privileges of the floor. Thank you for joining us today, thank you for sharing your experiences. You are always welcome here. Thank you so very much.

MS. CRUZ: Thank you, Mr. Speaker. It is my pleasure to introduce Layla Silverstein. Layla is participating in a program with the New York Transgender Advocacy Group, and is shadowing me today.

Layla, stand -- was sitting back here. Okay.

Layla is a college student from New York City and is a nonbinary person. Layla is passionate about advocacy for LGBTQ people, and particularly trans -- transgender, gender nonconforming, and nonbinary people. As a person with a disability, Layla wants to promote awareness of the issues that disabled people face, particularly within the education system. After Layla graduates, they are hoping to pursue a Masters in Social Work.

I ask that you help me welcome Layla to the Assembly. Thank you.

ACTING SPEAKER AUBRY: Certainly. On behalf

of Ms. Cruz, the Speaker and all the members, Layla, welcome to the New York State Assembly. We extend to you the privileges of the floor, we thank you for coming here today, sharing with us today. Please know that this is your House, you are always welcome. Thank you so very much.

(Applause)

MR. RA: Thank you, Mr. Speaker, for the opportunity to interrupt the proceedings and introduce a group of guests we have here today. So, a few weeks back when we were on our break post-budget, I had the opportunity to visit Carle Place High School and speak to some government students who were -- who were very well-informed about what was going on in the Capitol. I have with me today Jason Miller, who is here with the New York Transgender Advocacy Group and is shadowing me today. Jason is a licensed Master of Social Work, working with an agency that assists foster youth in their endeavors and their attempts to carve a future for themselves while they are struggling with being disconnected from a family. Jason has demonstrated to me already quick wit and an insightful nature, and I hope it will have a good experience here today watching the proceedings and enjoying what occurs on the floor once we actually get to work.

So, thank you very much, and I hope you will give Jason your warm greetings, Mr. Speaker.

Legislative Resolution memorializing Governor Andrew M. Cuomo to proclaim May 30th, 2019, as Women in Baseball Day in the State of New York.

ACTING SPEAKER AUBRY: Ms. Romeo on the resolution.

MS. ROMEO: Thank you, Mr. Speaker. On the resolution. Today I rise to -- with my colleagues to recognize May 30th as Women in Baseball Day and to honor the 76th Anniversary of opening day for the All-American Girls Professional Baseball League. The 1992 film, *A League of Their Own*, is said to be one of, if not the best, baseball movie of all -- ever. Prior -- prior to the film's release, the League was one of the best-kept secrets in baseball and a secret, some might argue, that even saved baseball during World War II. Though many are now familiar with its story, when you conduct an online search, Google will show you a list of common-related questions regarding women in baseball and the League, and the second one being, *Was there really an all-girl baseball league?* Well, there absolutely was. And in the fall of 1942, Philip Wrigley, then the owner of the Chicago Cubs, asked his GM to head up a committee on

how to keep fans in the stands to make many quality baseball -- while many quality baseball players were leaving -- leaving the MLB to go to the war. The idea originated then to have a professional women's softball league. The All-American Girls Professional Baseball League was then formed in the Spring of 1943. However, at first the League was attempting to play fast-pitch softball under MLB, Major League Baseball, rules. After some public controversy about using the name "baseball" to define a softball league, the League did eventually transition into playing regular hard ball, or as we all refer to it, baseball. From 1943 to 1954, over 600 women played professional baseball with the AAGBL. In addition to spring trainings, championship series and 108 regular series games, these players also were required to attend evening charm school classes and follow the rules of their team chaperones. During the off-seasons, there were new -- no lucrative contracts for these players. They earned \$75 a week during the regular season, and then in their off-season many would spend their time off the ball field in munition factories, tending to their victory gardens and supporting the war effort. In those 12 years, the players of the League helped change how society views women in professional sports and paved the way for many other professional liaisons in sports to organize professional leagues. At its peak in 1948 there were more than 900,000 spectators that were cheering on their local teams.

Today there are many young girls who feel that their dreams are impossible, that they want to grow up to play baseball. As

a young ballplayer myself, I, too, found myself facing that reality that the one thing I loved the most, there was not an opportunity for me to do. But then I saw the movie, *A League of Their Own* and then I had the opportunity to meet these great women. Women in professional baseball or in any organized sport has been part of the ongoing pursuit for equal treatment and opportunity. The former players of the AAGPBL who pursued their dreams not only set an example for young women on what they can accomplish, but that these dreams were not impossible. But not only were they possible, but they had a rich history. And I'm glad that we, as a Body, were able to honor their history. I hope it becomes a continued tradition, and I thank you for the time.

First, I'd like to thank Assemblyman Zebrowski for carrying this bill and ensuring that New York State is the first in the nation to pass legislation, Harper's Law, named after a beautiful young girl from my district whose family was just introduced. This will set the standard now for a child -- children's safety, furniture tip -- tip-over safety. And I'm proud that the State Assembly, led by Mr. Zebrowski, is leading the way. I'm proud to vote in the affirmative.

ACTING SPEAKER AUBRY: Mr. Zebrowski on the...

MR. ZEBROWSKI: Thank you, Mr. Speaker.

ACTING SPEAKER AUBRY:... to explain his vote.

MR. ZEBROWSKI: My colleagues, if I could just have your attention briefly to explain my vote. This -- this is an important bill that will affect all of our districts. This bill is a first in this nation, and will require furniture to comply with strict safety requirements and require that products contain a tip restraint device

and warning labels. This bill is named after Harper, who, unfortunately, was a young lady who lost her life. But through Harper's memory, her parents have started a not-for-profit called Harper's Smile [sic], which has pushed for awareness to the dangers of furniture -- furniture and -- and tipping over. And through that, we've crafted this legislation which we're going to pass here today, hopefully with my colleagues' support. We had done so previously, and the good news is that the Senate and the Assembly have now reached an agreement, and I believe that this will be a first in the nation law. And it will, through Harper's name and her memory and the dogged advocacy of her family, make all of our districts a safer place and I encourage all my colleagues to vote in the affirmative.

When children are exposed to lead, they suffer devastating health and neurological effects that may persist over a lifetime. This bill requires manufacturers of children's jewelry containing lead to put a label on the jewelry saying, *This contains lead*. And I guarantee you, no parent in New York State is going to buy jewelry for their children that says, *This jewelry contains lead*.

So, it's a simple, consumer-friendly bill that will protect our children from lead poisoning. Thank you, Madam Speaker.
