For the purposes of an introduction, Ms. Woerner. MS. WOERNER: Thank you, Mr. Speaker, for

I know each of us has people in their lives, family members, who have been role models and mentors that have helped get us to the place that we are today. I am pleased to be joined in the Chamber today by one such family member. My Uncle Jim Caird, and his lovely wife, Cindy, have joined us today. Jim is a native of Troy, a graduate of the Albany Academy and Hobart College in the Finger Lakes. And after completing his education, found his way to California where he founded auto insurance specialist, which when he sold it some 40 years later, was the largest independent insurance agency in North America.

During those years, I was fortunate enough to have been given my first work opportunity working for him. And in that, he taught me the value of a hard's days work -- actually, six hard days work in a given week. He showed me what it takes to be successful, just as he was successful. And he -- he also taught me the value of telling a joke. Nobody could tell a joke better than my Uncle Jim. So, I am pleased to have him here today and to welcome him to the Chamber, along with his wife. In their -- in their retirement, they have turned to philanthropy and are great supporters of the Albany Academy down the road and Hobart College and, in fact, that's what brings them to New York today.

MR. MCDONALD: Thank you, Mr. Speaker. And I thank you for the opportunity. As you know, today we'll be passing a resolution declaring May 2019 as Neurofibromatosis Awareness Month. We'll call it NF from this point on just to get through the rest of the day. NF encompasses a set of distinct genetic disorders that causes tumors to grow along various types of nerves. NF causes these tumors to grow anywhere in the body, and it can cause significant damage to nerves leading to hearing loss, visual impairment, balance issues and other functional problems depending on the location of the tumors.

Today, we have two guests with us today representing NF Northeast, Mr. Vito Grasso, and Susan Benjamin. And we are passing a resolution earlier on -- later on today. There are 7,800 families throughout the State of New York that are affected by NF. I see also we have the Nobis family, Peter Nobis, Amelia Nobis

and Nancy Nobis, and also Amanda Metott and Dalton Metott, as well. The reality is living with NF is like living with other chronic diseases. It can be challenging and often at times it can be discouraging. Our purpose in designating May as NF Month is to call attention to this devastating disease, to acknowledge the clinicians who treat patients, and also to acknowledge the scientists whose work provides hope for these families and the patients. It's also to recognize the individuals whose lives are affected by NF and whose valiant struggle to live full and productive lives in spite of their disease is an inspiration to all of us.

Mr. Speaker, if you can please welcome the members of NF Northeast to the People's House, I'd appreciate it.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. McDonald, the Speaker and all the members, we welcome you here to the New York State Assembly, extend to you the privileges of the floor. Thank you for the work that you are doing to inform us about NF and to help those families who are struggling with it and, of course, the best that we can ever do is help folks who may never know our name. ACTING SPEAKER AUBRY: Mr. Zebrowski on the resolution.

MR. ZEBROWSKI: Thank you, Mr. Speaker, for allowing me the opportunity to briefly talk about this resolution, ask my colleagues' support to once again declare May as Hepatitis C Awareness Month. We made great strides here in New York State as being a leader across the nation in terms of promoting testing and getting folks into treatment in Hepatitis C. Many of you served with my father who passed away from complications related to Hepatitis C; some of our newer members did not. But New York has led the way and had a first in the nation testing law that required that folks be offered a one-time test, and that's done a host of good work in terms of getting folks aware of their disease and into treatment. And we have actually had some tremendous advancements in treatment where there

actually is what we can call a cure. But, of course, we have to get the folks that are afflicted with the disease into treatment in order to get a cure because if you wait too late, it can become too late and folks can actually be too -- too late for treatment and pass away.

Just a few statistics, Mr. Speaker, about the disease. Right now, there is currently about three to five million Americans and 280,000 New Yorkers that are afflicted with Hepatitis C. About 34,000 new cases nationwide each year; about 15,000 in New York State. And there's about 20,000 hospital-related deaths each year. Historically, it's disproportionately affected the Baby Boomer generation. This is a generation that may have gotten medical procedures prior to even the knowledge of Hepatitis C. So, therefore, they may have contracted Hepatitis C through blood transfusions before blood was even tested. And the way the disease works is that it lies dormant in your system affecting your liver, breaking down your liver, leading to cirrhosis and cancer. And by the time you know it, it's too late for treatment, which is why it's so important to get folks into testing. It's estimated that almost 50 percent of those folks that have Hepatitis C right now do not know that they have it.

But there's a new challenge related to the opioid epidemic as we have seen in a host of other areas in our State and in our nation and that is the newest cohort that is getting Hepatitis C actually are those people that are under 30. Ninety-one percent of new cases related to injection drug use for those under 30, which means that we have now an entire new age cohort that we need to get

into testing. So, I'm hopeful with the efforts of Governor Cuomo, the Department of Health, all our county Health Departments around the State and many of my colleagues, and I will say that you can do a lot of great work in your districts if you promote this disease, the need for testing and try to get your -- your constituents knowledgeable about this disease, what the risk factors are and into treatment because you can literally save their lives.

So hopefully with those efforts and declaring May Hepatitis C Awareness Month, we can all join together to attack this disease, to get folks more knowledge about it and hopefully get them into treatment and we can save more lives and New Yorkers. Thank you for this opportunity, Mr. Speaker.
