MR. EPSTEIN: Thank you, Mr. Speaker. I rise to explain my vote. So, people with epilepsy have great care many times, but unfortunately there's an illness called SUDEP. And if they don't know about SUDEP before they go to their practitioner, there's a risk of infants dying from SUDEP. And this bill just requires

physicians in New York to inform their patients of the potential risk for SUDEP and what tools and techniques they need to ensure that people do not die. Unfortunately, this happened because a constituent in my district passed away from SUDEP but was not armed with the information necessary to prevent this tragic death. Hopefully, with this legislation passing, other families will be informed with the knowledge to avoid such a loss.

I encourage all my colleagues to support this bill.
