MR. GOODELL: Thank you, Mr. Speaker. The Republican Conference will be generally opposed to this legislation for the reasons I'll explain in a moment. Thank you, sir. Those who wish to vote in favor it, of course, are encouraged to call the Minority Leader's Office and we'll record their vote accordingly.

MS. SOLAGES: I would like to remind my colleagues that this is a Party vote. Majority members be recorded in the affirmative. If there are any exceptions I ask the Majority members to contact the Majority Leader's Office at the number

(The Clerk recorded the vote.)ACTING SPEAKER AUBRY: Thank you.Mr. Goodell to explain his vote.

MR. GOODELL: Thank you, sir. This is a chapter amendment that deals with the obligation of defense counsel to provide copies of all the insurance information for their client. The original bill that was passed last year was opposed unanimously by the Republican Conference because it distorts what should be a system of justice that focuses on what the actual liability is of the defendant, if any, and what the amount of damages, if any, should be. And unfortunately, some of us think this is part of an effort to ensure that attorneys and their pocketbook comes first and the justice system comes second. We've always been concerned, of course, when we see all these advertisements for lawyers urging people to call them. And you might say, How can they pay for all these incredibly expensive *television advertising?* And the answer is, they get a percentage of every case. And so if you settled a personal injury action, for example, the attorney won't take any more from one-quarter to one-third of the entire amount. And that can be substantial. And so what this chapter amendment says is you have to provide the attorney right at the beginning of the case with all the insurance information so that the attorney knows right at the beginning how much gold is at the end of that rainbow. And this makes sure that our attorney colleagues know how much effort to put in, how much cash they'll make if they

settle a case, how much the case is worth right from the beginning. So rather than focusing on the merits of the case and the actual damages, they know how much cash is involved and it distorts the whole process.

Now, the chapter amendment makes the original bill somewhat better because the original bill required that disclosure to be within 60 days and this chapter amendment moves it to 90 days. But it doesn't address the fundamental problem, that is, the focus on the attorneys' pocketbook rather than the justice for the plaintiff. And for that reason I'll oppose it and recommend my colleagues do the same.

Thank you, sir.

ACTING SPEAKER AUBRY: Mr. Goodell in the negative.

Ms. Lunsford to explain her vote.

MS. LUNSFORD: Thank you very much, Mr. Speaker. The purpose of this bill is simply to clarify the nature, timing and scope of insurance disclosure. It's to stop gamesmanship from insurance companies preventing plaintiffs attorneys and trial attorneys from understanding who they are seeking information from, which attorneys need to be involved, and delaying justice for the people of this State who are seeking redress for harms against them. This change helps clarify the timing. It helps relieve some undue burdens on larger organizations that have many claims. Happy to make those changes. And it clarifies that the relevant policies simply need to be disclosed in a reasonable amount of time so that attorneys

are not two, three, four years into a case and suddenly finding out there's another insurance company involved, another attorney involved to make this case take even longer for their clients. You know, these questions of relevancy, which are of course for the courts to decide, are something that we are constantly fighting with insurance companies about. So what these chapter amendments do is simply clarify what is expected of players in a game that is rigged against people in this State, and I'm happy to sponsor this bill.

ACTING SPEAKER AUBRY: Ms. Lunsford in the affirmative.

Mr. Abinanti to explain his vote.

MR. ABINANTI: Thank you, Mr. Speaker. The sponsor of this legislation just gave a very good explanation that this is purely a technical amendment that makes it clear what we did last year. Some people are trying to turn this legislation into an attack on the system of -- of the lawyers getting a percentage of the take at the end and saying that that is a -- a bad system, while the ones who benefit by doing away with the contingency approach are the insurance companies, are the defendants, because poor people cannot afford to hire a lawyer. And when a poor person is damaged, the only way they can get a lawyer is if the lawyer works on a contingency. Similarly, good disclosure limits the amount of litigation in court. If a plaintiff's lawyer understands that there's only a \$10,000 policy, they will not ask for \$400,000 even if \$400,000 worth of damages is

warranted because they will know that defendant cannot pay \$400,000 and they will settle the case much quicker.

This makes the system -- this bill makes the system more efficient and fairer for everyone. Therefore, I vote in the affirmative.
