Legislative Resolution memorializing Governor Kathy Hochul to proclaim February 28, 2022 as Rare Disease Day in the State of New York.

MR. MCDONALD: Thank you, Mr. Speaker. As you know, today is national Rare Disease Day throughout the country and throughout the world. NORD, the National Organization of Rare Disease, is the official sponsor of Rare Disease Day in the United States. And this year's theme for Rare Disease Day is Health Equity. Founded by the European Organization for Rare Diseases, the first Rare Disease Day was celebrated in 2008 on February 29th, a rare day that happens only once every four years. Since then, Rare Disease Day has taken place on the last day of February, a month known for having a rare number of days.

Today is held to raise awareness for rare diseases and improve access to treatment and medical representation for individuals with rear diseases and their families. Treatment for rare diseases is insufficient, as are most social networks to support individuals with rare diseases and their families. Individuals observing Rare Disease Awareness Day today take part in walks and press conferences, they organize fundraisers, write letters and e-mails to their government officials, along with holding events, gatherings, and campaigns. As you can tell, Rare Disease Day is an incredible global event highlighting patients' stories and the importance of community awareness and connection. With over 300 million people impacted by the diseases globally, and over six million people here in the United States, the message is very clear to patients and their families: You are not alone.

here in the Assembly Chamber and wish them all continued success in the future. Thank you.

Legislative Resolution memorializing Governor

Kathy Hochul to proclaim February 2022 as Dominican Heritage Month in the State of New York, in conjunction with the commemoration of the 178th anniversary of Dominican Independence.

ACTING SPEAKER AUBRY: Ms. Reyes on the resolution.

MS. REYES: Thank you, Mr. Speaker. I'm honored to lead the Dominican delegation in introducing this resolution commemorating the 178th anniversary of Dominican independence and Dominican Heritage Month in our State. Since its inception, our beautiful island nation of Quisquella has seen its children carry its reach across the globe. The Dominican diaspora is over two million strong in the U.S.; here in our State, over one million Dominicans call New York their home. My borough of the Bronx now has the largest concentration of Dominican Americans in New York City. The contributions of our -- of our vibrant community, composed of new immigrants, the children of immigrants, and New York -- New Yorkers generations removed, are represented in nearly every aspect of our State identity. We are a proud people grounded by our culture, customs and language, and that sense of unity and pride is what has allowed us to survive and persevere. Unity not only within the Dominican community, but between the diaspora of vibrant cultures in our State is what gives us all strength.

As we celebrated the joyous day of our independence in the community yesterday, we paused to reflect and pray for another country currently fighting to maintain their own sovereignty. Current events remind us that freedom is not free and peace should always be the objective. Our Dominican flag reads, "Dios, Patria y Libertad." Libertad, liberty, the most resonating ethos of our people, one that every person on every continent can relate to, one that we celebrate today and defend every day, one that we carry with us long after we departed our beloved island. Que viva Quisqueya.

ACTING SPEAKER AUBRY: Ms. Tapia.

MS. TAPIA: Thank you, Mr. Speaker. Yesterday we celebrated that 170 years ago our half island was named the Dominican Republic, free and independent of foreign countries thanks to founders Duarte, Sanchez, y Mella. Today, we celebrate with all our brothers and sisters the great day full of pride. With more than two million Dominicans in the U.S. and more than 800,000 of those in the City of New York, we've seen the major concentration in the Bronx, Dominicans have greatly contributed to the fabric of the City of New York and have become a force to be reckoned with.

While some Dominican civic groups began to form in the 1960s, during the 1980s church organizations and social welfare groups up to the need -- to meet the needs of this growing community. Many Dominican voluntary associations, cultural clubs and community-based organizations emerged during this decade. Most notably in the Washington Heights/Inwood neighborhoods of New York City.

After years of organizing and surviving, in 1991

Dominicans began to acquire a visible political presence in New York City with the election of Guillermo Linares to the City Council.

During the 1990s up to 2010, our visibility increased as more

Dominican Americans were elected to seats in the New York City

Council and the New York State Assembly and in the New York State

Senate. And in 2016, we elected our first representative to the

Congress of the United States, Adriano Espaillat. The State of

Maryland, Pennsylvania, and Massachusetts have also seen

Dominicans elected to many political positions, and there have been

Dominican city mayors in the State of Rhode Island and New Jersey.

In New York City and in every place we live, we Dominicans are widely represented among the small business owners. In Washington Heights/Inwood and the Bronx, the stores owned or operated by Dominicans stand out as one of the most significant economic phenomena in the area. They represent an economic engine for the City of New York and the Dominican Republic with thousands of bodegas, supermarkets, beauty salons, barbershops, taxi bases, restaurants, day cares, street vendors among others, contributing billions of dollars annually to the U.S. and the Dominican Republic.

Culturally, we eat mango, rice and beans and sancocho. We are loud, dance merengue y bachata. More than 200,000 of our children attend our public school system, and ten percent of the enrolled in higher education are Dominicans in the State of New York. We are good, passionate people with creativity, that work hard and like progress. We have planted our feet in this

country knowing that we believe in the American Dream and -- and are getting it through the daily struggles and being an example. It is a testament of who we are as a community.

Now I'm going to say something in Spanish, of course: Soy Dominicana, de una tierra alegre, llena de bellos paisajes y mucho gente valiente. Soy de una media isla independiente y soberana todavía. Yo soy de una patria plena, la de Duarte, Sanchez y Mella. Yo soy de la República Dominicana.

Legislative Resolution honoring Piermont Firefighter
Thomas Pomplin posthumously upon the occasion of being the first
African-American Line of Duty Death in Rockland County.

One minute. Shh. A member is speaking, please. Mr. Lawler.

MR. LAWLER: Thank you, Mr. Speaker. And I appreciate my colleagues' indulgence as this, the final day of Black History Month, I thought it fitting to recognize Thomas Pomplin who is the first Line of Duty Death in Rockland County in 1854, and he has never been recognized as such. And so now we are seeking to right

that wrong from well over 150 years ago where Thomas Pomplin sacrificed himself at the age of 28 to try and address a fire in Nyack. And at the time, he traveled along with his brothers in the Fire Department from Piermont, pushing their fire truck three miles from Piermont to Nyack to help put out the fire. And ultimately a few days after that fire, he succumbed to injuries. But he was the first Line of Duty Death in the fire service in Rockland County. And so this year on August 5th on the occasion of the anniversary of his death, we will be unveiling a monument in his honor to ensure that his memory endures and that people understand the tremendous sacrifice he made at a time when African-Americans were not treated well, and at a time when they were not recognized in the manner in which they should be.

And so this is trying to right a wrong from many, many years ago and so I -- I appreciate the indulgence of my colleagues as we pass this resolution in memory and in honor of Thomas Pomplin, the first Line of Duty Death in Rockland County's history of the fire service.
