Then we're going to take up two bills from the A-Calendar, that would be Rules Report No. 95 by Ms. Sillitti and Rules Report No. 96 by

Mr. Stern. If there is any additional floor activity, it will be announced at the appropriate time; however, Mr. Speaker, that's the general outline of where we're going. If you have any housekeeping, now would be a perfect time. Thank you, sir.

Legislative Resolution memorializing Governor Kathy Hochul to proclaim May 1-7, 2022 as Small Business Week in the State of New York.

ACTING SPEAKER AUBRY: On the resolution, Mr. Stirpe.

MR. STIRPE: Thank you, Mr. Speaker. As most of us know, small businesses are the heart and soul of communities throughout New York, from Syracuse in Central New York to Buffalo to Montauk to New York City to Plattsburgh and all the small towns and villages in between. Besides making up the majority of businesses and employing over half of all working residents in this State, the small businesses along Main Street unite and entertain us with restaurants and pubs, independent booksellers, movie theaters, grocery and hardware stores, bike shops, and hair salons.

These past couple of years have been extremely challenging for small businesses. The pandemic, shortages of employees, and persistent supply chain disruptions all have affected small businesses. And while most have risen to the challenge, they still could use some help. That is why in the last two State Budgets the Assembly has included more than 2.5 billion in support for small businesses. Specifically, in 2021 we passed an \$800 million COVID pandemic small business recovery grant program for small businesses that experienced economic hardship due to the pandemic, as well as a number of other programs to help out restaurants, tourism, and the arts. In this year's 2022 enacted budget, we included a \$200 million seed funding grant program for small businesses that began operating during the pandemic. We also enacted a \$250 million COVID capital cost small business tax credit, which will provide small businesses with a 50 percent tax credit of up to \$25,000 to cover unexpected COVID-related costs small businesses had to incur, such as cleaning supplies, outdoor heaters, air purifiers. And we are providing 100 million in tax relief for an estimated 195,000 small businesses to help them keep their doors open.

Additionally, we have enacted several other programs that will provide small businesses with expanded access to capital and job creating investments. The Assembly will continue to support small businesses so that they prosper and remain the backbone of our economy as we recover and grow stronger. Thank you, Mr. Speaker.
