For the purposes of an introduction, Mr. Burdick. MR. BURDICK: Thank you, Mr. Speaker. I rise for

the purpose of making introductions of four of my constituents who are here today, and if you could please stand so we may recognize you. We have 14-year-old Jared Saiontz, his mother, Stacey Saiontz, and his grandparents Sammy and Jean Feldman also are here. And just a very brief word about Jared. Jared is a 14-year-old constituent of the Town of New Castle with over 26 life-threatening food allergies who contacted me a few weeks back with a heartfelt plea that I sponsor a resolution, which we will be taking up today, which is to memorialize Governor Kathy Hochul to declare May 9th through 14th, 2022 as Food Allergy Awareness Week, and that's in conjunction with the observance of National Food Allergy Awareness Week. So I wanted to introduce my constituents, Mr. Speaker.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. Burdick, the Speaker and all the members, we welcome this wonderful family here to the New York State Assembly, extend to you the privileges of the floor. Thank you for the work that you're doing not just for yourself, but other individuals who suffer the same malady. We hope that this work is successful and that we are able to

protect our population and have them understand the difficulties that you have faced in your life. Thank you so very much, and we're really pleased to have you, sir. Have a great life.

MS. LUPARDO: Yes, thank you very much, Mr. Speaker. I rise to introduce Lieutenant Colonel Frank Birt who is visiting us from the Broome County/Chenango County area. As many of you know, we do have a legislative squadron with almost 40 members, and Mr. Birt, Lieutenant Colonel Birt is our liaison. So would you please give him a welcome, Mr. Frank Birt.

Santii, in following the words of the Majority Leader today, has truly made a difference in the lives of others. Through her not-for-profit

organization, Santii's Smiles, she saw that young people of different abilities in the Town of Greece may not have the same opportunity to play with their friends as other children, and so she raised over \$10,000 to help make one of our town's parks and playgrounds more handicapped accessible. In that model and in that vein, she just doesn't want to stop with one park. Her goal is to make every park in the State of New York, in the United States of America, and worldwide available so that all children can play. In the Rochester area, she is the youngest recipient in the history of the very prestigious ESL Jefferson awards, which recognizes exemplary people and citizens in the Rochester area. And I'm proud to call her my constituent and my neighbor, and I'd ask you to welcome her and her family to the floor.

ACTING SPEAKER AUBRY: Certainly. On behalf of Mr. Jensen, the Speaker and all the members, we welcome the Patel family here to the New York State Assembly, and we extend to you the privileges of the floor and our appreciation and pride in you, my young friend, for the work that you have done to help other young people. I know he's here for some festivities this evening and just to meet with some old colleagues. And if you could, Mr. Speaker, please extend the cordialities of the floor.

Legislative Resolution memorializing Governor Kathy Hochul to proclaim May 2022 as Amyotrophic Lateral Sclerosis Awareness Month in the State of New York.

MR. D'URSO: Thank you, Mr. Speaker, and I thank everybody for supporting this -- excuse me. Thank you everybody, thank you for your support on this resolution. ALS, also known as Lou Gehrig's Disease, is a progressive, neurodegenerate disease that attacks motor neurons in the brain and spinal cord. This results in the wasting away of muscle, loss of movement, and eventual paralysis. There are an estimated 30,000 people living with ALS in the United States at any given time. Every 90 minutes, someone is diagnosed with ALS. About 90 percent of all ALS cases are sporadic. ALS can

affect anyone at any age, gender or race; however, for the most part, ALS affects people between the ages of 40 and 70 with no known history of the disease in the family. The remaining ten percent of cases are known as familial ALS. Most people live about three to five years after they experience their first sign of the disease, with one and ten people surviving only ten years. The variable rate of this disease progression makes prognosis difficult to predict, and therapies challenging to develop. Currently there are no effective cures or treatments to stop this disease.

ALS is a complex disease which varies from person to person. Far more research is necessary to discover the effective treatments for each person living with ALS, but thankfully there are many local agencies, volunteers, non-for-profits that have made some amazing strides and fundraising and research as their priorities for such a group. ALS Ride For Life is one of these such groups. Ride For Life was founded in 1997 by Christopher Pendergast and his supporters. Chris was the driving force behind this organization, serving as its president. He ran the daily operations with help from his small but mighty staff of volunteers until his passing in October of 2020. Chris defied the odds, living with ALS for 28 years. The organization is continuing his legacy and celebrating its 25th anniversary this year.

Mr. Speaker, I would like to thank you and all the members for allowing me to speak on this resolution, and I hope that we can somehow find a way to cure this terrible disease. And I want

to thank the many groups like Ride For Life for their ongoing support and efforts to continue to support the people with ALS. Thank you, sir.
