Mrs. Peoples-Stokes.

MRS. PEOPLES-STOKES: Mr. Speaker, I move

that we dispense with the further reading of the Journal of Wednesday, June the 2nd and ask that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

Mrs. Peoples-Stokes.

MRS. PEOPLES-STOKES: Thank you, Mr.

Speaker. Colleagues, this is the last day of this week in the 244th legislative Session, but I want to share a quote with you before we go to the schedule for the day. This one comes from Harvey Milk, who was born in New York and you may know was elected -- the first openly gay person to be elected in the State of California, in San Francisco. Harvey's words for us today, *It takes no compromise to give people their rights. It takes no money to respect the individual. It takes no political deal to give people freedom. It takes no survey to remove repression.* Again, Harvey Milk.

So colleagues we do have on your desk a main Calendar and a debate list. After there's any housekeeping or introductions, we will begin taking up our work with the resolutions on page 3 and then we're going to continue to consent new bills on the main Calendar that were left -- where we left off on yesterday, beginning with Rules Report No. 311 on page 15, going through Rules Report No. 404 on page 33. We will also work off of our existing debate list. Immediately following the close of this Session, there is going to be a need for a Majority Conference, and clearly if our colleagues on the other side need something similar, we will apprise at

that time.

That is the general outline, Mr. Speaker. If there are introductions and/or housekeeping, we could do that and then move on to our work. Thank you so much, sir.

ACTING SPEAKER AUBRY: Thank you so much. And today we have, on June the 3rd, no housekeeping and no introductions.

We will go directly to resolutions on page 3, the Clerk will read.

THE CLERK: Assembly Resolution No. 373, Ms. Glick.

Legislative Resolution memorializing Governor Andrew M. Cuomo to proclaim June 2021, as Gay Pride Month in the State of New.

ACTING SPEAKER AUBRY: Ms. Glick on the resolution.

MS. GLICK: Thank you, Mr. Speaker. The resolution details many of the wonderful successes of the LGBT community from a political and legislative point of view. June is, in fact, Gay Pride Month because in 1969 a group of largely transgender New Yorkers, many women of color, were tired of the constant harassment and police raids, the threat to their liberty, and they rebelled. And we dedicate this month to celebrate being who we are, the freedom to live and love who we care to.

But that -- that celebration is all on the surface.

Underneath we continue to struggle against discrimination, bigotry and, frankly, religious zealotry. There are young people across this State and across the country who remain afraid to be who they are, who face challenges, threats to their -- from their family, from their community. And so we have to redouble our efforts to lift up and remind people that being who you are is no sin. Being who you are should be something you can celebrate and be proud of and, yet, in many places across the globe, just being LGBTQ can be a death sentence. That is a very frightening thing for a lot of people. And our great country has not necessarily covered itself in glory over the years. It has exported some of the most pernicious attitudes and supported the work of people who would push forward legislation and ideas that would result in people being detained, beaten, and ultimately killed.

So while New York State has been a beacon since 1969, I will remind members that I joined this Body in 1991. New York State did not pass basic civil rights for lesbians and gay men until 2002. As a sitting member of this Body, I could have been asked to leave a restaurant with no legal recourse if I was holding another woman's hand. But we have moved. In 2011, we passed marriage equality. My good friend and colleague, Danny O'Donnell, deserves all the credit in the world for the work he did on that and, yet, there are still people who consider themselves progressive who didn't support marriage equality.

We have seen many advances across the country, and I'm very proud of the work that New York has done to lead the nation.

But we should not think that the work is over. Bullying in schools is still a major problem. Fear of being isolated from your family is still a major problem. So while people will celebrate and be proud of who they are, and June is a great month for us to come together to celebrate, we also have to remember that the work is not done, just as we have not eliminated racism, we have not eliminated sexism, we still have to challenge homophobia throughout this State and throughout this nation.

So I want to thank you, Mr. Speaker, for giving me the opportunity to speak on the resolution. I have no doubt that the Governor would be happy to proclaim this Pride Month, but I also want to remind the members that while we celebrate, we have to also legislate and we have to work to make certain that all youngsters feel safe being who they are in this State. Thank you, Mr. Speaker.

> ACTING SPEAKER AUBRY: Thank you. Mr. O'Donnell on the resolution.

MR. O'DONNELL: Thank you very much. I would like to commend my dear friend, Deborah Glick, for her strength, for her courage, for her ability to speak the truth as it relates to a population that is often forgotten about. I'm very proud to have passed marriage equality. And for those members who doubted I would be able to do that, or doubted that my marriage would stick, we're still married, just so you know. And I remain amazed that the ways in which the intolerance comes out from people. And I was given an award in California and a young man grew up on a cattle

ranch in Montana told me that when he came out to his mother, his mother said she knew and that she was shocked because gays and lesbians are the only people not born to their own kind, which I thought was a very profound thing for a cattle rancher to say, because the truth is if you're being discriminated against in many other ways, chances are there's a parent in your house who may have shared that experience. That is not -- rarely the case for our community.

And what we are struggling with is very serious these days. There has been a rash of suicides in the LGBT community during COVID, and I'm trying to clear up why that is, but it's something that clearly needs to be addressed. And so I'm very proud to be a member of this community, I'm proud to serve with this Body. I'm proud that I passed marriage equality, and I'm proud that we will pass the gender recognition bill next week. But in the end, those are all incremental changes when what we really need is to change people's hearts and minds to know that we're not a harm to anyone. So thank you for having this resolution, and let me just once again give a shout-out to Deborah Glick for her hero's role in our community. Thank you very much.

#### ACTING SPEAKER AUBRY: Thank you.

Mr. Bronson on the resolution.

MR. BRONSON: Thank you, Mr. Speaker. First, let me start by thanking the sponsor of this resolution, Deborah Glick, for her leadership, for her steadfast advocacy for my community, the LGBTQ+ community. And to all my colleagues who signed on to this

resolution, it means a great deal to me that you are allies in our fight for full equality. Some of you may have heard me say what my mantra, and it is, *No matter who you are, what you look like, where you come from, who you love or how you identify, we all have dignity. And with that dignity, we all deserve equity, justice, and an opportunity to succeed.* I thank Deborah Glick for passing the Sexual Orientation Non-Discrimination Act. It passed after I was a member of a law firm as a young associate and had my mentor partner say to me, *It's okay with me if you're gay, but if the other partners in this firm find out, there will be no place for you in this firm.* 

Discrimination on the basis of employment -- or on the basis of our status as LGBTQ members in employment, in housing, in banking and on and on, we addressed that legally with SONDA, but we continue to face discrimination.

I thank Danny O'Donnell for being the champion and the lead in marriage equality. There other folks in government who want to take the credit for that, but Danny O'Donnell is the person who made it happen. And to keep this personal still, Danny, I want to thank you because your advocacy for marriage equality allows me to now say that I'm engaged to be married as of this weekend.

So we've come a long ways, but there is so much more we need to do, so much more. Young people who served by the Center for Youth in Rochester, and we have a housing facility specifically for LGBTQ+ youth who find themselves not accepted by

their families, find themselves homeless and walking the streets, find themselves without the support that they need without having the Center for Youth. As Danny mentioned, an uptick in suicide, the murder of our trans members of the community, in particular trans women of color, each year. There's so much more we need to do. We will continue the work legislatively, but we also have to continue the work to have a society that recognizes us no longer as second-class citizens, but as the full humanity which all have and recognizes us as full participants in our society and our community, allows us to be true to who we are and live our authentic selves.

Thank you all of your support. I look forward to Pride Month so I can say I am proud of who I am and I thank all of you for recognizing the dignity and humanity of every LGBTQ+ person. Thank you.

ACTING SPEAKER AUBRY: Mr. Burdick on the resolution.

MR. BURDICK: Thank you, Mr. Speaker, on the resolution. The previous speakers have talked about a very difficult history and hard-fought battles that have been won, but also there's so much more to do. And yes, we did move forward with the Walking While Trans bill earlier this year, but as the previous speakers have said, we have a long way to go. And I believe that it's the responsibility of all of us, the straight community to join with our fellow human beings, because that's what this is about. This is about

dignity. This is about treating everyone equally no matter who they are, as the previous speakers have said. We have a moral responsibility to do more, and I am hopeful that in the closing days that we can move forward with the initiatives that Deborah Glick and Donny [sic] O'Donnell and others have so courageously moved forward. Let's see if we can't pass the Gender Recognition Act. And I'm very proud that it now includes a provision that I had written to make it much easier for trans New Yorkers born out-of-State to change their birth certificates without going through an invasive process.

So yes, we've made progress, but there still is a long road ahead, and I do wish to commend the courage, the fortitude, and everything which the sponsor and those with her have done. Thank you so much.

ACTING SPEAKER AUBRY: Ms. Bichotte Hermelyn.

MS. BICHOTTE HERMELYN: Thank you, Mr. Speaker, for allowing me to speak on this resolution. I want to thank the sponsor for this resolution proclaiming the month of June as Gay Pride Month in the State of New York. In this month, we celebrate the freedom of expression and sexual preference by members of LGBTQ community, and acceptance of members in this community by others.

As many of you may know, when I first came into the Assembly, one of the first flags that I had on my -- my desk was the

rainbow flag. It was to show pride and it was supposed to show -- it was supposed to show support in my pride. And I can tell you, in 2015 after the passage of the Marriage Equality Act in the State of New York, there were still eyes looking at me. *Why do I have this flag on my desk?* And I could remember when the fact that I was endorsed by a local LGBTQ organization called Lambda in Brooklyn, when I was running, that endorsement was then sent by my opponent to all the pastors, religious pastors to use that against me. But you know what was great? All the pastors didn't care. They didn't care, because in the Bible it's un-Christian like to hate, to go against someone because of who they are, whether it's their sexual orientation, their race, their gender. And so they embraced that endorsement.

So Mr. Speaker, I want to say that being an ally to the LGBTQ community is not new for me. It's not an all of a sudden popular thing. It's been engrained in me for a very long time to accept everyone for who they are. And it is time to recognize the impact that individuals and organizations of the LGBTQ community have had in this society and their contributions locally and internationally.

So this month, June, marks the 51st anniversary of Pride Month, which began on June 28th, 1970, one year following the Stonewall Riots which fought the momentum of the LGBTQ rights movement. The Stonewall Riots was an event in time where patrons of the LGBTQ community decided to resist the decades of harassment and discrimination from law enforcement and the government. The Stonewall Riot took place on June 28, 1969 at a bar on Christopher

Street in Greenwich Village, New York City, called The Stonewall Inn. Protest and demonstration pursued for six days from frustrated members of the LGBTQ community. The determination for changes moved -- has moved the pendulum for the LGBTQ community resulting in historical milestones, such as serving openly in the military and the right to same sex marriage in the United States.

I certainly want to thank our champions in the Assembly: I want to thank Deborah Glick, I want to thank Donny [sic] O'Donnell, I want to thank Richard [sic] Bronson and all the members of the LGBTQ, but all the advocates who's been loud and forward on fighting for the rights of all people.

Congratulations, Assemblyman Bronson, I wish I was invited. But I'm really, really excited for this resolution for this day, for this month, and know that I'll always be an ally and I thank you. Thank you. Thank you, Mr. Speaker.

> ACTING SPEAKER AUBRY: Thank you. Ms. González-Rojas.

MS. GONZÁLEZ-ROJAS: Thank you. I'm proud to speak on this bill. I want to thank the sponsor for her leadership, her courage and her tenacity, and being a role model for so many. I also want to recognize our other openly queer trailblazers here in the Assembly. I am proud to consider myself part of the LGBTQ family and I'm proud to represent one of the most queer and diverse districts in New York City. We are the home to the second largest Pride Parade in New York City, in a community that has been on the front

lines of activism. People like Julio Rivera in my community was murdered by White supremacist for both being Latino and for being queer. And as this resolution reminds us how important it is to uplift the courage, the fight, and the resilience of the LGBTQ community, I am so proud that one of my first bills that was passed in this Assembly in this Chamber was a bill that provided dignity and respect to our trans communities to be able to use their preferred name and pronoun on something as simple as their utility bills.

So as many have said, we have done historic things here as a Body, but there's so much more work to do. I'm proud to fight alongside our LGBTQ family. I am proud to fight for dignity, for equity, and for justice. And I can't -- I'm so proud to celebrate Pride Month this year and moving forward. So thank you to the sponsor and all the amazing trailblazers who have been at the front lines of this work. I'm proud to vote in the affirmative.

MR. DESTEFANO. Thank you, Mr. Speaker, for the opportunity to speak on this resolution. The purpose of this resolution is to bring public awareness to the fact that in the United States, there's over 43 million people that are homeless and fall below the poverty line. This means that millions of American -- a million Americans are struggling just to fulfill basic needs. While most of us, if not all, think that there's nothing second nature to having a meal at the end of the day, or breakfast when you're waking up in the morning, that's not really true for everyone. In New York State, there is over 90,000 -- as of 2020, there was over 90,000 New Yorkers that

were homeless. They also have to stress about having the basics in life, something that no one should have to endure. Then as COVID came, for many of us, this started creeping closer and closer to home, starting to see our friends and neighbors starting to struggle. I encourage everyone to keep these individuals in mind and donate time or resources when possible to show that our communities are ready, willing, and able to fulfill those needs that are needed by our friends and neighbors in our communities. Thank you, Mr. Speaker.

After the conflict in Vietnam, it took many years to fully realize the extent of the health damage done to servicemen and women due to exposure to Agent Orange. Unfortunately, a similar pattern has emerged in our veterans who served in the Middle East throughout the conflicts of the past 30 years. The practice of using burn pits to dispose of toxic materials has caused a litany of chronic illnesses for our returning veterans. Because of the nature of these illnesses, it often takes time for the condition to emerge, to get diagnosed, and even to determine the most likely cause. This legislation will ensure our veterans can access New York courts with a cause of action without being barred by the typical period of limitations. I will be voting in the affirmative and ask my colleagues to do the same. Thank you.

Mr. Palmesano to explain his vote.

MR. PALMESANO: Yes, thank you, Mr. Speaker,

for allowing me the opportunity to explain this vote on this local bill and bringing this bill forward to help the -- the kids of the Corning-Painted Post School District who suffered a \$500,000 penalty simply because of technical errors where the clerk did not send in paperwork certified mail. He lost the paperwork so they realized that they had to resend it and because they got in late, they suffered a \$500,000 penalty. A number of my colleagues have similar legislation on your side of the aisle, (inaudible), several on our side. We did a couple of these in the Budget. I still don't know why we only did a couple and not all of them. But I am glad we're doing this bill here today.

But you all know, we're going to get a call from the Governor's Counsel's Office probably around Thanksgiving or

Christmastime, like he has in the past saying he's vetoing the bill because the funding should be dealt with in the Budget. It's a common theme you hear over and over again. So we're going to get that same call again this year. Year after year, we never put it in the Budget. So if the Governor wants to punish kids, it's certainly his right -- Constitutional right to veto the bill. It's wrong, but it's his right. But it's also our Constitutional right to override a veto, and we never do. Why not? What are we afraid of? Him? Really? We're basically saying we're okay with the veto and hurting the kids for they -- they're doing nothing wrong. We're choose -- you're choosing the Governor over the kids. Overriding that veto will say we're an equal, co-branch of government, but it appears that we're okay letting the Governor have all the power. Haven't we ceded enough power in this Legislature to him already over the past 15 months? Enough is enough. It's time to send a clear message to the Governor that we're a co-equal branch and we can show it here today the kids that we stand with them over this Governor. You can do that by overriding the vetoes when the time comes later in the year, because the vetoes are definitely going to come.

The definition of insanity is doing the same thing over and over again and expecting a different outcome or result. We know the outcome and result, we got -- doing it this way over and over again. If we want a different outcome or result we have two choices: One, insist that these bills, all our bills are included in the Budget like the other ones were and -- and not just a couple, all the

bills; or two, we could override the veto to forfeit to be included in the Budget. So, let the --

ACTING SPEAKER AUBRY: Mr. Palmesano, how do you vote?

MR. PALMESANO: I vote right -- I vote yes because it's the right thing to do and we need to override it --

MR. TAGUE: Thank you, Mr. Speaker. To explain my vote. I just want to thank all my fellow legislators for voting in favor of this bill today. This bill is a really, really good environmental bill, will help preserve the Albany Alcove. And I want to take a special moment and thank my fellow Assemblymember, Patricia Fahy, for partnering with me on this piece of legislation. Thank you, Mr. Speaker.

And I would point out that credit unions enjoy a special advantage in New York State that is not available to any of our private banks. All of our credit unions are tax exempt.

They don't pay any taxes. On the other hand, our private community banks, for example, they all pay property taxes. They all pay income taxes. They all support the State of New York.

And so while credit unions were originally designed to allow employees to group their own funds to help other employees, this bill opens the door to credit unions being involved in direct competition with the private sector that actually pays the taxes that are being used to make these deposits. And I think that's an inappropriate role for credit unions and I would recommend that we continue to recognize that our community banks, our New York State chartered banks are the ones that are paying taxes and they're the ones that we've allocated in the past this participation and should in the future. For that reason, I'll oppose it and I would recommend that my colleagues also vote against it. Thank you, sir.

> ACTING SPEAKER EICHENSTEIN: Thank you. Are there any other votes? Announce the results. (The Clerk announced the results.) The bill is passed.

And I'm not up here to say that anyone's being paid off in any of those municipalities or anything like that, but a smart system is designed to make sure that we don't have that potential for favoritism, fraud or abuse, and that we're getting the best price for the taxpayers. I don't understand why the City of Buffalo can't put its bonds out to competitive bid just like hundreds of other municipalities and counties and other entities all across New York State and, therefore, I am opposing this and recommend that my colleagues also do the same. Thank you, sir.

ACTING SPEAKER AUBRY: Mr. Goodell in the negative.

Mrs. Peoples-Stokes to explain her vote.

MRS. PEOPLES-STOKES: Thank you so much, Mr. Speaker, for the opportunity to explain my vote. I want to just make it, you know, really clear that there's no one who is more disappointed by people who lack conscience and serve in government roles and use that position in government roles to either abuse the system or abuse the taxpayers. And I can also assure you, I -- I personally know every City Council member in the great City of Buffalo, not just in your role as Council members, but in their personal lives. And also, quite frankly, know the Comptroller and the Mayor. And so I want to make

people feel comfortable that this is not about an opportunity to do anything that's yet unfair. This is about an opportunity to keep the city going and provide the services to the taxpayers and to ensure that what people pay for, they get. And we are getting much better at that in the great City of Buffalo because of the people who looked at, wrote and signed and sent over here the Home Rule message asking us to do this. And so with all due respect to my colleagues on the other side, I honor your opinion, I'm going to need you to honor mine and I know at some point, you know, everybody needs something for their local government, I'm going to honor yours and I just that -- would ask that you would honor ours, as well.

With that, Mr. Speaker, I'm pleased to vote in support of the city that I represent who asked me and this legislative Body to do something in their interests. This is in the interest of the citizens of the City of Buffalo. Thank you for the opportunity to do this.

I proudly vote in the affirmative. Thank you very much.

So this bill would evaluate this setting in all of these -- all of these industries and also create a long-term strategy for addressing both the profound lack of living wage in all of these areas and the causes of why there's such a shortage, and increase the number of individuals in these fields, which we desperately need for equity in our workforce. If you take the entire Medicaid costs in Florida plus Texas, both of whom are substantially larger than New York State, you would find that our Medicaid costs exceed theirs. On a per capita basis, it's the highest in the nation. We're almost as expensive as California, which is two and a half times larger than we are. So every time we say, *Yeah, let's expand it, let's expand* 

*it, let's expand it*, let's remember that we're adding a huge additional cost to our taxpayers all across New York State.

So while I appreciate the great work they do, I think we also have to exercise some fiscal restraint at some point in time and that's why I will be voting no. Thank you.

But what the law requires is that if an insurance company thinks that part of the claim ought to be approved, they have to -- they have to pay as much of the claim as they approve. So what this bill says is, it wants to change the notice so that it's not confusing to the insured so that the bill needs to -- or the notice needs to indicate whether it's a denial or a partial approval of that claim, and it also makes some changes in terms of the size of the font and some other notice requirements. So it's a -- it's a pretty straightforward bill.

The concern is that because plans are already required to pay the undisputed portion of a claim and to provide notice

require -- regarding the disputed portion of the claim, the changes proposed in the bill, including the notice titles, do not appear to provide any benefit to consumers, and there's also a concern that this is going to require some administrative work to make adjustments to the forms. And, you know, any time that we increase or change regulations through legislation like this, it's just more of an administrative burden and it becomes, you know, kind of what we've sometimes called the death by a thousand cuts. So that's really the concern about the bill, and that's, you know, that's basically it. So thank you very much, Mr. Speaker.

## ACTING SPEAKER EICHENSTEIN: Mr. Goodell. MR. GOODELL: Thank you, sir. Many people

believe that doing an annual stress test on systems to ensure that they can withstand and anticipate, reasonably anticipate natural disasters is a great idea, and I would agree with them. The concern that many of us have on this particular bill, however, is it imposes a \$250,000 a day fine if the stress test is not performed on time. And that fine alone is going to create stress, but an entirely different kind. And ultimately when we impose huge fines on a public utility, it hurts the customers. Even if we say in the law you can't charge that fine back to the customers, what happens is, the utility, if they have to pay a multi-million dollar fine, don't have that money available to actually improve the infrastructure, the very infrastructure that we want to see improved.

And so we have a great Catch-22. If you don't do the stress test on time, we'll make sure you don't have the money available to improve the things that the stress test indicate that you ought to improve. So support the idea, the fine is unreasonable and unfortunately as a result, will hurt consumers and for that reason, I will be voting no. Thank you, sir.

MR. THIELE: Thank you, Mr. Speaker, to explain my vote on this bill. I -- I'm glad that there is -- seems to be general consensus about what this bill is attempting to try to do, which is to

ensure that an annual successful stress test is performed for outage management and communication systems. We had a complete and total meltdown on Long Island with a mere tropical storm. Not Superstorm Sandy, not Hurricane Gloria, a tropical storm which literally created hardships for millions of Long Islanders and cost Long Islanders a lot of money. So I -- I think we have agreement on that. But with regard to the fine, I need to point out two things: One is that the service provider for the Long Island Power Authority which, by the way, the Long Island Power Authority supports this bill and has worked with us on the language, but the PSE&G Long Island has literally taken tens if not hundreds of millions of dollars of compensation under the premise that the system that they provided was ready to deal with a tropical storm such as Isaias. They lied. They were wrong. And that -- that is millions and millions of dollars of ratepayer dollars that got paid to them in the way of a bonus.

Secondly, the kind of hardship and losses that businesses and ratepayers see when the system fails is substantial. And I would just argue that in the face of what PSE&G Long Island has collected under the existing contract, as well as the hardship and financial losses to small businesses and individual ratepayers that occurs when a company like PSE&G does not do what they contracted and what they said they were going to do is -- is -- makes the fine of \$250,000 a day as a deterrent for this kind of egregious behavior --

ACTING SPEAKER EICHENSTEIN: Mr. Thiele, how do you vote?

MR. THIELE: -- makes that fine ultimately reasonable. I withdraw my request and I vote in the affirmative.

ACTING SPEAKER EICHENSTEIN: Mr. Thiele in the affirmative.

Mr. Brown to explain his vote.

MR. BROWN: Thank you, Mr. Speaker. I rise to explain my vote on this bill. I want to thank the sponsor of this bill and with all due respect to my esteemed colleague and my floor leader, this fine is really a way to make sure that the ratepayers on Long Island are protected from the mismanagement of the Long Island Power Authority. When this tropical storm hit, the utility and its contractual manager were completely caught flatfooted. And that's because their system of communication absolutely just crashed. There was no way for ratepayers to find out when their power was going to be turned on, how soon it was going to be turned on, and it completely caught them off guard. It's absolutely unacceptable in this day and age for a public utility like LIPA to operate the way it does. So I urge my colleagues to vote in favor of this on -- my colleagues on both sides of the aisle, because it will force LIPA to actually manage its affairs the way we all expect to. We expect our lights to be on in our homes every day without question, notwithstanding a tropical storm that damaged Long Island the way it did. So I want to thank you for the opportunity and I'm voting in favor of this measure.

ACTING SPEAKER EICHENSTEIN: Mr. Brown in the affirmative.

Mrs. Griffin to explain her vote.

MRS. GRIFFIN: Thank you for allowing me to explain my vote. I thank the -- my colleague for bringing this to the floor. Anything we can do to hold LIPA accountable to the ratepayers is essential. If it takes these fines to get them to do their job appropriately and correctly, then that -- so be it. Last summer this storm was disastrous for the Long Island ratepayers. All over -throughout Long Island, people lost power. Elderly didn't have power, people that were sick. People lost merchandise, you know, businesses were affected and for these reasons, I vote in the affirmative. Thank you very much.

ACTING SPEAKER EICHENSTEIN: Mrs. Griffin in the affirmative.

Mr. Burdick to explain his vote.

MR. BURDICK: Thank you, Mr. Speaker. To explain my vote. Like my colleagues on Long Island, Westchester County is so frequently victimized by breakdowns in the system, and let alone planning for the climate crisis, we need to make sure that the existing distribution system does have the strength, has the ability to withstand the storms that are becoming far more frequent and far more destructive in their path. And so I wish to thank the sponsor for bringing this legislation forward. A stress test is something that should be beneficial not only for the ratepayers, but actually for our electric service providers themselves. So thank you very much. I vote in favor. ACTING SPEAKER EICHENSTEIN: Mr. Goodell. MR. GOODELL: Thank you, sir. In addition to the votes in the affirmative on the floor, please record the following colleagues voting in favor of this legislation: Mr. DeStefano, Mr. Fitzpatrick, Mr. Mikulin, Ms. Miller, Mr. Montesano, and Mr. Smith. Thank you, sir.

No. 260, Dinowitz, Galef, Cymbrowitz, Sillitti, Englebright, Zinerman, Davila, Fahy. An act to amend the Penal Law, in relation to the forgery of immunization records.

ACTING SPEAKER EICHENSTEIN: An explanation is a requested, Mr. Dinowitz.

MR. DINOWITZ: Sure. As I'm sure you all know, a number of recent reports have shed light on the escalating trend of counterfeit or otherwise fraudulent vaccination cards in New York and around the nation. Under these disgusting schemes, individuals sell or distribute forged COVID-19 vaccination cards that are normally provided upon immunization and bear a CDC signature -- insignia. These falsified cards are concerning because of the deleterious impact on our public health and the public's trust when participating in the

activities or attending venues that require proof of vaccination.

So this bill would clarify existing forgery-related sections in Penal Law to explicitly make clear that forging or possessing a -- possessing a forged immunization record, including but not limited to the COVID-19 vaccination record card, shall be considered a Class C or Class D felony depending the number of forged records.

ACTING SPEAKER EICHENSTEIN: Shh. Can we please have quiet in the Chamber?

Mr. Goodell.

MR. GOODELL: Thank you. Would the sponsor yield?

ACTING SPEAKER EICHENSTEIN: Mr.

Dinowitz, do you yield?

MR. DINOWITZ: Yes.

ACTING SPEAKER EICHENSTEIN: The sponsor

yields.

MR. GOODELL: Thank you, Mr. Dinowitz. What is

the current criminal penalty for creating a false vaccination card?

MR. DINOWITZ: There -- there are criminal penalties for forgery. What this bill does, it specifically makes clear that forging vaccination cards falls into those categories. So I don't know that there is a specific penalty, but I think you possibly can be charged on the basis of forgery. But we want to make sure that the law specifically indicates that falsifying, forging vaccination cards

which, of course, can endanger people's lives. You know, if -- if you're at a big venue, say a -- a Yankee game, and they're -- I don't know what they do because I haven't been to a Yankee game yet this year, but I assume they're doing some kind of screening and if you falsely put forth -- put yourself out there as having been vaccinated, that could endanger people's lives. You know, not everybody can get vaccinated. There are certain people who can't, maybe they don't want to, they're pregnant or they -- they're immuno -immunocompromised. So it's very important that we have the opportunity to -- to know in certain cases whether somebody is vaccinated. And by having a forged vaccination card, that is -- well, first of all, it's -- it's a terrible thing to do, but it can actually endanger people.

MR. GOODELL: Am I correct, though, that under existing Penal Law Section 170.10, the creation of a forged vaccination card would be Forgery in the Second Degree, which is a Class D felony, correct?

MR. DINOWITZ: I would imagine, yeah. Yes. MR. GOODELL: And likewise, under Section 170. -- oh, I forgot the section -- subsection number, possession --MR. DINOWITZ: We -- we know what you mean. MR. GOODELL: -- simply possession of -- of a

fraudulent vaccine card, knowing that it was fraudulent, is a Class A misdemeanor, correct?

MR. DINOWITZ: Yes.

MR. GOODELL: And am I also correct that possession of a fraudulent vaccination card knowing it's fraudulent also violates Federal law currently, right?

MR. DINOWITZ: I'm not aware of the Federal law, but I imagine since if you used a CDC, Centers for Disease Control insignia, that that would be a Federal matter.

MR. GOODELL: And I apologize, the reference to criminal possession was Penal Law Section 170.20. Now, the penalty, if we enact this, would be a Class C felony, is that correct?

MR. DINOWITZ: I think it depends upon the circumstances here, including the number of cards.

MR. GOODELL: And a Class C felony is punishable by seven years in prison, correct?

MR. DINOWITZ: I believe that's the -- yes.

MR. GOODELL: Okay. Thank you very much. I appreciate your comments to clarify the nature and scope of this bill.

On the bill, sir.

ACTING SPEAKER EICHENSTEIN: On the bill.

MR. GOODELL: I certainly agree with the sponsor that forgery of an official government document is a serious offense. And, indeed, our current Criminal Procedure Law and our criminal -the Penal Law recognizes that it's a serious offense and already makes it a serious felony. That's if you're the person that's making the forged card. And current Penal Law recognizes that possession of a fraudulent vaccination card itself is a Class A misdemeanor, which is

punishable by up to a year in jail. It is also violation of Federal law because there's a Federal symbol on that vaccination card and replicating a Federal symbol without -- a governmental -- official governmental symbol without authorization violates Federal law.

So for those of -- those in the public that are thinking that it would be fun to create and sell false vaccination cards, it is already a very serious offense. This bill rachets it up one more step and says that if you are in possession of a fraudulent card, you could be facing seven years in prison. And while I agree with the sponsor that this is an important issue, I think the punishment of seven years in prison, six years after no one hopefully is even wearing a mask, is overkill. And I -- so I think the current provisions which provide up to a year in prison -- in jail if you are in possession and several years if you create it are more than adequate. And for that reason, I will be recommending against this legislation. Thank you, sir.

#### ACTING SPEAKER EICHENSTEIN: Mr. Reilly.

MR. REILLY: Thank you, Mr. Speaker. Will the sponsor yield for a quick question?

ACTING SPEAKER EICHENSTEIN: Mr.

Dinowitz, do you yield?

### MR. DINOWITZ: Yes.

ACTING SPEAKER EICHENSTEIN: The sponsor yields.

MR. DINOWITZ: I'm not (inaudible) so soft on crime, by the way. Yes.

MR. REILLY: Mr. Dinowitz, thank you. So this bill would make it a Class D felony?

MR. DINOWITZ: Again, it depends on the number of forged vaccination cards you have. For example, if you have, say, 51, you're probably not merely possessing but you're distributing. So it depends.

MR. REILLY: So -- but if you have one, is it the

Class D?

MR. DINOWITZ: Yeah, I believe that is right. MR. REILLY: Okay.

MR. DINOWITZ: I'd have to double check, but I believe that's the case.

MR. REILLY: Okay. So under this, would the individual who was arrested, would they be eligible for a desk appearance ticket?

MR. DINOWITZ: A desk appearance?MR. REILLY: A desk appearance ticket, correct.MR. DINOWITZ: I don't know.

MR. REILLY: Okay. The only reason I ask is under current law when we did the -- when this Body passed bail reform and it was signed, Class E felonies allowed desk appearance tickets and ironically, one bill that we talked about was 3D firearms and the possession was a Class E felony. So we allowed a desk appearance ticket under that --

MR. DINOWITZ: Well perhaps that still be the case

here.

MR. REILLY: Well, that's -- that's what I'm asking. If this is a Class D felony, this wouldn't be eligible for a desk appearance ticket, is that correct?

MR. DINOWITZ: I don't -- I don't think so. I think a Class E would. I mean, the -- the -- we're not actually debating bail reform. I know you like to talk about that, but this is about this bill but I think --

MR. REILLY: Well, it's about -- it's about criminal justice reform and criminal justice issues --

MR. DINOWITZ: No --

MR. REILLY: And if we're going to talk about --

MR. DINOWITZ: Well, no, actually it's about

making sure that people who were committing reprehensible acts by putting themselves out there or helping other people do so as people who have been fully vaccinated, thereby endangering the lives of others, that's what this bill is about.

MR. REILLY: Okay. So -- so we're going -- so just taking it into context about the class of felony that we're talking about, you're making the possession of a forged immunization card a Class D felony as it relates to other crimes under criminal justice reform. I think it just outweighs the severity considering that we were okay with allowing a Class E felony for a 3D firearm, which could actually cause public safety concerns. So that's -- that's -- I wish we would just halt a little bit and -- and weigh the severity of the actual crime that we're

talking about.

MR. DINOWITZ: Well, I would argue that this, the -- the act of possessing false vaccination cards is a very serious threat to public safety. Not all threats to public safety involve -- involve somebody taking a gun or a knife and hurting somebody. Spreading a deadly disease which has killed almost 600,000 people in this country, which is the greatest death count of any event in the history of the United States of America other than the Civil War, I would say is a very serious matter and we should do everything we can to prevent additional people from dying. And people who possess or worse than possessing, distribute those cards are potentially committing serious violence and threatening the lives of who knows how many people.

MR. REILLY: Okay. I -- I appreciate that answer. And I -- I am in no way downplaying the severity of the pandemic and the lives that were lost, I'm just putting it into perspective of what we're talking about when it comes to criminal justice and we're adding a -- a provision into the Penal Law. So just when you look at the comparison, it -- it's just a little concerning. But I thank you for your answers and I appreciate it. Thank you --

MR. MORINELLO: Can we have an explanation,

please?

ACTING SPEAKER CUSICK: An explanation has been requested, Ms. Paulin.

MS. PAULIN: Yes, thank you, Mr. Speaker. The bill exempts victims of sex trafficking from the requirements to provide a DNA sample for the State DNA Identification Index.

ACTING SPEAKER EICHENSTEIN: Mr.

Morinello.

MR. MORINELLO: Will the sponsor yield for a couple of questions?

ACTING SPEAKER EICHENSTEIN: Ms. Paulin, do you yield?

MS. PAULIN: I would be happy to.

MR. MORINELLO: Thank you.

ACTING SPEAKER EICHENSTEIN: The sponsor

yields.

MR. MORINELLO: I just want to clarify a couple of things. This is an amended version because the loitering provision was removed. Am I correct, based on --

MS. PAULIN: Absolutely.MR. MORINELLO: -- based on prior legislation?MS. PAULIN: Yes, exactly.

MR. MORINELLO: The main purpose of this is of course to protect victims of sex trafficking; am I correct?

MS. PAULIN: That's correct.

MR. MORINELLO: Okay. But it also includes just prostitution, the crime of prostitution. Can I ask why that is included in there?

MS. PAULIN: So the -- I think that most sex trafficking victims don't identify by age automatically. So by including that broader definition, you capture a sex trafficking victim who happens to have been arrested for prostitution.

MR. MORINELLO: Was there ever any consideration that the DNA sample may be helpful to the victim of sex trafficking?

MS. PAULIN: I think that, you know, what most -you know, most of the sex trafficking victims are actually -- or many are in domestic violence shelters. That's how, you know, my

familiarity with -- with sex trafficking victims occurred. And those advocates explained to me that this, the trauma of providing a DNA sample is a trauma to these victims. They're -- they're young girls. Even if they look like they're 18 or 19, they're often 14, 15 and they're traumatized by the entire experience and this is just one more trauma that we're trying to avoid.

MR. MORINELLO: I was more focusing on those that are victims of sex trafficking that may have been taken out of their homes, out of their villages and brought into this country and then spread around the country. So this also would be those that are involved in the prostitution, but that may not be technically sex -victims of sex trafficking. Can I interpret it as that?

MS. PAULIN: Sure.

MR. MORINELLO: Well, I'm just trying to clarify it.MS. PAULIN: No, it's generally true, yes.

MR. MORINELLO: Also, was there ever any consideration that the DNA on those that are truly victims of sex trafficking may have other family members that will become victims of sex trafficking that are in different areas of the country that can tie them together or locate each other?

MS. PAULIN: I think that, you know, unfortunately victims in this circumstance can't -- just like -- very -- it's very similar to domestic violence. You can't force someone who's a victim in this circumstance to leave that life.

MR. MORINELLO: Okay.

MS. PAULIN: You have to hope that they want to and that they seek help. So what the DNA does is they could link them perhaps, although I don't know that the families use the DNA database to do that. I don't think they do, I think it actually is prohibited from their use, I think it's just law enforcement. But even if we change the law to allow, I -- I don't know that they're going to be able to find that victim through this mechanism or use it. There are other mechanisms unfortunately, you know, that we have done through our laws which are -- which are better in terms of helping a victim come to terms with their own issues. You know, I passed a law that requires, for example, little cards in hotels for a victim if they see the -- they see the phone number, they can memorize it, they could take the card and put it in their shoe and then they could seek help. So I -- I think that we have to encourage victims to come forward. Forcing them, which might be one of the things that you could do with a database like this, hasn't been shown to be helpful.

MR. MORINELLO: Thank you.

On the bill, Mr. Speaker.

ACTING SPEAKER EICHENSTEIN: On the bill.

MR. MORINELLO: Thank you for the answers and answering my questions. I think we all agree that sex trafficking does occur. I think we all can agree that victims of sex trafficking are traumatized. But I believe that we need to look at it and break it down into two categories: Those that are in prostitution because of their own desires versus those that have been plucked out of their homes,

taken from disadvantaged areas and forced into organized sex trafficking. DNA also can be helpful in identifying. For example, if a victim of sex trafficking that may have been placed in the working position in the East may then be moved to the West. That DNA could help exonerate them from another charge in another part of the country, rather than harming them.

Additionally, as I had stated in my questioning, and I had spoken on this on the floor before through my domestic violence training, the -- there's many villages in foreign countries that these organized sex traffickers will go in and take disadvantaged individuals, bring them into this country, move them around and become part of an organized sex trafficking ring. Many times they would take members of the same family, they would separate them. And I just look at DNA not as a negative for traumatizing, but as a positive to assist in bringing family members that have been victims of sex trafficking from disadvantaged areas and moved around the country. Thank you very much, Mr. Speaker.

ACTING SPEAKER EICHENSTEIN: Read the last section.

Legislative Resolution mourning the tragic and untimely death of NYPD Police Officer Anastasios Tsakos on Tuesday, April 27, 2021.

ACTING SPEAKER EICHENSTEIN: Mr. Brown on the resolution.

MR. BROWN: Thank you, Mr. Speaker. Thank you for giving me an opportunity to put forward this resolution mourning the tragic death of NYPD Police Officer and Highway Patrolman Anastasios Tsakos. The resolution states it is with profound sadness that legislative Body records the passing of New York City Police Department Police Officer Anastasios Tsakos, who made the ultimate sacrifice on Tuesday, April 27th of this year while faithfully executing his responsibilities, serving with dedication, loyalty, and compassion and who devoted his purposeful life and career to serve and protect.

Officer Tsakos exemplified what it truly means to give himself in providing vital police services in keeping the whole noble mission of the New York City Police Department.

Officer Tsakos, a 43-year-old resident of East Northport, New York, and a few blocks from where I grew up, died in the line of duty following a tragic accident. Early in the morning on Tuesday, April 27th, Officer Tsakos was struck by a passing vehicle as he stood next to his marked car while diverting traffic from a previous fatal crash on the Long Island Expressway in Queens, New York. He was rushed in critical condition to New York Presbyterian Queens Hospital, where he later succumbed to his injuries. Officer Tsakos was the son of immigrants from Laconia, Greece. He grew up in Astoria, Queens and was a graduate of St. Demetrios High School. He moved to Greece for a short time to serve in the Greek Military.

In January of 2007, Anastasios Tsakos joined the NYPD upon graduating from the Academy, and he was assigned to the 75th Precinct and the 83rd Precinct before he was assigned to Highway (inaudible). Officer Tsakos was a member of St. Paul's Society, the NYPD fraternal organization for police officers of the Eastern Orthodox Christian faith. A 14-year veteran of the force and a father to two small children, Officer Anastasios Tsakos and his wife recently purchased a home in East Northport. Officer Tsakos was affectionately known as "Taso" to his neighbors. To his neighbors, they knew him as a friendly, dedicated family man and an extremely hard worker. He frequently came to the aid of his neighbors when

they were stricken with COVID-19 by bringing them food and items needed from the supermarket. He even helped one neighbor put up molding. And although he worked nights, Officer Tsakos enjoyed playing with his children during the day.

Officer Tsakos gave 14 years to the NYPD, protecting its residents and making sure they stayed safe. He loved being a police officer and was dedicated to his profession, and was well-respected by his fellow police officers who described him as the best of the best. Officer Tsakos performed his duties with great honor, integrity, and pride. He was truly an exceptional role model and an inspiration to his fellow officers. At his funeral, Police Commissioner Dermot Shea posthumously promoted him to the rank of Detective.

Officer Tsakos leaves behind his wife of seven years, Irene Tsakos; his six-year-old daughter, Jenny; three-and-a-half-year-old son, Stavros; older sister, Katina; and younger brother, Lefteris. The New York City community and entire State of New York has lost a prominent officer, husband, father, brother, and friend. He will be deeply missed and truly merits the grateful tribute of this legislative Body.

Irene Tsakos told mourners at the funeral mass that each time she watched her husband, Taso, with their young children, he was patient, wonderful, and fun. And he would say a silent thank you to God for him -- she would, pardon me. She said the couple had looked forward to watching their children grow, head off to college, get married, and planned to grow old together. *I wish we could grow* 

old together, Irene Tsakos said at an emotional eulogy at Saint Paraskevi Greek Orthodox Shrine Church, *That was the plan. But he* was taken from us too soon and now our kids will grow up without their dad. I will be sure they know who he is. Each day they will see his face and learn about all the wonderful things he did and what a hero he truly was. They will never forget, and I will make sure of that, she said. I personally attended the wake and funeral service of Officer Tsakos. I met his wife and his beautiful family, his daughter and his son, his brother, his sister, his father and his mother. I also met his former partner who described him as *the best*. He told me he was a pilot and that one day he wanted to be a helicopter pilot for the NYPD.

I'd just like to read to you a portion of his palm card. It's a poem. It says, quote, "When I must leave you for a little while, please do not grieve and shed wild tears, and hug your sorrow to you through the years. But start out bravely with a gallant smile and for my sake and in my name, live on and do all things the same. Feed not your loneliness on empty days, but fill each waking hour in useful ways. Reach out your hand in comfort and in cheer, and in turn, will comfort you and hold you near. And never, never be afraid, for I will be waiting."

I ask that we stand as a Body and pause for a moment of silence in honor of Highway Patrolman Tsakos, and thank you very much.

ACTING SPEAKER EICHENSTEIN: Thank you.

Mr. Reilly on the resolution.

MR. REILLY: Thank you, Mr. Speaker. We owe a debt to the Tsakos family that we can never repay, no matter how long it takes. We will always remember and honor his legacy for his family, for his brothers and sisters in the NYPD. Rest easy, my brother. Fidelis ad mortem; faithful until death. Thank you.

ACTING SPEAKER EICHENSTEIN: Mr.

Tannousis on the resolution.

MR. TANNOUSIS: Thank you very much, Mr. Speaker. You know, when I learned of the passing of Officer Tsakos, you know, it hit me in two ways. The first is that I, as he, were former members of law enforcement. He was a 14-year veteran of the NYPD, sworn to serve and protect. And the second token, he's also a member of the Greek community, as I -- as I am. He came here as an immigrant with his family for the American Dream, as so many people do. And instead of going into a lucrative business where he could have and provide and make lots of money for him and his family, he instead decided that he was going to serve and protect his community, and that's what he did as a 14-year veteran.

So he leaves behind two young children. He's a native of Astoria, Queens. Those two kids will now grow up without a father because of this tragic incident, but I ask everyone here to please keep his memory eternal and as they say in Greek, (speaking Greek), May his memory always be eternal. Thank you very much.

ACTING SPEAKER EICHENSTEIN: Thank you.

Mrs. Griffin on the resolution.

MRS. GRIFFIN: I thank my colleague for introducing this resolution. This is a tragic and devastating loss and I just wanted to offer my deepest condolences to Officer Tsakos' family, his children, his wife, and his NYPD family, and friends and really thank him for his service. My deepest condolences. Thank you.

ACTING SPEAKER EICHENSTEIN: Thank you.

On the resolution, all those in favor signify by saying aye; opposed, no. The resolution is adopted.

We have a couple more fine resolutions that we will take up with one vote. On the resolution [sic], all those in favor signify by saying aye; opposed, no. The resolution [sic] is adopted.
