ACTING SPEAKER AUBRY: The House will come to order.

In the absence of clergy, let us pause for a moment of silence and let our thoughts go to Louisville and Dadeville. Over the weekend, we lost more lives.

(Whereupon, a moment of silence was observed.)

Visitors are invited to join the members in the Pledge of Allegiance.

(Whereupon, Acting Speaker Aubry led visitors and members in the Pledge of Allegiance.)

A quorum being present, the Clerk will read the Journal of Sunday, April 16th.

MRS. PEOPLES-STOKES: Mr. Speaker, I move to

dispense with the further reading of the Journal of April the 16th and that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

MRS. PEOPLES-STOKES: Thank you, sir.

Colleagues and guests that are in the Chambers, I want to start today's Session with a quote. This one is from Billie Holiday. She was an American jazz and swing musician. Her nickname was "Lady Day" by her friends and her music partner, Lester Young. Holiday had an innovative influence on jazz music and pop singing. Her vocal style strongly inspired by jazz instrumentalists pioneered a new way of manipulating both phrasing and tempo in music. Her words for us today, *If I'm going to sing like someone else, then I don't need to sing at all*. Again, these words, Billie Holiday.

Colleagues have on their desk a main Calendar.

MS. WALLACE: Thank you, Mr. Speaker. I rise to speak on behalf of a resolution asking Governor Hochul to proclaim April 10th, 2023, as Dyngus Day in the State of New York. For those of you who don't know, Dyngus Day is a cultural holiday celebrated by Polish-Americans to rejoice over the end of Lent and to celebrate

the joy of the Easter season. Historically, the tradition is believed to have originated with a baptism of Prince -- - Prince Miekszko, the first historical ruler of the Polish state. Over the years, the tradition has evolved to be a celebration of Polish food, dance, culture and heritage by Polish-Americans across the country. I have the privilege of representing the town of Cheektowaga and part of the East Side of Buffalo, which have been home to one of the largest populations of Polish-Americans for decades. MRS. PEOPLES-STOKES: Mr. Speaker, members have on their desk an A-Calendar. I would now move to advance that Calendar.

ACTING SPEAKER AUBRY: On Mrs.

THE CLERK: Assembly No. A06550, Rules Report No. 119, Weinstein. ACTING SPEAKER AUBRY: Governor's Message is at the desk. The Clerk will read.

THE CLERK: I hereby certify to an immediate vote, Kathy Hochul, Governor.

ACTING SPEAKER AUBRY: An explanation is requested, Ms. Weinstein.

MS. WEINSTEIN: Very briefly. This bill would provide appropriations for payroll, contracts, liabilities, and Federal and State assistance of various State departments and agencies, as well as the Governor, Lieutenant Governor, Comptroller, Attorney

General, Judiciary and Legislature from April 1st through April 20th.

ACTING SPEAKER AUBRY: Mr. Ra.

MR. RA: Thank you, Mr. Speaker. Will the Chair of Ways and Means yield for some questions?

ACTING SPEAKER AUBRY: Ms. Weinstein?

MS. WEINSTEIN: Yes.

ACTING SPEAKER AUBRY: Ms. Weinstein

yields, sir.

MR. RA: Thank you. So April 1st to the 20th, so how much does this bill appropriate in total for that period of time?

MS. WEINSTEIN: Two point nine billion.

MR. RA: Okay. And then we had gone through a couple of numbers in the Committee meeting. How much more than last week's bill, and then how much more total is added into this spending for this week?

MS. WEINSTEIN: There -- it is 946 million over last week's bill, and there is -- of that amount, 845 million is -- are new appropriations.

MR. RA: Okay, thank you. You know, we've done this the last couple of weeks, obviously, so we, I think we're -- we're pretty clear on the types of payments that are coming due and all that type of stuff, but can you give us anything on what's going on and do we think this is the last extender? It's only taking us a few days as opposed to the previous ones that took us a week.

MS. WEINSTEIN: This is the extender that the

Governor sent up through Thursday. We are making progress towards final -- a final agreement. We're not there yet, so I couldn't guarantee that this is going to be our last extender.

MR. RA: Fair enough. Do -- do you have any sense as to once we get past Thursday, because this obviously in addition to having any payments due it takes care of the payroll that would have come up this week much like we did last week and the week before. Do we have any sense as to what might be coming new as we get into after this extender, Friday, Saturday, Sunday?

MS. WEINSTEIN: There is a Monday pay period that would be coming up so we would, once we get past -- we would on Thursday have to do another extender if we weren't enacting a budget.

MR. RA: Okay. Thank you.

Mr. Speaker, on the bill.

ACTING SPEAKER AUBRY: On the bill, Mr. Ra.

MR. RA: So I'm running out of talking points here at this point, but I just want to, again, stress, you know, we all get the importance of it. Actually it's nice to be doing this today. We're not up against a deadline that we were told about to make sure our State workers are paid which is a good thing. I think we're being proactive in that regard. But this is, you know, I know many folks here have been around for awhile, this is the first time in my tenure here that we've done multiple extensions; this is the third one. And it's happening despite the fact that one party is controlling our State

government. And I think at the end of the day we need to figure out a way to have a responsible State budget that addresses the needs of New Yorkers. And I know that it's -- there's so many important issues that are being discussed and, you know, everybody's trying to get what they're looking to get out of this budget, but I'll reiterate, what am I hearing from my constituents? They want local control in their municipalities. They don't like the housing plan that the Governor's put forth. I don't think that is a budgetary issue, I don't think it should be part of this conversation. But also, they're concerned about public safety. Now, I know we talked about policy in and out of the budget, and that's been a debate for years and generally I don't like seeing policy in the budget. But I will say this, when it comes to bail reform, we broke it in a budget and I think we can fix it in a budget.

So I hope that over the next couple days, this takes us to Thursday, that we can come up with a final State budget that is responsive to the needs of New Yorkers, that is responsible in terms of not raising taxes in a time where people are struggling with increased costs, but that will put things like public safety and affordability first and that we can get there in a transparent manner, dare I say. Now, for us to start adopting, I'm just going to throw this out there, for us to start adopting actual budget bills on Thursday, and for them to age properly consistent with our State Constitution, they would need to be in tonight. Now, I'm an optimist, but that may be beyond my level of optimism that we're going to see that without the need for message of

necessity and all those other things that unfortunately have become a matter of convenience, not really a necessity when we negotiate these bills. So I'm going to be voting in favor of this. I urge all my colleagues to do so to make sure the State can continue to pay its bills and pay our workers and do everything it needs to do, but I hope that this is the last of these extenders. Thank you, Mr. Speaker.

Speaker. I just wanted to point out to our colleagues what we're doing with this bill in case you weren't following it. It is very simple. We are acknowledging that cannabis is an agricultural crop in New York State, similar to every other agriculture crop, and is going to allow land use to grow cannabis to be eligible to receive an agriculture assessment allowing farmers to cut their costs of production and keep land in farming. Also, it's going to extend the right to Farm Law protections to our cannabis farmers. So basically we're coming full circle acknowledging that cannabis is a crop that farmers grow legally in New York State. Thank you very much.

MR. GOODELL: Thank you, sir. I will be

supporting this bill. It's a modest amendment to the Public Officers
Law, but I thought it would be helpful if other members also looked at
some of the history. In 2019, Governor Cuomo got quite upset with
the Public Authorities Board because they started questioning the
financial wisdom of some of his grandiose plans to rebuild Penn
Station, and there was a concern by the Governor that perhaps they
might not support his proposal for Amazon. And so the Governor
responded, as was typical back then, by including language in the
budget that said that the Authority Board could only vote on whether
or not there was enough money for the project, and if they voted on
anything else, he had the power to immediately remove them. And
that was the Amendment that went through in 2019 that was forced ---

ACTING SPEAKER AUBRY: One minute, Mr.

Goodell. Really would appreciate it if you took conversations off the floor. Gentlemen, ladies.

Proceed, Mr. Goodell.

MR. GOODELL: Thank you, sir.

And so Governor Cuomo put this provision in the Public Officers Law, forced it through as part of the budget, and basically said the Public Authorities Board had virtually no substantive role in reviewing the wisdom of the project, only whether or not the checks would clear. And this is a modest amendment that takes out that provision and restricts their authority to adjust whether or not the checks will clear. It's a step in the right direction, thank you to my colleague. I do hope that in the future we'll continue to review

this because right now it's a five-member board of which only three people can vote. The Minority, while it's on the board, has no voting whatsoever. And so I'm hopeful that as we move forward we can address that glaring shortfall, but thank you to this bill, I will be supporting it. Thank you.
