MRS. PEOPLES-STOKES: Mr. Speaker, I move to dispense with the further reading of the Journal of Monday, May the

29th and that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

MRS. PEOPLES-STOKES: Thank you, sir. To colleagues and guests that are in the Chambers, I would like to share a quote today from Elizabeth Cady Stanton. Many of you probably know the work that she's done in the Women's Suffrage Rights Movement, not just in New York State, but across America. Her words for us today, Mr. Speaker, *the best protection a woman can have is courage*. Again, these words from Elizabeth Cady Stanton, serving no pun intended by all the women who sit behind me who has already demonstrated enormous amounts of courage, but as well as the women who I serve with in this honorable Body who demonstrate courage everyday.

Mr. Speaker and colleagues, members have on their desk a Calendar, and we also have a debate list. And after some housekeeping and introductions, we're going to take up the following Committees: Ways and Means and Rules. These Committees are going to produce an A-Calendar which we're going to take up today on consent. And there definitely is a need for a Majority Conference in Hearing

Room B at the conclusion of our work today on the floor. And, Mr.

Speaker, as always, I will conference with our Minority Conference to see what their needs are if they have conference needs.

We extend to you the privileges of the floor. Our undying gratitude for the service that you are providing and have provided to this State, to this country, to the world. We hope that you know that you always have friends here and you are always welcome here. Thank you so very much for joining us.

MR. JENSEN: Thank you very much, Mr. Speaker. I rise today to introduce some of my favorite constituents; my wife Casey; my son Brendan; my daughter Margot, along with my cousin Christian Jensen; his daughters Ella and Amelia, my aunt and uncle Lynda and Gary Donovan, my cousin Michael Donovan and his daughter Lottie Donovan-Last. They're here not just to see their favorite Assemblyman at work, but also to celebrate Danish-American Heritage Day, which we will be taking up at the end of session. As a proud Danish-American family, the Jensens, hailing from Copenhagen via Middelfart, we're very proud to welcome and celebrate that day along with my fellow Danish-American legislator, Michael Durso. So

thank you very much, Mr. Speaker, and I appreciate if you could extend the courtesies of the House to the Jensens.

Mr. Speaker, thank you very much for the opportunity today to make this introduction. It's my honor today to introduce Svetlana Lipyanskaya, the first female CEO of New York City Health and Hospitals, South Brooklyn Health, formerly known as Coney Island Hospital. During the pandemic when hospitals were an indispensable part of our public health strategy to defeat COVID-19, Ms. Lipyanskaya developed and implemented a campus-wide strategic master plan that allowed South Brooklyn Health to serve 875,000 New Yorkers from South Brooklyn and surrounding communities. Ms. Lipyanskaya led the recent completion of a new, brand new 11-story Ruth Bader Ginsburg Hospital, and has

developed the Health and Wellness Institute that reimagines and elevates the quality of primary and specialty care services offered to its patients. She has also shepherded the creation of several lifesaving services and programs that place vital care for heart disease, heart attack and stroke close to home to our community. Throughout her tenure, Ms. Lipyanskaya has focused on aligning the hospital's mission, vision and values around access, quality and patient-centered care. She is truly a visionary, with unwavering leadership, to move South Brooklyn's health care system forward to better serve our community.

Mr. Speaker, would you please welcome Svetlana Lipyanskaya to our Chamber and award her the cordialities of the House. Thank you, Mr. Speaker.

ACTING SPEAKER AUBRY: Certainly. He is a U.S. Army Recruiter. He lives in and works right around in the Capital District, he's a very active member of recruiting for the Army. Along with him, Mr. Speaker, is Emil Barber, who is a Public Affairs Outreach Volunteer Specialist for the Veterans Administration, U.S. Department of Veterans Administration. If you would please give both of these gentlemen the cordialities of our floor and welcome them to our Chambers, it would be greatly appreciated, I'm sure Mr. Santabarbara will be too, in his absence.

to be able to connect with each other, and we've talked so many times in this Chamber about the mental health needs of our returning servicemembers, and I think that Mary's work over the years as part of a team on the Capital Region Veterans Memorial is going to be a wonderful asset. It's going to be located in my district, but it's going to be serving the whole Capital District. She's a retired Colonel, New York Air National Guard Scotia with over 27 years. I can't read all of her different accolades, all I can tell you is that she's one of our hometown heros and I'm just so very grateful that she took the time to be with us today.
