One pint of blood can save three lives. Just think about that. With the donation of one pint of blood that will take 45 minutes of your time, you can save three lives. How amazing is that? So this month is Blood Donor Awareness Month. I'm going to be rolling up my sleeves to do my part and I hope you will, as well. Thank you, Madam Speaker.

Legislative Resolution memorializing Governor Kathy Hochul to proclaim January 2025 as Thyroid Disease Awareness Month in the State of New York.

ACTING SPEAKER HUNTER: Mr. DeStefano on the resolution.

MR. DESTEFANO: Thank you, Madam Speaker. I bring this resolution today as it's personal to me as my mom suffered from thyroid disease. She had cancer from it, she had her thyroid removed, and it eventually did take over. But more than 20 million Americans, including many here in New York, are affected by thyroid disease, with some not even knowing they have it. The disease can develop in anyone, but tends to occur three-times more often in women than men. They have a higher mortality rate from thyroid cancer, and that's unacceptable. In New York State, incident rates for late-stage thyroid cancer is 5.7 cases per 100,000. This is higher than the national rate of 4.1. Counties such as Richmond, Nassau, and my home of Suffolk County, their report rates were even higher. In addition to cancer, thyroid disorders, including Graves Disease, Hashimoto's, Goiter, nodules, and both hypo- and hyperthyroidism, terrible conditions that no one should have to endure.

Because 60 percent of people with thyroid disease

don't even know they have a problem, public awareness is critical in minimizing its devastating effects. This is why I'm sponsoring this resolution year after year to bring awareness to this terrible disease that so many people in our State go through. I'm designating this as Thyroid Awareness Month, and thank you to the Governor and my colleagues for sponsoring this in the State of New York. Let us encourage people to reduce their risk of thyroid issues through awareness, regular check-ups, preventive measures, and such an exercise as stopping smoking. If we can save one more New Yorker from these discerning effects of thyroid disease, it will be well worth it to all of our citizens. Thank you, Madam Speaker.

Legislative Resolution commemorating the Asian American community's celebration of Lunar New Year, the Year of the Snake, on January 29th, 2025.

ACTING SPEAKER HUNTER: Mr. Kim on the resolution.

MR. KIM: Madam Speaker, tomorrow is a historic day in New York State and for our country. For the first time in the history of this nation, we are celebrating Lunar New Year as a Statewide holiday, the first in the country to do so. And thanks to all of our efforts led by the Chair of the APA Task Force, our former colleagues in government, the bill's sponsor who fought for this for many years, and all of you who voted for this last year.

And for the first time, a generation of young people will grow up in this State and beyond knowing that Asian Americans belong in this country, they belong in our cities and they belong in this State.

My mother, when I was a young boy, she used to make me Korean food, very smelly Korean food to take me -- to bring to school. It had some kimchi in it, some beef in it, and I remember the kids taunting me, like *what is that smell*, you know, *what is that thing, what are you eating?* And I remember coming back and lashing out at my mom, *can you make me some more American food please*, you know, *I just don't want to be bullied anymore in our classroom*. And when I look back at that moment as a young boy, I

feel so ashamed, right, looking back, feeling ashamed of my mom's cooking as an Asian American. And I wish I had the opportunity before my mom passed from COVID to tell her all the things we did right, not for just me, but for my kids, so we can walk tall, walk proud as an Asian, Asian American in this country and this State, that you don't have to feel like you don't belong here.

Now, we still have a crisis when we're constantly pushing immigrants and Asian Americans to compete to try to fit in into a group. There's a difference between competing to fit in versus feeling like you belong. This piece of legislation that we did, the celebration we're doing now, recognizing Lunar New Year as a Statewide holiday will make sure that the next cohort of generations know that they can feel like they belong, they don't have to compete to try to belong to a group.

So with that, I want to thank my colleagues for taking this resolution on again this year in a very special, historic year, the Year of the Snake. Despite the sound of it, it's a very symbolic animal. It symbolizes transformation, it symbolizes initiation, it symbolizes change for the better. And just a few minutes ago, one of my colleagues on the other side of the aisle even asked me some questions about the animals in the Lunar New Year, and this is how it starts, this is how we learn more about each other's cultures and have insightful conversations. Every 12 years, there's a different animal. So this is the fourth animal of the cycle, this Year of the Snake. I'm a Sheep, myself, but I like to tell people I'm a Ram, not a sheep, but

anyways, thank you so much colleagues for doing this, and happy Lunar New Year, everybody.

Tomorrow, New York will close schools in observance of Lunar New Year, making New York the first state in the nation to recognize Lunar New Year as a Statewide school holiday. This milestone recognizes Asian Americans as an essential piece of the cultural fabric of New York.

As the first Korean-American woman elected to the State Legislature, it has been my honor to help to lead the fight for this law and to see its impact come to life. Over 15 years ago, then-Assemblymember Grace Meng first took on this effort in this Chamber. It is a collective power of the persistence of our community that has culminated into this history-making moment.

But this is more than a day off. It is an opportunity for all New Yorkers to reflect on the rich diversity and inclusion that make our State so great, and to recognize the vital role Asian Americans have played in shaping our communities. This Lunar New Year, we celebrate the Year of the Woodsnake, a symbol of tolerance, good luck, and rebirth. The snake represents essential traits for

guiding one's life with wisdom and grace.
