MR. JONES: Madam Speaker, I rise today to share a bit of information with you all about cystic fibrosis. This is very personal to me because I've had dear friends affected by cystic fibrosis. This disease is caused by a defective gene that forces the body to produce an abnormally thick, sticky mucous that clogs the lungs and can lead to life-threatening lung infections that obstruct the pancreas. Approximately 40,000 children and adults in the United States, and over 105,000 worldwide, are affected by cystic fibrosis. In New York, there are over 1,600 individuals who live with this disease.

We will be doing a resolution on this, honoring May as Cystic Fibrosis Awareness Month, but I'd like to highlight some of the incredible advocates that work to support families, as well as recognize 21 world-class specialized treatment centers throughout New York. On behalf of McDonald -- Assembly members McDonald, Bendett, Steck and Friend, it is my pleasure to introduce some of the families who live with cystic fibrosis and celebrate all they do to raise awareness and the wonderful advocates on what they do for the loved ones with cystic fibrosis. I want to thank the following great New Yorkers for being here today: Emilie McHale,

Kellen McHale, her little guy in the bunch (Zeke McHale), Janet Shuster, Francis Gransbury, Julie Chasney, Nina Harmon, Diane Nardacci, and Anita Gerace. And I believe we have Lisa Reid with them back there for a little bit.

Madam Speaker, will you welcome these fine individuals to the People's House and thank them for all the incredible work they do on behalf of cystic fibrosis.

This bill will create the crime of unlawfully operating an uncrewed aircraft over school grounds or critical infrastructure, and it will be a Class B misdemeanor for a first offense and a Class A misdemeanor for any subsequent offense. I'm going to be supporting this bill. I think what some concerns we're just -- we were -- as we were talking about the bill, there were some concerns raised to just make sure that if you have, say, a school club, or you have school photography that's being done and you want to use a drone for that, I just want to make sure that that was still going to be allowed, and it will be allowed as long as there is prior written consent from the schools.

There was also a concern that was being raised about

the bill not defining what remains above or hover means, and it doesn't include a time frame as to what qualifies as such an act. So, there was a little bit of concern about whether the application of this bill would be subjective and maybe result in unequal prosecution under the law, but I think we felt that unbalance. The bill was a good bill and from reading the news, we know that sometimes there are -- there is definitely an increase in drone traffic around. So, to protect our critical infrastructure and areas around our schools, I will be supporting the bill. I just think that, you know, there -- there may be a little bit of an improvement in language that would be helpful. So, I just want to make that and put that on the record.

So, thank you very much, Madam Speaker, I will be in the affirmative.

ACTING SPEAKER HUNTER: Thank you.

Ms. Walsh in the affirmative.

Mr. Morinello to explain his vote.

MR. MORINELLO: I just want to comment on this bill because it's over school grounds. With the proliferation of pedophiles, it would really concern me if there were drones over schoolyards with little children and young adults running around.

So, I commend this bill. I do vote in the positive and I think it's a great step, even though that may not have been one of the focuses. What we have to do when we look at the bills is tear them apart and add other positives. So, I think it's a very good bill and I think it does protect our children. Thank you.

This is a fast vote because it is a local law, but in the past, I wanted to alert members that it has received considerable opposition. Last year, we had 17 no votes on the floor of the Assembly, and the reason why is because it eliminates the requirement that bond issuances in the City of Yonkers go through a competitive bidding process, which is the same process that almost every other municipality goes through. Yonkers was authorized to do a private sale 18 years ago when they had a fiscal crisis. They are no longer in

a fiscal crisis. The bond rating for the City of Yonkers is currently A+ with a stable outlook. And so, the feeling is that maybe it's time that you go back and have an open competitive bid to make sure that anybody who wants to bid on those bonds has a fair and equal opportunity to bid to make sure that you're getting the best price, by getting the best competition to avoid favoritism and the possibility of corruption.

Because this bill is no longer needed, I will be voting against it and I would recommend that my colleagues do the same.

Thank you, Madam Speaker.

Today, I rise proudly to vote in favor of this legislation which requires every college and university in New York to appoint a Title VI coordinator. This bill is a direct response to the alarming rise in anti-Semitic incidents and other forms of discrimination on campuses across the State. I want to thank SUNY, CUNY and (indiscernible) for their support of this bill. As we know, having a dedicated Title VI coordinator would ensure that students have a clear point of contact to report discrimination and receive timely, effective support. Many schools like NYU, my alma mater, have already taken this important step by appointing a coordinator and it's time for every institution in New York to follow suit. Our institutions of Higher Education must live up to the values of safety and inclusion of everyone, regardless of who they are, regardless of where they come from or what religion they practice. This legislation ensures that no student is left without recourse and that colleges are equipped to respond to hate, bias and discrimination before it actually escalates. As we've seen, there continues to be troubling incidents at colleges across the State from various CUNY institutions to Columbia University. So the need for accountability and institutional action is quite urgent. We cannot afford to be passive in the face of rising anti-Semitism and discrimination.

So, I'll be voting in the affirmative and I urge my colleagues do the same. Thank you.

ACTING SPEAKER HUNTER: Thank you.

Ms. Rozic in the affirmative.

Mr. Ra to explain his vote.

MR. RA: Thank you, Madam Speaker.

I want to thank the sponsor for bringing this piece of legislation forward. As -- as many know, I've introduced legislation to do a number of things with regard to campuses and anti-Semitism and one of them is exactly what this bill covers, in making sure that there is a point person, there is a process for students when they need to make a complaint and there's a process for dealing with that complaint on our campuses. As -- as the sponsor said, there's been alarming rise in anti-Semitism on our campuses and -- and any other form of discrimination, and it is important that we make sure that all of our students feel safe on -- on their campuses and -- and know what to do if there's an incident and how to report it and how it should be dealt with.

So, I'm happy to be a cosponsor on this piece of legislation and I urge all my colleagues to support it. Thank you.

ACTING SPEAKER HUNTER: Thank you.

Mr. Ra in the affirmative.

Mr. Lavine to explain his vote.

MR. LAVINE: I want to commend the sponsor as well. No student, on any college campus, should be made to feel uncomfortable, should be harassed, should be assaulted, because of who they are inherently are. This bill helps us to protect those students and again, I sincerely want to thank the sponsor for her efforts to bring this to the floor and I want to thank all my colleagues

because this is passing unanimously. Thanks again.

ACTING SPEAKER HUNTER: Mr. Lavine in the affirmative.

MR. YEGER: Thank you, Madam Speaker.

I, too, am very grateful to the sponsor for proposing this legislation. But, as we sit here today and vote for it and, as the gentleman said, I'm glad it's unanimous. It is also a constant reminder not just what's going on on the campuses, but that there are schools in this State that need a law to make this happen. It shouldn't have been the case, the -- the schools, the campuses, the universities, both public and private in our State, have seen the rise in anti-Semitism in the last several years. Many of them have not only done nothing to combat it, but their leadership has encouraged it, not just by osmosis, but by actual real actions. So, this law is necessary, but it's also a reminder to us that colleges have not been doing the right thing in the State.

So, I'm grateful again to the Speaker. I vote in the affirmative. Thank you.

So, colleagues will recall that a couple of years ago, I think, now -- seems like a couple of years ago -- we -- we passed a bill

requiring AEDs, these auto -- automatic external defibrillators, to be maintained on-site at public schools. What this bill does is it extends that mandate and requirement to nonpublic schools. And while I don't generally like the idea of the State putting mandates on nonpublic schools, I'm -- I'm going to support this because, number one, I think that it is important for the safety of people that work within the school or that are visiting the school. And in our prior debate on the previous bill, we talked a lot about that.

And I think the other thing that sort of leaned me towards a yes vote on this particular piece of legislation is that, it's my understanding that in the budget this year there is an appropriation of \$70 million for grant money to assist with the cost of AEDs, and -- in the -- in the nonpublic schools.

So, for those reasons I'll be happy to support this bill this year based on those factors.

And just as we celebrate cultural landmarks like Little Italy, El Barrio, Chinatown, today we are taking a meaningful step towards honoring another vital part of our City. With the passage of this bill, we officially recognize Little Yemen as a

cultural district. Little -- Little Yemen is vibrant, it's resilient and full of life, whether breaking fast together during Ramadan or opening small businesses in our community or gathering for celebrations, the Yemen -- Yemeni community continues to shape the Bronx with its generosity and its strength.

And so I want to thank my colleagues in this

Chamber today for their support of this legislation. And I especially
want to thank many members of the Yemeni community back home in
the Bronx, and my staff, who have worked so hard with me in this
effort. Your voices and your vision have made this bill today possible.

And, Madam Speaker, this designation is not just symbolic, it brings real opportunities. With it comes access to funding, technical support, and the kind of recognition that strengthens cultural institutions for generations to come.

There's a Yemeni proverb that says, "He who has no past has no future." And so today, with this legislation, we honor a proud past, and we help secure a thriving future for Yemenis across our State, but more importantly, in the Bronx. And to all those who visit the Bronx, and to my colleagues, make sure, when you come to the Bronx, Little Yemen is on your list. And there you'll find heritage, you'll find hospitality, and a community that exemplifies the American Dream.

So, this bill extends for two years the provision that allow for the Department of Motor Vehicles to suspend driver's licenses of individuals who have failed to make child support payments, which, I think, is an important stick in the conversation to make sure that the people who owe child support actually do pay child support. I do think, though, however, that there's a missing piece to the puzzle that I think could be in the future incorporated.

I had developed legislation and had introduced it. I didn't introduce this year. Don't ask me why, I think I just got busy. But the idea that I had was -- and -- and I think others do, too, is that in order for people who owe child support to get current, they need to be able to get to work to be able to make the money to pay the child support. And if they don't have transportation, particularly in Upstate areas, that is a real problem. And that could just -- it -- it could become a situation where neither party is happy; the one who is owed, who's not going to be getting paid, or the person that owes the money. So I think that there -- there's a need for some kind of a process to allow for a conditional driver's license, and I think that that's something that we should probably try to work on going forward.

I'll support the extender because I do think it's important that we -- that we continue to hold individuals accountable. And this is certainly a way to get people's attention if you take away their driving privileges until they can come current or make these payments. But I do think that in -- in -- realistically, I think that we

need to create a possibility for a conditional driver's license. I think that that's -- that's maybe a better way to go in conjunction with this bill.

But I will be supporting it. I'll be in the affirmative. And thank you very much, Madam Speaker.

ACTING SPEAKER HUNTER: Ms. Bichotte Hermelyn on the resolution.

MS. BICHOTTE HERMELYN: Thank you, Madam Speaker, for allowing me to speak on this vital resolution that establishes today as MWBE Advocacy Day in New York State.

Advocacy Day represents the economic empowerment for minorities and women business enterprise who own and operate business, and increasing their success and ability to thrive under New York State's and other municipalities such as New York City's MWBE program.

Despite decades of legislation and programs in both New York City and New York State to level the playing field for MWBEs, disparities continue to persist and our MWBE community faces an uphill battle and roadblocks to equality and contracting with the government.

In 1988 the New York State Executive Law enacted Article 15-A to ensure and promote fair and equal employment, and minority women business enterprise participation in State contracts through the establishment of goals for the minority and women-owned business enterprises. And in 1989 the U.S. Supreme Court ruling in the landmark case *City of Richmond v. Croson*, and others that followed it, set legal boundaries for municipalities intending to create minority business enterprise programs. Then in 2005, New York City established an MWBE program via Local Law 129. On a State level in 2014, New York State launched an MWBE certification campaign to encourage minority and women business owners to certify with the State and take advantage of billions of dollars in State procurement opportunities. And the Governor pledged to increase MWBE certification by an additional 2,000 businesses; a goal that the State exceeded in January of 2016 as a result of the number of certified

State firms more than doubled just in five years.

Since then we have become a nation leader in MWBE utilization, setting back-to-back records for support in spending. But we still have a lot of work to do. We are still experiencing bias, exclusion, and barriers, still making it hard for minority communities to close the wealth gap. And guess what? Minorities and women make up the majority of our population.

We want expanded mentorship and training so our firms and small businesses can grow from subcontractors to prime contractors. We want ways to increase participation and improve the quality of programs through access of State funding, City funding, localities so it can do what it was meant to do, that our procurement process is equitable. Because we all know what the truth is despite what certain folks say or are trying to tell you, MWBEs are not looking for favors. They're asking for fairness. They don't want to be given contracts. They want a fair shot to win. They don't want handouts. They want the system to stop putting hurdles in their path.

This is what Advocacy Day is all about. MWBC -MWBE Advocacy Day has gathered the best businesses, leaders,
industry groups, stakeholders, and lawmakers. It's about showing up,
speaking out, and making it clear that economic justice is not optional,
it's essential. We are here to ensure that this State's wealth and
opportunity are shared equitably. Not just for today, but future
generations. This is our moment. Let's keep building. Let's keep
fighting. And let's make 2025 the year New York fully commits to

MWBE equity. Not in name, but in action.

MS. KASSAY: Thank you for letting me speak on this very important resolution.

Being a native Long Islander growing up on the North Shore, my relationship with the Long Island Sound started when I was child going to the beach. But I felt really -- when I started my

career in environmental science and leading a team volunteer group along the North Shore in Stony Brook in Suffolk County that I really got to know the Long Island Sound more deeply.

I would take students out to tag horseshoe crabs, conduct species studies of terrapin turtles, to do beach cleanups and invasive species removal, and it really deepened my understanding of this incredible ecological resource and how sensitive and how important it is to both native species as well as migratory species that pass through like the Red Knot and others throughout the year going to and from the Arctic and South America.

So little did I know as a child this incredible, incredible place in our backyard was so ecologically important in our global ecological society. Then as I became a small businessowner in the Village of Port Jefferson, we had a bed and breakfast, we had folks coming near and far to enjoy the beauty and the magnificence and the recreation on the Long Island Sound.

My husband and I also took up sailing. We had a J-24 sailboat and would go out there ourselves and along with fellow boaters, enjoy that aspect of the Long Island Sound.

And so I'm very proud today to represent a stretch of the land that is -- is along the Long Island Sound there. You know, it stretches from the Western Narrows of New York City and along the Sound Shore of Westchester County. And so this body of water truly connects a lot of us here in this room, and is of great importance, again, both ecologically and economically, as it's a huge economic

driver. Commercial and recreational activities in the Long Island Sound generate upwards of \$9 billion in the economy every year. And as an environmentalist, I've learned that sometimes you have to speak about the environment and its importance in terms of how it's an economic driver. And so, again, I will say \$9 billion of our local economy comes from this incredible body of water. So when we speak about water quality, when we speak about protecting our environment, it's not just for, you know, the incredible species that it call it home, but it's also for our economy. And so I look at every investment that New York State makes into environmental protections is just that, an investment in the grand scheme of our wonderful economy and one of the many reasons why New Yorkers love to call New York home.

So I'm so proud to present this resolution and celebrate, again, Long Island Sound Day and its importance this Friday and every day of the year.

And an estuary is the most productive ecosystem on the Planet Earth; serving, feeding, breeding, and providing nursery grounds for over 7 -- excuse me, over 1,200 species and invertebrates, not to mention 170 different kinds of fish and dozens of migratory birds.

So let's do our part not to only protect and preserve this incredible natural resource of Long Island, let's do it for future generation -- future generations, but to also vote yes on this amazing resolution.
