In 1999 the United States Supreme Court decided in *Olmstead v. E.W. and L.C.* that individuals with disabilities be integrated into society in an appropriate manner to address the needs of the individual. Pursuant to that decision New York developed an Olmstead Implementation Plan under which the New York State's service and support delivery system for individuals with developmental disabilities is undergoing a major transformation. This process has required the Office for People with Developmental Disabilities (OPWDD) to enter into a transformation agreement with the Centers for Medicare & Medicaid Services (CMS) to identify and implement a series of initiatives which are aimed to develop a person centered care model and provide enhanced opportunities for individuals with developmental disabilities in the areas of employment; integrated living, including moving individuals from institutional settings to community based living; and self-direction of services, utilizing a managed care payment structure.

The purpose of this hearing is to provide the committee with an update regarding the actions taken in the SFY 15-16 budget with regard to the implementation of the transformation agreement as well as to identify barriers that may require additional resources in the upcoming fiscal year to ensure New York State has sufficient capacity to provide supports and services for individuals with developmental disabilities.

In order to meet the needs of those who may have a disability, the Assembly, in accordance with its policy of non-discrimination on the basis of disability, as well as the 1990 Americans with Disabilities Act (ADA), has made its facilities and services available to all individuals with disabilities. For individuals with disabilities, accommodations will be provided, upon reasonable request, to afford such individuals access and admission to Assembly facilities and activities.
