All not-for-profit applicants must now pre-qualify on the NYS Grants Reform Website at grantsreform.ny.gov/grantees in order to apply for certain New York State grant solicitations. Potential not-for-profit applicants are strongly encouraged to begin the process of registering and pre-qualifying immediately as this is a lengthy process.

### **Office of Addiction Services and Supports, Opioid Treatment Program**

In response to the state's ongoing opioid crisis, the Office of Addiction Services and Supports (OASAS) is seeking applications for the development of Opioid Treatment Program (OTP) Additional Locations to increase the availability of OTP services. An OTP Additional Location is a facility established as part of an existing OASAS-certified OTP while remaining geographically separate. Additional locations' licensed private practitioners or community pharmacists dispense or administer an opioid agonist treatment medication or collect samples for drug testing or analysis. Other treatment services can be provided as allowable under OASAS Part 822 regulations. OTP Additional Locations are not required to be free-standing entities and can be colocated with other services. There are no minimum or maximum distance requirements from the home OTP.

- Eligibility: Voluntary agencies, county-operated local government units or other not-for-profit organizations that currently operate OASAS-certified opioid treatment centers are eligible to apply.
- **Funding:** \$200,000 per award, five awards anticipated.

### Governor's Traffic Safety Committee, Child Passenger Safety Grants

Through funding from the National Highway Traffic Safety Administration (NHTSA), the Child Passenger Safety grant program provides funding to help local communities conduct programs to promote child passenger safety awareness and education.

To that end, the Governor's Traffic Safety Committee (GTSC) has issued a Request for Application (RFA) to solicit proposals from local and tribal governments and not-for-profit agencies for Child Passenger Safety grants under the Federal Highway Safety Program.

- Eligibility: Not-for-profit organizations, local governmental entities and tribal governments are eligible to apply.
- Funding: Not specified

# On the federal level...

### Department of Justice Office on Violence Against Women, Improving Criminal Justice Responses to Domestic Violence, Dating Violence, Sexual Assault, and Stalking Grant Program

The Improving Criminal Justice Responses to Domestic Violence, Dating Violence, Sexual Assault, and Stalking Grant Program (ICJR Program) encourages state, local and tribal governments and courts to treat domestic violence, dating violence, sexual assault and stalking as serious violations of criminal law requiring the coordinated involvement of the entire criminal justice system.

- Eligibility: City or township governments, county governments, federally recognized Native American tribal governments, nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, and state governments are eligible to apply.
- Funding: Up to \$1 million per award with \$30 million in total program funding.
- Deadline: April 26, 2022

### U.S. Department of Justice, Office of Juvenile Justice Delinquency Program, National Mentoring Programs

In an effort to reduce juvenile delinquency, truancy, drug abuse, victimization and other dangerous and high-risk behaviors, the Department of Justice (DOJ), Office of Justice Programs (OJP), Office of Juvenile Justice and Delinquency Prevention (OJJDP) seeks applications for funding for the fiscal year 2022 National Mentoring Programs solicitation. The program supports the implementation and delivery of mentoring services to youth populations that are at risk or high risk for juvenile delinquency, victimization and juvenile justice system involvement. Mentoring services can be oneon-one, group, peer or a combination of any of these types. Applicants must initiate mentoring services to youth who are 17 years old or younger at the time of admission to the program. Mentors must be an adult (age 18 or older), or in cases where peer mentoring models are being implemented, an older peer and under adult supervision. New mentoring matches are encouraged, but funds can also support existing mentoring matches through program completion. Applicants are encouraged to target mentoring services to underserved populations. Further, OJJDP requires applicants to develop and implement a plan to serve American Indian and Alaska Native (AI/AN) youth, both on and off reservations, with these grant funds. OJJDP strongly encourages applicants to target mentoring services that incorporate opportunities for youth and law enforcement engagement.

**Eligibility:** The following entities are eligible to apply: national organizations, defined as organizations that have active affiliates or subawardees in at least 45 states. For the purposes of this solicitation, two or more independent organizations that form a collaborative to meet the 45-state requirement do not satisfy OJJDP's definition of a national organization. The organization's national headquarters must submit the application. OJJDP encourages applicants to minimize their administrative costs in an effort to subaward at least 90% of this award to active affiliates or subrecipients, located in at least 38 states, while at the same time allowing for effective subrecipient oversight. If the requested award amount is reduced upon award, OJJDP will work with the grantee to determine the appropriate number of states required to subaward funds that match the total award amount. To advance Executive Order 13929 Safe Policing for Safe Communities, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process to be eligible for FY 2022 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's use-of-force policies adhere to all applicable federal, state and local laws and (2) the agency's use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

- **Funding:** Up to \$30 million per award, total program funding approximately \$45 million.

# On the private level...

### **THRIVE! Uplifting Theatres of Color**

THRIVE! Uplifting Theatres of Color is inviting applications with support from the Doris Duke Charitable Foundation, as developed and administered by Theatre Communications Group with an advisory circle of Black, Indigenous and People of Color (BIPOC) theater leaders.

THRIVE! provides funding to support organizations that have all too often been excluded from funding opportunities, including Black theaters, Indigenous theaters and Theaters of Color (BITOC) based in the United States (including Tribal Nations and U.S. Territories) which are closely connected to and positively impact their chosen communities. Through this funding, THRIVE! aims to help theaters invest in their staff and artists and support their organizational success beyond the scope of artistic projects and programming, easing some of the stress of fundraising.

To that end, grants will be awarded in two categories: RESPOND and RECOGNIZE grants. For RESPOND grant funding, 25 rapid response grants of \$10,000 will be awarded to address immediate, time-sensitive challenges that prevent ongoing work with their community. Recipients of RESPOND grants will still be eligible to apply for RECOGNIZE grants. Applications are due April 19, 2022, at 11 p.m. ET. For RECOGNIZE grants, 20 general operating grants of \$50,000 will be awarded to BITOC demonstrating a deep level of service to their chosen communities, a clear vision guiding their work and the highest potential for the THRIVE! program to positively impact their organization. In addition, during the grant program period, RECOGNIZE grantees will participate in REBUILD: A Learning Cohort, working with BIPOC consultants to strengthen their effectiveness in specific areas that may include financial planning, crisis management, scenario planning and program evaluation. Additional opportunities will consist of awareness-building topics and intersectional programming. Applications for RECOGNIZE grants are due May 6, 2022, at 11 p.m. ET.

Eligibility: To be eligible, applicants need selfidentification as a BITOC organization (founded by, for, about, with and near) based in the United States (including Tribal Nations and U.S. Territories) with organizational documents and platforms confirming this self-identification, evidence of theater as a central factor in activities and programming, and evidence of serving and engaging BIPOC community/communities.

RESPOND applicants must have either a 501(c)(3) for their organization or fiscal sponsorship by an entity

with tax-exempt status or certificate of incorporation; if the applicant organization has not incorporated yet, then a lead contact person must be able to receive taxable income in the U.S. Applicants must also have a minimum of six months prior existence as a theater organization with documented activities, an intention to continue operations and a lead contact person. Organizations and companies formed for a single project and moment in time are not eligible.

RECOGNIZE applicants must have 501(c)(3) for their organization or fiscal sponsorship by an entity with tax-exempt status, a minimum of two years prior existence as a theater organization with documented activities and an intention to continue operations, and evidence of operations (other than in-kind revenue) as a theater organization.

# **Scholars Awards...**

### American Psychological Association, Global Mental Health Fellowship

The American Psychological Association and the International Union of Psychological Science are accepting applications for the Global Mental Health Fellowship with the World Health Organization.

The APA-IUPsyS Global Mental Health Fellowship provides an opportunity for a psychologist to contribute 20-30% of their professional time to the work of the World Health Organization (WHO) in the Department of Mental Health and Substance Abuse (MSD) for one year. The fellow will focus on one or more issues related to the WHO Mental Health Action Plan and carries a stipend of \$22,000 over 12 months, with additional funds of up to \$8,000 provided for travel related to the work plan. It is anticipated that work done will be conducted primarily at the fellow's home institution, followed by a brief orientation period at WHO in Geneva. There will likely be one or two additional brief periods in Geneva or elsewhere in the world, if needed. Upon selection and after approval from WHO, the fellow will be engaged under a contract that specifies the work plan, timeline, stipend and expense allowances.

Fellows will support research and program activities that address one or more WHO MSD program priorities that include the mental health Gap Action Programme tools and their implementation, scalable psychological interventions, psychosocial responses to conflict and other emergencies, e-mental health, public health response to dementia, early childhood development, maternal mental health and suicide prevention.

**Eligibility:** Applicants must hold a doctoral degree



from a recognized program in a clinical area of psychology, be a psychologist of any career level with demonstrated research experience and leadership in at least one of the Department of Mental Health and Substance Abuse priority areas, and be an APA member or have applied for APA membership at the time of application. Applicants may be based in any country.

- **Funding:** \$22,000 stipend and \$8,000 for related travel.

### Bogliasco Foundation, Arts and Humanities Fellowships

An American nonprofit with a program in Italy, the Bogliasco Foundation awards residential fellowships at its study center in Liguria to gifted individuals of all ages and nationalities who have made significant contributions in the arts and humanities.

Each year, the Foundation awards approximately 60 one-month fellowships to individuals doing creative or scholarly work in the following disciplines: archaeology,

architecture, classics, dance, film/video, history, landscape architecture, literature, music, philosophy, theater or visual arts.

During their stay, Fellows are provided with living quarters, full board, and a workspace or separate studio, depending on the discipline. All meals are shared, and every evening, Fellows come together for a formal dinner featuring typical cuisine from the Liguria region, such as focaccia, pesto, local produce, cheese and wines. While residencies are expected to lead to published or performed works, fellows have no specific work requirements or obligatory formal presentations. The center cannot accommodate children or family members other than spouses/partners.

- Eligibility: To be eligible for a Fellowship award, applicants should demonstrate significant achievement in their disciplines, commensurate with their age and experience. Students currently in a degree-granting program are not eligible to apply. Fellows must be able to speak conversational English to communicate in this international community, where the common language is typically English.
- **Funding:** Fellows are provided with living quarters, full board, and a workspace or separate studio.
