Dear Speaker Heastie,

I am pleased to submit the 2023 Annual Report for the Assembly Standing Committee on Governmental Employees.

The Committee on Governmental Employees advanced significant legislation throughout the 2023 Legislative session to benefit both public employees and their employers.

The Committee passed numerous pieces of legislation aimed at improving public employers' ability to recruit and retain employees. Chapter 358 of the Laws of 2023 requires the Department of Civil Service and municipal civil service commissions to post examination announcements at certain sites where they will be more likely to be seen by potential examinees. Additionally, in the State Fiscal Year 2023-24 Enacted Budget, the Committee advocated for the inclusion of a temporary waiver for all civil service examination fees. This fee waiver, effective from July 1, 2023, to December 31, 2025, removes a potential barrier to the civil service system in order to expand access to civil service examinations and help public employers recruit employees.

The Committee also passed legislation improving the civil service rights of public employees. For example, the Committee advanced A.3748-A (Pheffer Amato), which would require disciplinary hearings brought against a public employee to be held by an independent hearing officer provided by the Public Employment Relations Board, unless an employee is subject to an alternate disciplinary procedure pursuant to a collective bargaining agreement. This bill would ensure fair, unbiased hearing procedures for all public employees. Additionally, the Committee advanced Chapter 676 of the Laws of 2023, which extends the procedures for suspension and demotion upon the reduction of force that currently apply to competitive class employees to non-competitive and labor class employees. This would ensure that in the case of layoffs, all state employees are subject to equitable procedures.

Finally, this year the Committee passed legislation strengthening the retirement benefits of public employees. For example, the Committee advanced A.5630 (Jones), which would allow the beneficiaries of certain deceased employees of the Department of Corrections and Community Supervision and the Office of

Mental Health to receive the value of the pension reserve if an employee dies while in service and eligible for retirement. The State Fiscal Year 2023-24 Enacted Budget also included several pieces of pension legislation improving the benefits of first responders employed by municipalities.

These examples of legislation advanced by the Committee this year demonstrate its commitment to New York State's dedicated public workforce. This annual report provides greater detail on the actions and accomplishments of the Committee throughout the 2023 Legislative session year.

I would like to thank the Committee members and staff for all their hard work and dedication to our state's public employees. Additionally, I would like to thank the public employee organizations, unions, and the many government officials who have helped make this year a successful one. I look forward to continuing to serve as the Committee chair.

I also thank you for your guidance and support, which was vital to the accomplishments of the Committee during the 2023 Legislative session.

#### **COMMITTEE SUMMARY**

The New York State Assembly Standing Committee on Governmental Employees oversees legislation and policy proposals concerning the civil service law and public retirement systems.

Throughout the 2023 Legislative Session, the Committee remained dedicated to protecting the rights and benefits of all employees and officers of the State of New York. In furtherance of such mission, the Committee has worked earnestly to pass legislation that relates to disciplinary procedures, civil service examinations and appointments, disability and retirement benefits for uniformed employees, and the ratification of collective bargaining agreements. The Committee has also reviewed legislation altering pension and disability benefits, and eligibility for such benefits, for members of the public pension and retirement systems. At the same time, the Committee has reviewed policies to ensure that legislation does not undermine the pension funds on which public retirees depend. Through such work, the Committee seeks to enhance the governing structure of the pension systems as well as maintain their sustainability.

Additionally, the Committee on Governmental Employees is responsible for the mandate of legislative initiatives protecting the individuals our communities rely on the most: our public safety personnel. Our police, fire, emergency medical technicians, sanitation, and correction workers risk their lives to protect our citizens and maintain the services New Yorkers rely on every day. In recognition of their dedicated service, the Committee has advanced legislation that aims to enhance the effectiveness and efficiency of the law enforcement, public safety, and security organizations located within New York State.

During the 2023 Legislative Session, a total of 320 legislative proposals were referred to the Committee on Governmental Employees. The Committee reported 59 bills. Of those proposals, 46 passed both Houses. Of those, 31 were chaptered and 13 were vetoed.

#### I. <u>RECRUITMENT, RETENTION, AND CIVIL SERVICE PROTECTIONS FOR PUBLIC EMPLOYEES</u>

New York State is home to some of the most dedicated servicemen and women in the country. In return for the tireless support that they provide to our communities, the Committee must ensure that these employees' rights and benefits are protected. Additionally, the Committee is dedicated to ensuring that New York State is able to recruit and retain enough qualified employees to provide important services to New Yorkers. As such, during the 2023 Legislative Session, the Committee considered the following bills to safeguard the rights and benefits of current employees and improve the State's ability to recruit and retain a qualified workforce.

#### 1. A.7155 (Pheffer Amato) / S.5494 (Jackson) – Chapter 356 of the Laws of 2023

This law provides that prior provisional service in a title to which an employee is permanently appointed shall be credited toward the probationary term. This law will be subject to a chapter amendment in the 2024 Legislative Session clarifying that provisional service may only be credited to the probationary period if an employee is permanently appointed to a title immediately following the end of provisional service in such title.

#### 2. A.6855 (Pheffer Amato) / S.5486 (Jackson) – Chapter 358 of the Laws of 2023

This law requires the Department of Civil Service and municipal civil service commissions to post civil service examination announcements at boards of cooperative educational services, high schools, colleges, universities, social services districts, and job training programs. This law will be subject to a chapter amendment in the 2024 Legislative Session specifying that the Department of Civil Service and municipal commissions shall provide notice to the entities named in the law and providing that such notice shall be given to public entities.

#### 3. A.6480 (Burdick) / S.6482-A (Mannion) – Chapter 521 of the Laws of 2023

This law clarifies that positions designated to be filled by individuals with disabilities and veterans with disabilities pursuant to the State's 55-b and 55-c programs may be filled on a part-time basis and requires that postings for such positions include whether they are part-time or full-time

#### 4. A.6856 (Pheffer Amato) / S.5487 (Jackson) – Chapter 676 of the Laws of 2023

This law extends procedures for suspension and demotion upon the abolition or reduction of force applicable to competitive class positions to non-competitive and labor class positions.

## 5. A.3748-A (Pheffer Amato) / S.1039-A (Jackson) – Passed both Houses

This bill would require disciplinary hearings brought against a public employee, other than a New York City employee, to be held by an independent hearing officer, unless an employee is subject to an alternate disciplinary hearing procedure pursuant to a collective bargaining agreement.

#### II. <u>BENEFITS FOR UNIFORMED PERSONNEL</u>

During the 2023 Legislative Session, the Committee advanced legislation seeking to provide and extend eligibility for disability benefits to certain uniformed personnel and provide financial stability to injured members and their families. The following are such noteworthy pieces of legislation.

#### 1. A.4008 (Pheffer Amato) / S.3492 (Jackson) - Chapter 685 of the Laws of 2023

This law provides that uniformed court officers and peace officers employed by the Unified Court System who are injured as the result of a physical assault by an assailant suffered while in service shall be eligible for accidental disability retirement benefits.

#### 2. A.6731 (Stern) / S.6598 (Jackson) – Chapter 694 of the Laws of 2023

This law establishes an accidental disability retirement benefit equal to three-quarters of final average salary for deputy sheriffs employed by Suffolk County.

#### 3. A.6499 (Pheffer Amato) / S.6216 (Jackson) – Chapter 720 of the Laws of 2023

This law provides for the payment of the special accidental death benefit to the beneficiaries of deceased paid deputy sheriff members of the New York City Employees' Retirement System who died in service as the result of an accident sustained in the performance of duty.

## 4. A.4018 (Pheffer Amato) / S.1991 (Jackson) – Vetoed Memo. 84

This bill would establish a twenty-year retirement plan for non-seasonally appointed sworn members and officers of the division of law enforcement in the Department of Environmental Conservation (DEC), forest rangers and police officers in the service of the DEC, the regional state park police, and university police.

## 5. <u>A.5630 (Jones) / S.5849 (Jackson) – Vetoed Memo. 87</u>

This bill would allow the beneficiaries of deceased uniformed personnel employed by the Department of Corrections and Community Supervision and deceased security hospital treatment assistants employed by the Office of Mental Health who were eligible for service retirement at the time of death to elect to receive either the death benefit and the reserve-for-increased-take-home-pay, if any, or the value of the pension reserve that would have been established had the member retired on the date of their death.

#### 6. A.5710 (Pheffer Amato) / S.7519 (Jackson) – Vetoed Memo. 89

This bill would provide members of the New York State and Local Police and Fire Retirement System employed as university police officers with the presumption that any disability or death resulting from illness of the heart shall have been the result of an accident incurred in the performance of duty.

### 7. A.5716 (Pheffer Amato) / S.5239 (Skoufis) – Vetoed Memo. 90

This bill would establish a twenty-five year retirement plan for members of the New York State and Local Employees' Retirement System employed by the Division of Military and Naval Affairs in the titles of airport firefighter apprentice, airport firefighter I, airport firefighter II, airport firefighter III, and training and safety officer.

#### 8. A.7220 (Pheffer Amato) / S.6536 (Mayer) – Vetoed Memo. 106

This bill would deem credit in the New York City Employees' Retirement System earned while employed as a police officer in the New York City Department of Environmental Protection as creditable in a New York State and Local Police and Fire Retirement System service-based retirement plan.

#### III. <u>PENSION AND CIVIL SERVICE LEGISLATION FOR INDIVIDUALS</u>

The following legislation advanced in 2023 pertains to certain New York State Civil Service employees and members of New York State Retirement Systems concerning eligibility for retirement plans and tiers, competitive civil service examinations, and fields of employment.

#### 1. A.5862 (Buttenschon) / S.3513 (Griffo) – Chapter 192 of the Laws of 2023

This law authorizes Douglas Brenning, a part-time police officer in the village of New York Mills, to take the competitive civil service examination for full-time appointment as a police officer in such village and, contingent upon his examination score, be placed on the eligible list for appointment.

#### 2. <u>A.4916 (Byrnes) / S.4087 (Helming) – Chapter 199 of the Laws of 2023</u>

This law authorizes Michael Telesca, a full-time peace officer in the county of Livingston, to take the competitive civil service examination for appointment as a full-time deputy sheriff in Livingston County and, contingent upon his examination score, be placed on the eligible list for appointment.

#### 3. <u>A.6722-A (Barrett) / S.5057-A (Hinchey) – Chapter 200 of the Laws of 2023</u>

This law authorizes Benjamin Doty, a part-time police officer in the village of Millerton, to take the competitive civil service examination for appointment as a full-time deputy sheriff in Columbia County and, contingent upon his examination score, be placed on the eligible list for appointment.

#### 4. A.6723-A (Barrett) / S.6622-A (Hinchey) – Chapter 202 of the Laws of 2023

This law authorizes Brian Laurange, Jr., a part-time corrections officer in the county of Columbia, to take the competitive civil service examination for appointment as a full-time police officer with the Columbia County sheriff's office and, contingent upon his examination score, be placed on the eligible list for appointment.

#### 5. <u>A.5866-B (Bendett) / S.6807-A (Hinchey) – Chapter 204 of the Laws of 2023</u>

This law authorizes the county of Columbia to appoint Paul Strobel as a provisional parttime deputy sheriff, and allows Mr. Strobel to take the competitive civil service examination for appointment as a full-time police officer with the Columbia County sheriff's office and, contingent upon his examination score, be placed on the eligible list for permanent appointment.

#### 6. A.7620 (Smullen) / S.7418 (Walczyk) – Chapter 207 of the Laws of 2023

This law authorizes Brett W. Brewer, a part-time police officer in the in village of Ilion, to take the competitive civil service examination for appointment as a full-time police officer with the Ilion police department and, contingent upon his examination score, be placed on the eligible list for appointment.

## 7. A.7582 (Smullen) / S.7419 (Walczyk) – Chapter 208 of the Laws of 2023

This law authorizes Isaac B. Bertos, a part-time police officer in the village of Ilion, to take the competitive civil service examination for appointment as a full-time police officer with the Ilion police department and, contingent upon his examination score, be placed on the eligible list for appointment.

#### 8. <u>A.3052 (Wallace) / S.2519 (Gallivan) – Chapter 363 of the Laws of 2023</u>

This law deems an application for conversion of benefits from service or disability retirement to accidental death benefits filed by Audra Lakeman, the beneficiary of deceased New York State Police and Fire Retirement System member Lawrence Lakeman, as timely filed.

#### 9. <u>A.5075 (McDonald) / S.5539 (Ashby) – Chapter 642 of the Laws of 2023</u>

This law allows the city of Rensselaer to offer participation in the twenty-year retirement plan for police officers and firefighters to William Schumaker and Mark Hennessey, firefighters employed by such city.

#### 10. <u>A.5762 (Lupardo) / S.5605 (Webb) – Chapter 644 of the Laws of 2023</u>

This law allows the city of Binghamton to offer participation in the twenty-year retirement plan for police officers and firefighters to Scott Pavlick, a firefighter employed by such city.

## 11. A.6492 (Shimsky) / S.4715-A (Stewart-Cousins) – Chapter 659 of the Laws of 2023

This law deems previous service as a police officer in the Village of Dobbs Ferry by Gabriel Bonilla, a police officer currently employed by Westchester County, as creditable in the twenty-year retirement plan for police officers and firefighters.

#### 12. A.6609 (McDonough) / S.6188 (Rhoads) - Chapter 663 of the Laws of 2023

This law grants Daniel Miller, a tier 6 member of the New York State and Local Employees' Retirement System, retroactive tier 5 status in such system with a starting date of March 7, 2012.

#### 13. <u>A.6706 (Manktelow) / S.6788 (Helming) – Chapter 665 of the Laws of 2023</u>

This law grants Justin Whitmore, a tier 6 member of the New York State and Local Police and Fire Retirement System, retroactive tier 2 status in such system with a starting date of July 7, 2007.

#### 14. A.7616 (Santabarbara) / S.7468 (Breslin) – Chapter 670 of the Laws of 2023

This law grants Marc Del Prado, a tier 6 member of the New York State and Local Employees' Retirement System, retroactive tier 4 status in such system with a starting date of August 2, 2004.

#### STATE FISCAL YEAR 2023-24 ENACTED BUDGET

Each year during budget negotiations, the Committee seeks to include legislation and funding to enhance the rights and benefits of public employees and improve the State and municipal governments' ability to recruit and retain a qualified and capable workforce. The State Fiscal Year (SFY) 2023-24 Enacted Budget included numerous pieces of legislation reducing barriers to state employment for potential civil service employees, expanding pension benefits for retirement system members, and improving upon programs for employers to hire staff and contribute to employee benefits.

#### 1. <u>Continuous Recruitment – Public Protection and General Government, Part S</u>

In order to allow public employers to hire employees to vacant positions in a timely manner, this Budget part allows the Department of Civil Service and municipal civil service commissions to establish continuing eligible lists for any positions in the competitive class which the Department or commission deems appropriate for continuous recruitment.

#### 2. <u>55-b Expansion – Public Protection and General Government, Part T</u>

A study by the Department of Civil Service published in December 2022, found that the State's 55-b program, which allows individuals with disabilities to be appointed to competitive class positions without examination, was near capacity. This part increases the number of positions eligible to be filled through the 55-b program from 1,200 positions to 1,700 positions.

#### 3. <u>Civil Service Examination Fee Waiver – Public Protection and General Government,</u> <u>Part EE</u>

The fees required to take a competitive civil service examination may act as a barrier to employment for many New Yorkers seeking employment with the State. To remove this barrier and allow more people to take civil service examinations, this part waives application fees for all examinations held by the Department of Civil Service from July 1, 2023, to December 31, 2025, and allows municipal civil service commissions to do the same. The Legislature provided \$2.5 million in funding for this waiver program.

#### 4. <u>Retiree Income Cap Waiver – Public Protection and General Government, Part V</u>

To address staffing shortages in New York's schools, this part extends provisions of law waiving the income cap for retirees employed by a public school or board of cooperative educational services for one year, from June 30, 2023, to June 30, 2024.

#### 5. <u>Contribution Stabilization Program – Public Protection and General Government,</u> <u>Part W</u>

The New York State and Local Retirement System's Contribution Stabilization Program allows employers to amortize a portion of their contributions in order to offset significant changes to annual contribution rates over time. This part modernizes the program by allowing employers to access their reserve fund when the employer contribution rate exceeds the employer graded rate, making the reserve fund easier to access for many employers. This part also establishes provisions for employers to terminate their participation in the program.

## 6. <u>Special Accidental Death Benefits – Public Protection and General Government, Part</u> <u>Y</u>

This part includes counties as payors of special accidental death benefits to families of deceased members of county sheriff departments. To ensure that families of members who died prior to the enactment of the SFY 2023-24 Enacted Budget receive benefits, this part also provides for the payment of the special accidental death benefit to families of members who died prior to April 1, 2023, including any annual increases that the benefit would have been subject to had payment commenced on the date of the member's death.

#### 7. <u>Pension Legislation – Public Protection and General Government, Parts GG, II, HH,</u> <u>JJ, KK, and LL</u>

The SFY 2023-24 Enacted Budget included numerous pieces of legislation providing pension benefits for certain public employees. These include:

- a) Providing that the death benefit payable to beneficiaries of correction officers employed by Westchester County who are eligible for service retirement at the time of death shall be the greater of the pension reserve that would have been established had the member retired on the date of his or her death, or the death benefit and the reserve-for-increased-take-home-pay, if any (part GG);
- b) Providing that the death benefit payable to beneficiaries of fire marshals employed by Nassau County who are eligible for service retirement at the time of death shall be the greater of the pension reserve that would have been established had the member retired on the date of his or her death, or the death benefit and the reservefor-increased-take-home-pay, if any (part II);
- c) Allowing members of the New York City Fire Department Pension Fund to obtain service credit in their retirement plan for service rendered as an EMT member of the New York City Employees' Retirement System (part HH);
- d) Permitting tier 3 original, revised, and enhanced plan members of the New York City Police Pension Fund to borrow from their accumulated member contributions (part JJ);
- e) Authorizing Monroe County to permit deputy sheriffs-civil to retire pursuant to the optional twenty-five year retirement plan for sheriffs, undersheriffs, deputy sheriffs, and correction officers (part KK); and

f) Providing that police officer members of the New York State and Local Police and Fire Retirement System who are subject to a presumption that any disease of the heart resulting in disability or death was incurred in the line of duty shall not be required to establish that such disability or death was the result of an accident when filing for accidental disability retirement benefits (part LL).

#### 8. <u>Public Employment Relations Board – Transportation and Economic Development</u> <u>Part G</u>

The SFY 2023-24 Enacted Budget extended provisions of law granting the Public Employment Relations Board authority to engage the Metropolitan Transportation Authority and its recognized employee organization in binding interest arbitration for two years, from July 1, 2023 to July 1, 2025.
