I. COMMITTEE JURISDICTION

The New York State Assembly Standing Committee on Aging has jurisdiction over legislation affecting the quality of life and independence of New York's older adults. The Committee has legislative and budgetary oversight of the implementation and administration of New York State Office for the Aging's programs, including the Community Services for the Elderly (CSE) program, the Expanded In-Home Services for the Elderly Program (EISEP), Caregiver Resource Centers, the Long-Term Care Ombudsman Program (LTCOP), Wellness in Nutrition (WIN) Program, Managed Care Consumer Assistance Program (MCCAP), the Retired and Senior Volunteer Program (RSVP), Senior Respite programs, Social Adult Day programs, Naturally Occurring Retirement Communities (NORCs), Neighborhood Naturally Occurring Retirement Communities (NNORCs), the Foster Grandparent program, the Elder Abuse Education and Outreach program, and locally based Meals-on-Wheels programs.

The Committee also oversees the Elderly Pharmaceutical Insurance Coverage (EPIC) program, which is administered by the New York State Department of Health and reviews certain legislation providing property tax relief for older adults, including the Senior Citizen Rent Increase Exemption (SCRIE) program, the Disability Rent Increase Exemption (DRIE) program, the Senior Citizen Homeowners Exemption (SCHE) program, and the Disabled Homeowners Exemption (DHE) program.

During the 2024 legislative session, 35 bills were referred to the Assembly Committee on Aging. The following report details the major budgetary and legislative activities and accomplishments of the Assembly Committee on Aging during the 2024 Legislative Session.

II. STATE BUDGET HIGHLIGHTS

A. BUDGET SUMMARY CHART

B. ARTICLE VII

The Assembly rejected the Executive's proposal to establish an elder justice coordinating council within the State Office for the Aging to protect older adults from abuse and mistreatment and enhance collaboration between State agencies involved in elder justice.

III. COMMMITTEE ACCOMPLISHMENTS

A. ELDERLY PHARMACEUTICAL INSURANCE COVERAGE (EPIC) PROGRAM

A.9369-A, McDonald; Passed Both Houses: This bill would require the Department of Health to update the EPIC program application to allow eligible participants to be automatically enrolled in the Home Energy Assistance Program (HEAP).

B. LONG-TERM CARE

A.8520, Kim; Chapter 49 of the Laws of 2024: This law is an amendment to Chapter 770 of the Laws of 2023 to require the Department of Health to provide the State Long Term Care Ombudsman with a status report on the resolution of a reported issue instead of the staff or volunteer who reported such issue.

C. NATURALLY OCCURING RETIREMENT COMMUNITIES (NORC)

A.8519, Kim; Chapter 32 of the Laws of 2024: This law is an amendment to Chapter 661 of Laws of 2023 to clarify that certain data included in the study on the number of older adults residing in NORCs who are suffering from social isolation and loneliness be based on residents participating in programs or services provided by the NORCs.

D. OTHER

A.10142, Kim; Vetoed (Veto Memo 88): This bill would enhance the State Office for the Aging's oversight capacity of social adult day care programs.

E. PROPERTY TAX AND RENT EXEMPTIONS

A.10141, Lucas; Chapter 144 of the Laws of 2024: This law extends provisions of law related to the Senior Citizen Rent Increase Exemption (SCRIE) and Disability Rent Increase Exemption (DRIE) programs through June 2026.

A.10411, Bichotte Hermelyn; Chapter 592 of the Laws of 2024: This bill would allow NYC to utilize either the most recent income tax year or multiple different years to determine an applicant's eligibility for SCRIE, DRIE, SCHE and DHE depending on what data is available.

IV. HEARINGS

A. Expanded In-Home Services for the Elderly Program (EISEP)

October 17, 2024 10:00 AM New York, NY

The Assembly Standing Committee on Aging conducted a hearing on the Expanded In-Home Services for the Elderly program (EISEP). The purpose of this hearing was to review and examine the effectiveness of EISEP and the current needs of the program. The Committee sought testimony to evaluate the funding provided for EISEP, including the \$10 million in funding allocated in the State Fiscal Year 2024-2025 enacted budget designed to eliminate unmet need.

The Committee received testimony from the New York State Office for the Aging, New York City Department for the Aging, AARP New York, Association on Aging New York, LiveOn NY, SAGE USA, and Essential Care Visitor.

V. OUTLOOK FOR 2025

The Committee on Aging will continue to work to secure adequate funding for services and programs that serve older adults and their caregivers, so that they can age safely, independently, and comfortably in their homes and their communities. With more people living longer, it is essential that we meet the increasing demand of such programs and ensure that older New Yorkers receive the services they need.
