(Whereupon, Acting Speaker Aubry led visitors and members in the Pledge of Allegiance.)

A quorum being present, the Clerk will read the Journal of Wednesday, January 22nd.

Mrs. Peoples-Stokes.

MRS. PEOPLES-STOKES: Mr. Speaker, I move to

dispense with the further reading of the Journal of Wednesday, January the 22nd and ask that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

Mrs. Peoples-Stokes.

MRS. PEOPLES-STOKES: Thank you, Mr. Speaker. I'd like to provide a -- a quote for today. This one is from Roy T. Bennett. Roy is a [sic] author of *The Light in the Heart: Inspirational Thoughts for Living Your Best Life* book. It's a really good book, too, Mr. Speaker. This quote says this morning: "Success is not how high you have climbed, but how you make a positive difference in the world." We want to thank Mr. Bennett for those words today, but as we move forward, Mr. Speaker, the members do have on their desk a main Calendar. ACTING SPEAKER AUBRY: Thank you, Mrs. Peoples-Stokes. And we have no housekeeping today, a surprise, but we do have a [sic] introduction by Mr. McDonald.

Sir, for an introduction.

MR. MCDONALD: Thank you, Mr. Speaker. It's appropriate our Majority Leader talked about people who make a difference. I'd like to introduce a guest here who -- two guests who are here today. Francis HungMang and Retired Major David Erickson. And I want to speak specifically about Francis who's a constituent of mine here in the City of Albany who actually is here because of the generosity of my colleague, Mr. Ashby, who I share Rensselaer County with. But anyways, what's remarkable about Francis is that his real desire is to join the Army, to join the military. Unfortunately, he has a -- needs -- is in need of a medical exemption. My colleague, Jake Ashby, shared with me that he had a similar situation and he is mentoring him through the process, which I think is great. And the other part that's important is that Francis didn't start here in America, he started in Burma. Took six years to travel here to America. He made a huge difference, according to Major Erickson, with the soccer

team here in Albany, with the JROTC program, as well. He's one of our up and coming bright shining stars who truly are going to make a difference. And if you could extend him the cordialities of the House, we'd truly appreciate it.

ACTING SPEAKER AUBRY: Certainly. know. She was around to -- to see me and my siblings graduate from high school and college because of that donor.

So I just want to thank my -- my colleague, neighbor and friend, the sponsor, for putting this forward and I hope that we can, you know, we've done great work in this Chamber on organ donation. I think bone marrow donation and spreading awareness of this issue is a very important one, as well, because there are far too many that have -- have trouble finding matches. So I'm very happy to cast my vote in the affirmative in memory of my mother. Thank you.

MS. WALSH: Thank you very much, Mr. Speaker, for allowing me to interrupt the proceedings for an introduction of two fantastic athletic teams from my district, from the Burnt Hills-Ballston Lake Central School District. Today we're joined by the Burnt Hills-Ballston Lake High School Boys Cross-Country Team. We're also privileged today to be joined by the Burnt Hills-Ballston Lake Girls Volleyball Team and head coach Gary Bynon, upon the occasion of capturing the New York State Class A Championship on November 24th, it looks like, 2019. The team has now won their seventh State Volleyball Championship and demonstrated their superlative teamwork tying the State record by winning their 18th consecutive Regional Championship this season.

This is my home school district. Two of my kids went through this school district and one of them played volleyball, though not with Coach Bynon, but with the boys team. I'm so

impressed with these young men and women. They are also scholar athletes. They have, you know, combined scores that are well into the 90s for both teams. So I hope that, please, Mr. Speaker, if you could extend the cordialities of the House to these fine men and women who have joined us here today.

ACTING SPEAKER AUBRY: Certainly. On behalf of Ms. Walsh, the Speaker and all the members, we welcome both of these excellent teams here to the New York State Assembly. We extend to you the privileges of the floor. Our congratulations on your excellence both in athletics and in education. We hope the process of winning will teach you how to do that in the rest of life. And we know that you will always hold up the high standards that you have developed at your high school. My congratulations to the coaches who have helped you and your parents, no doubt, have been supportive through the entire proposes. Congratulations. You know you are always welcome here. Thank you so very much.

(Applause)

MRS. PEOPLES-STOKES: Thank you, Mr. Speaker. To colleagues that are in the Chambers, I really want to thank you so much for your participation on this third week of our 243rd Session.
