A quorum being present, the Clerk will read the Journal of Saturday, March the 23rd.

MRS. PEOPLES-STOKES: Mr. Speaker, I move to

dispense with the further reading of the Journal of Saturday, March the 23rd and that the same stand approved.

ACTING SPEAKER AUBRY: Without objection, so ordered.

MRS. PEOPLES-STOKES: Thank you, sir.

Members and guests that are in the Chambers, I would like to share a quote with you today from Jacqueline Kennedy Onassis. She was the First Lady of the United States between 1961 and 1963 as the wife of President John F. Kennedy. Her words for us today, *We should all do something to right the wrongs that we see, not just complain about them.* Again, these words are from Mrs. Jackie Kennedy Onassis.

Mr. Speaker, colleagues have on their desks a main Calendar, and after you have done any introductions and/or housekeeping, we're going to take up Calendar Resolutions on Page 3. MR. GIBBS: Thank you, Mr. Speaker. I rise to introduce two young dynamic young men. These two young men are actually my grandkids, my daughter's sons Myian and Ian. You know on -- it's hard for me, but on February 18, 2016 my daughter Ariel Gibbs passed away to an aortic stenosis. Today is her birthday, and what way to celebrate my daughter by bringing the two gifts she left me. She left me Ian and Myian at the ages of one and two. Let's start with Myian. MR. SAYEGH: Thank you very much, Mr. Speaker. Nearly two years ago I presented a resolution to recognize Ukrainian Independence Day, which took place some 33 years ago on August 24, 1991; independence, of course, from the USSR, the Soviet Union. And it's been two years with the conflict, the prolonged conflict in the Ukraine, and the conflict that has taken the lives of so many has given a sense of pride to Ukrainian-Americans all across our State and all across our nation. And I'm very privileged in my city of Yonkers, New York to have a very large and productive Ukrainian-American community, and working very closely with two very important Ukrainian organizations, Saint Michael's Ukrainian Catholic Church and the SUMA Federal Credit Union have served our community for over 40 years. So in light of the conflict, it is extremely important not only to recognize Ukrainian independence, but really provide the

continued moral and other support for the Ukrainian community as they continue to endure the conflict in their homeland. So today's resolution honors Ukrainian independence, which would be celebrated on August 24, 2024.

Sojourner Truth was born in what is today the Town of Esopus, and she made a historic walk from the Town of Esopus to the City of Kingston where she took slave owners to court in the Ulster County Courthouse and made history by winning that legal case. I am here today carrying this bill on behalf of many young folks in my district who really want an occasion to celebrate Sojourner Truth, to pass knowledge about the fight that she took all over the country not only to fight for freedom for all, but also for voting rights and to inspire Americans all over the country to be bold and to stand up for what is right.

With that, I vote yes on this bill very happily. Thank you.

MRS. PEOPLES-STOKES: Mr. Speaker, do you have any further housekeeping or resolutions?

ACTING SPEAKER AUBRY: No housekeeping, but we do have a privileged resolution, 1020, the Clerk will read.

THE CLERK: Assembly Resolution No. 1020, Mr. Tannousis.

Legislative Resolution recognizing the Federation of Cypriot American Organizations in conjunction with its commemoration of the 50th anniversary of the Turkish invasion and occupation of Northern Cyprus.

ACTING SPEAKER AUBRY: Mr. Tannousis on the resolution.

MR. TANNOUSIS: Thank you, Mr. Speaker. On July 20, 1974, the Turkish military invaded the Mediterranean island of Cyprus. They took over one-third of the island, they displaced 150,000 Greek Cypriots, and many of those Cypriots fled and many of them came to New York City. Two of those refugees are my parents. It would mark 50 years -- on July 20th it will be 50 years since the Turkish invasion of Cyprus. The Cypriot people suffered a great injustice. And before coming to the Assembly, as many in the Chamber will know, I was a prosecutor. Part of the reason I became a prosecutor was because my family suffered an injustice, and I wanted

to fight for those that also suffered an injustice. And that's why I became a prosecutor to begin with.

So I stand here before you today in memory of that invasion of Cyprus 50 years ago, and I want to recognize the Federation of Cypriot American organizations that represents dozens of organizations across the country of Greek Cypriots that is fighting for the cause, which is for justice for Cyprus. Thank you very much.

ACTING SPEAKER AUBRY: Thank you, sir.

Mr. Lemondes.

MR. LEMONDES: Thank you, Mr. Speaker. On the resolution.

ACTING SPEAKER AUBRY: On the resolution, sir.

MR. LEMONDES: Thank you. This resolution brings to light the great injustice thrust upon Greek Cypriots. More importantly, it illustrates that for the second time in 100 years, the displacement of Greek citizens from two of their natural places of origin; Cyprus most recently, and the Pontian Greek, a Syrian and Armenian genocide less than 100 years prior. The attempt of the Turkish government and its -- and its willingness to use these events as the erasure of Christian culture could not be more racist. It could not be more morally wrong and incorrect. Yet it happened and it occurred. And you have in this Chamber two people, two different generations; one his parents, myself, my grandparents who are the descendants of these injustices.

So, Mr. Speaker, so that we may never forget that the struggle is still ongoing and continues to impact thousands of Greek Cypriots and their descendants, we should continue to diplomatically pressure the Turkish government to withdraw all forces and repatriate all persons and property. Turkish uncertainty in the Eastern Mediterranean destabilizes the entire world. Thank you, Mr. Speaker.

ACTING SPEAKER AUBRY: Thank you.
