MR. LEMONDES: Thank you, Madam Speaker.

I rise to introduce Father David Smith, who was born and raised in Syracuse, New York and is a graduate of Drury University, Asbury Theological Seminary and Pittsburgh Theological Seminary where he earned his Doctorate of Ministry degree in 1999. He has served as an Orthodox priest for over 30 years, and since 2010 he's been the pastor of St. Sophia's Greek Orthodox Church in Syracuse. When he retires, Syracuse will continue to be his home. He is the author of three books of spirituality: *Mary, Worthy of All Praise, Christianity and Pleasure* and *Help! I'm Bored in Church*. His first novel, *The Saint Outside the Gate*, was published by St. Innocent Press last spring. Father David and his wife, Donna, have four children, five grandchildren and counting.

Norman is not only a constituent, he's also a very close friend of Member Steck's Chief of Staff, Thad, who has known him for decades. Norman is known for his keen intellect and sense of humor. And upon retirement, I don't know how to break it to him, but the poor guy lives a block away from my office, so we will continue to put him in service to the community.

I'm very privileged today to have my family here. I have my two grandchildren, Rafael and Juliana, my daughter, Melissa, and her mother, Rose. I -- I -- I'm so privileged -- I'm sorry, I'm at a loss for words. This is the reason I keep coming to Albany. These two are the reason that I won't stop until the Lord tells me. But I ask that you welcome them to the Chamber and afford them the cordialities of the floor.

MR. MORINELLO: This being Italian-American Legislative Day, I am going to introduce a trio of honorees that we have, that we honored this year. I would like to introduce Dr. Joseph Scelsa, Robert Fonti and Damien Crowley. Dr. Joseph Scelsa is a lifelong advocate for the Italian-American community, a noted author, and an advocate for all aspects of bringing dignity to those in the community of the Italian heritage. Robert Fonti, President of the Lieutenant Detective Joseph Petrosino Association of America. Advocate for police, advocate for safety. And I'd like to introduce Damien Crowley, Damien (indicating). Damien is one of our four

scholarship winners. Each year, the Italian-American legislators gives out two scholarships. Two in honor of James Conte and two in honor of John Marchi, but one being an Assembly, one being a Senator.

Damien was an outstanding athlete, an outstanding student. His grade average is higher than 100, higher than most peoples' IQs. I'm very proud to have and to welcome him to the floor. Dr., same with you, congratulations. Bob, thank you so much.

I ask that you extend them the courtesies of the floor and welcome them to the Assembly. Thank you.

ACTING SPEAKER HUNTER: On behalf of Mr. Morinello, the Speaker and all the members, we welcome you to the Assembly Chamber, our Italian-American Heritage Day honorees today, extend to you the privileges of the floor. Hope you enjoy the proceedings today and your event this evening. Thank you so very much for joining us.

MR. RA: Thank you, Madam Speaker.

I'm very proud to introduce on the floor today Maria Milito who is joining us as part of the Italian-American Day festivities. Last week, we adopted a resolution naming Maria the 2025 Italian-American of the Year in New York State, as awarded by the New York Conference of Italian-American State legislators. Just for everybody to know, we actually were supposed to recognize Maria back in 2020, and unfortunately, the COVID pandemic prevented us

from having Italian-American Day or a festa. So, I'm glad that she was able to join us today.

Maria has been -- is a native New Yorker. She's been on the air for over 25 years on Q104.3. She is one of the most well-known DJs in New York. She -- she previously worked with NY1 and Infinity Broadcasting and is an alumna of New York Institute of Technology in Old Westbury. She is an avid animal lover and hosts Maria's Mutts & Stuff podcast, where she and guests chat about animal rescue and welfare, and is passionate and involved in animal advocacy across New York State. In both her professional and work life she's always spreading the message of adopt, don't shop.

Maria also has given public service to this State in the aftermath of what we all agree was one of the most difficult times in New York State history in the aftermath of 9/11. Maria led her talent and her voice to making public service announcements from the New York City Office of Emergency Management.

So, we're very proud to recognize her. I know Maria's proud of her Italian-American heritage, and we are proud and honored that she was able to join us for Italian-American Day in New York today.

ACTING SPEAKER HUNTER: On behalf of Mr. Ra, the Speaker and all the members, we welcome you Ms. Milito to the Chamber and extend the privileges of the floor to you. Congratulations to you for being the 2025 Italian-American of the year. We hope you enjoy our proceedings today. Thank you so very

much for joining us.

MR. RA: Thank you, Madam Speaker.

I'm also proud to welcome today Matt -- Matt

Weingartner from Salisbury, down on Long Island. At the end of Session today, we're going to be adopting a resolution for Aphasia Awareness Month in the State of New York. June is Aphasia Awareness Month and Matt has come to the Capitol today to help spread awareness to aphasia, which is a condition that affects one's ability to communicate. Aphasia affects a portion of the brain responsible for the understanding of written and spoken language, and once the underlying cause of aphasia is treated, people can make significant progress with speech therapy and with appropriate support. Matt experienced this condition when one day, in April of 2018, he was in class with Local 3 studying to become an electrician. The next thing he knew, he was waking up in a hospital bed. He had suffered an ischemic stroke from a blood infection, and it resulted in a clot that traveled to his brain. This left him partially paralyzed and unable to speak without difficulty. Matt has made a fantastic recovery and has now made it his mission to raise awareness about aphasia and support others who have the condition, which is about 200,000 people who are diagnosed each year.

In his advocacy, Matt has hosted Aphasia Awareness Open House at the LIU Post Ladge Speech and Hearing Center. He's

involved in organizations including Voices of Hope for Aphasia, Aortic Hope and Aphasia Recovery Connection, and he was the New York leader for the annual 5K for Aortic Warriors. He also has his own chapter in Letisha Living's book, *Finding Yourself After Stroke*.

As I said, June is Aphasia Awareness Month in New York State, and Matt has also worked with Nassau County to light the Legislative Building in Mineola gray for the month. Matt's journey with aphasia is one of great resilience and hope, and his determination, positive outlook and steady recovery demonstrate there is hope for those with aphasia, and we're glad to welcome him to the Capitol today.

Mr. Patrick Carroll for the purposes of an introduction.

MR. P. CARROLL: Thank you, Madam Speaker.

I'm proud to rise today to introduce an inspiring group of students from Clarkstown South and Felix Festa Middle School in my district. They're accompanied by their teachers, Ms. Sachs, Ms. Magazine-Fishkin [sic], Ms. Freimann, as well as their principal, Dr. Michael St. John and the principal of Clarkstown South, Ms. Debra Tarantino. Their superintendent is also with them, Dr. Marc Baiocco.

They're accompanied by the founders of the program they've been involved with. Tova and Doug Rosenberg are the founders of Names, Not Numbers, an organization created to ensure that we never forget the atrocity of the -- of the Holocaust. Over the last year through the Names, Not Numbers project, these students interviewed Holocaust survivors, World War II veterans, conducted research, produced videos and edited their work to create mini documentaries in order to digitally preserve the stories that were told to them. Their program culminated with events honoring the interviewees and showcasing the documentary that they created. The Names, Not Numbers program has enabled thousands of students worldwide to learn about the Holocaust firsthand from survivors, and preserve their stories for future generations.

As we move -- more further away from the Holocaust, we unfortunately have become desensitized from the pain,

suffering and tragic loss -- loss of life -- life that occurred. As one program participant said, Sam Petowski (phonetic) noted, their generation will be the last we hear firsthand accounts of the Holocaust survivors. We see that now with the alarming rise of anti-Semitism in our State and our country. We will always say we never forget the unthinkable tragedy that was the Holocaust. These students work, along with the dedication of the Rosenbergs, make it possible that we will never forget and that the generations who will come, will they be able to learn from the stories of the Holocaust.

I thank you for allowing me to introduce these inspiring group of students here today. I'm inspired by Clarkstown South and Felix Festa, and I thank the teachers and the students for doing such inspiring work. It's great to welcome them. Please offer them the cordialities of the House.

ACTING SPEAKER HUNTER: On behalf of Mr. Carroll, the Speaker and all the members, we welcome our future leaders from the Clarkstown South High School and middle school students. Welcome you to the Assembly Chamber and extend the privileges of the floor to you. Thank you for the very important work that you are doing interviewing Holocaust survivors, and the important documentary that you are creating. Enjoy our proceedings today. MS. McMAHON: Thank you, Madam Speaker, for

allowing me to introduce my constituent who has traveled all the way from Western New York to visit with us today. Hannah-Kate McFadden is a junior at Amherst Central High School. She created the Nonpartisan Candidate Pledge [sic] at the age of 13, after experiencing instability in the political discourse while volunteering for a local mayoral campaign. She later created the Elected Official Pledge. Both pledges contain similar commonsense principles that are not always so common in politics. Things like be respectful to other candidates, stick to the issues and have a servant's heart, my personal favorite. Hannah-Kate has met with many candidates and elected officials at all levels of government, including the Governor of her home state of Tennessee. Both Democrats and Republicans have signed on and Hannah-Kate would encourage all of us to join her in this effort to foster civility and cooperation in politics in government.

Madam Speaker, please welcome Hannah-Kate and her mother, Brandy, and provide them with all the cordialities of the House.

Following Bryan Johnson's loss, this Legislature enacted a law to mandate that anyone born after 1996 must take an eight-hour boating safety course before operating a craft on New York's waterways.

National Safe Boating Week is the U.S. Coast Guard and National Safe Boating Campaign's annual week of recognition to

bring attention to the important life-saving information recreational boaters need to have for a safer, more enjoyable experience on the water now and throughout the year.

For nearly 100 million Americans, boating continues to be a popular recreational activity. The Coast Guard estimates that human error accounts for 70 percent of all boating accidents, and that lifejackets could prevent more than 85 percent of boating fatalities. Through simple boating safety procedures such as carrying life-saving emergency distress and communications equipment, wearing lifejackets, attending boating safety courses, participating in free boat safety checks and staying sober when boating, New Yorkers can help ensure boaters in New York's waterways stay safe.

I ask my colleagues to please join me in support of this resolution recognizing Safe Boating Week in New York State to help ensure all those recreating on New York's waters are safe as we kick off boating season.

Many of these individuals came over on -- by boat. They came either through Ellis Island, they came through Canada, and they came for a better life. They came and they worked. They came and they had nothing, but they expected nothing. They came. They didn't come with their hand out, they came with their shovels and their backs. They came and were ridiculed. They came and found life difficult. If you go and watch some of the movies, the children had to live in sewers because there were no places for them. There was no government handouts; yet, they survived. They came together as families. And what the Italian holidays are are family, friends and food.

But for many Italian families, mine included, those cultural treasures couldn't protect some from the horrors of war. In 1944, after years of -- of refusing refugees fleeing from the Holocaust, President Roosevelt authorized the admission of 902 Italian refugees to the United States. They were brought to Fort Ontario Emergency Refugee Shelter in Oswego, New York, an isolated camp under strict military guard. Though it was a small and belated gesture, it became a lifeline for those few who were fortunate enough to find safety within its walls. My grandmother and mother were among them. A respected furrier from Milano [sic], my grandmother arrived in Oswego with her young daughter, my mother, both seeking safety and the opportunity for a new life. They were determined to become Americans, to learn the language, adapt to their new home and give back to the country that welcomed them.

So today as we honor Italy's contributions to the world, we also honor the determination of those who came here not just to start over, but to serve, build and belong.
